

RCW 39.58.108 Requirements to become depository. Any financial institution may become, and thereafter operate as, a public depository upon approval by the commission and segregation of collateral in the manner as set forth in this chapter, and subject to compliance with all rules and policies adopted by the commission. A public depository shall at all times pledge and segregate eligible collateral in an amount established by the commission by rule or noticed resolution.
