WAC 391-25-170 Intervention—By incumbent representative. An organization which demonstrates that it has been the exclusive representative of all or any part of the bargaining unit involved in proceedings under this chapter during the year preceding the filing of the petition must automatically be allowed to intervene in the proceedings without motion and is entitled to participate in the proceedings and to have its name listed as a choice on the ballot in any election.
