WEIGHTS AND MEASURES REGULATION ADOPTING AMENDMENTS
TO NATIONAL BUREAU OF STANDARDS HANDBOOK 44, 3rd EDITION

I, Donald W. Moos, Director of Agriculture of the State of Washington by virtue of the authority vested in me under Chapter 19.93 RCW, after due notice as provided under Chapter 34.04 and 42.32 RCW, and public hearing held in Olympia on November 15, 1967 do promulgate the following regulation:

Regulation 1.

The 1967 amendments to the National Bureau of Standards Handbook 44, 3rd Edition (as adopted by Order 1035) are hereby adopted as provided under RCW 19.93.060 as the specifications, tolerances, and regulations for commercial weighing and/or measuring devices of the state.


