3 Strike everything after the enacting clause and insert:

4 "NEW SECTION. **Sec. 1.** A new section is added to chapter
5 28C.18 RCW to read as follows:

6 (1) It is the intent of the legislature, to the extent
7 possible, that all public funds related to training and retraining
8 be deposited in a single account administered by the board.

9 (2) The state job training trust fund is created in the
10 custody of the state treasurer. All state and federal general fund
11 appropriations for training and retraining, including but not
12 limited to programs currently administered or provided by the
13 employment security department, the state board for community and
14 technical colleges, the workforce training and education
15 coordinating board, the department of social and health services,
16 the department of labor and industries, the higher education
17 coordinating board, the Washington institute of applied technology,
18 and the department of transportation, shall be deposited into the
19 fund. Only the director of the workforce training and education
20 coordinating board or the director's designee may authorize
21 expenditures from the fund. Expenditures from the fund may be used
22 only for training and retraining programs that are consistent with
23 the board's state comprehensive plan developed under RCW
24 28C.18.060(4). No appropriation is required for expenditures from
25 the fund.

26 NEW SECTION. **Sec. 2.** For the Biennium ending June 30, 1995,
27 all state and federal general funds for training and retraining,
28 including but not limited to programs traditionally administered or
29 provided by the employment security department, the state board for
30 community and technical colleges, the workforce training and

1 education coordinating board, the department of social and health
2 services, the department of labor and industries, the higher
3 education coordinating board, the Washington institute of applied
4 technology, and the department of transportation, shall be
5 appropriated to the state job training trust fund.

6 NEW SECTION. **Sec. 3.** The governor shall designate the
7 workforce training and education coordinating board as the
8 administrative agency for federal training and retraining funds.
9 The governor shall take other executive actions necessary to carry
10 out the intent of this act.

11 NEW SECTION. **Sec. 4.** If any part of this act is found to be
12 in conflict with federal requirements that are a prescribed
13 condition to the allocation of federal funds to the state, the
14 conflicting part of this act is hereby declared to be inoperative
15 solely to the extent of the conflict, and such finding or
16 determination shall not affect the operation of the remainder of
17 this act. The rules under this act shall meet federal requirements
18 that are a necessary condition to the receipt of federal funds by
19 the state.

20 NEW SECTION. **Sec. 5.** If any provision of this act or its
21 application to any person or circumstance is held invalid, the
22 remainder of the act or the application of the provision to other
23 persons or circumstances is not affected."

EFFECT: Eliminates the Employment and Training Trust Fund and
the .12 percent offset tax (which provides funding for
Employment and Training Trust Fund). Creates the State Job
Training Trust Fund. Requires that all state and federal
general fund appropriations for training and retraining be
deposited in the State Job Training Trust Fund, which is
administered by the Workforce Training and Education

Coordinating Board. Transfers administration of federal training funds to the Workforce Training and Education Coordinating Board from the Employment Security Department and other agencies.
