- 8 (1) The department shall adopt rules and standards with respect to 9 adult family homes and the operators thereof to be licensed under this 10 chapter to carry out the purposes and requirements of this chapter. The rules and standards relating to applicants and operators shall 11 address the differences between the nature of the ownership and number 12 13 of adult family homes owned in whole or in part by the same person, including: (a) Individual resident providers of a single facility; (b) 14 15 individual providers of a single facility; (c) individual providers of more than a single facility; (d) providers of a single facility that 16 17 are partnerships, corporations, associations, or companies; and (e) providers of more than a single facility that are partnerships, 18 19 corporations, associations, or companies. <u>The rules and standards</u> 20 shall also recognize and be appropriate to the size of the adult family homes and number of beds provided at the adult family homes. The rules 21 22 and standards shall also recognize and be appropriate to the different 23 needs and capacities of the various populations served by adult family 24 homes such as but not limited to the developmentally disabled and the 25 In developing rules and standards the department shall recognize the residential family-like nature of adult family homes and 26 27 not develop rules and standards which by their complexity serve as an 28 overly restrictive barrier to the development of the adult family homes 29 in the state. Procedures and forms established by the department shall 30 be developed so they are easy to understand and comply with. work requirements shall be minimal. Easy to understand materials shall 31 32 be developed for applicants and providers explaining licensure requirements and procedures. 33
- 34 (2) In developing the rules and standards, the department shall 35 consult with all divisions and administrations within the department 36 serving the various populations living in adult family homes, including

- 1 the division of developmental disabilities and the aging and adult
- 2 services administration. Involvement by the divisions and
- 3 administration shall be for the purposes of assisting the department to
- 4 develop rules and standards appropriate to the different needs and
- 5 capacities of the various populations served by adult family homes.
- 6 During the initial stages of development of proposed rules, the
- 7 department shall provide notice of development of the rules to
- 8 organizations representing adult family homes and their residents, and
- 9 other groups that the department finds appropriate. The notice shall
- 10 state the subject of the rules under consideration and solicit written
- 11 recommendations regarding their form and content.
- 12 (3) Except where provided otherwise, chapter 34.05 RCW shall govern
- 13 all department rule-making and adjudicative activities under this

- 16 as follows:
- 17 (1) An application for license shall be made to the department upon
- 18 forms provided by it and shall contain such information as the
- 19 department reasonably requires.
- 20 (2) The department shall issue a license to an adult family home if
- 21 the department finds that the applicant and the home are in compliance
- 22 with this chapter and the rules adopted under this chapter, unless (a)
- 23 the applicant has prior violations of this chapter relating to the
- 24 adult family home subject to the application or any other adult family
- 25 home, or of any other law regulating residential care facilities within
- 26 the past five years that resulted in revocation or nonrenewal of a
- 27 license; or (b) the applicant has a history of significant
- 28 noncompliance with federal, state, or local laws, rules, or regulations
- 29 relating to the provision of care or services to vulnerable adults or
- 30 to children.
- 31 (3) The license fee shall be submitted with the application.
- 32 (4) The department shall serve upon the applicant a copy of the
- 33 decision granting or denying an application for a license. An
- 34 applicant shall have the right to contest denial of his or her
- 35 application for a license as provided in chapter 34.05 RCW by
- 36 requesting a hearing in writing within twenty-eight days after receipt
- 37 of the notice of denial.

- 1 (5) The department shall not issue a license to a provider if the 2 department finds that the provider or any partner, officer, director, 3 managerial employee, or owner of five percent or more if the provider 4 has a history of significant noncompliance with federal or state 5 regulations, rules, or laws in providing care or services to vulnerable 6 adults or to children.
- 7 (6) The department shall license an adult family home for the 8 maximum level of care that the adult family home may provide. The 9 department shall define, in rule, license levels based upon the 10 education, training, and caregiving experience of the licensed provider 11 or staff.
- 12 (7) The department shall establish, by rule, standards used to
 13 license nonresident providers where the owner does not live in the
 14 facility and multiple facility operators, including where appropriate
 15 and permitted under the federal fair housing law, the dispersal of
 16 adult family homes where the owner does not live in the facility to
 17 avoid the concentration of such facilities in the same predominantly
 18 residential area.
- 19 (8) The department shall establish, by rule, for multiple facility 20 operators educational standards substantially equivalent to recognized 21 national certification standards for residential care administrators.
- (9) The license fee shall be set at fifty dollars per year for each home. A fifty dollar processing fee shall also be charged each home when the home is initially licensed."
