1 AN ACT Relating to vessel registration enforcement; adding a new
2 section to chapter 82.49 RCW; adding a new section to chapter 88.02
3 RCW; creating a new section; prescribing penalties; and providing an
4 effective date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** A new section is added to chapter 82.49 RCW
7 to read as follows:

8 An owner of a vessel that is not registered as required by chapter
9 88.02 RCW and for which watercraft excise tax is due under this chapter
10 is liable for a penalty in the following amount:

- 11 (1) One hundred dollars for the owner's first violation;
12 (2) Two hundred dollars for the owner's second violation involving
13 the same or any other vessel; or
14 (3) Four hundred dollars for the owner's third and successive
15 violations involving the same or any other vessel.

16 The department may collect this penalty under the procedures
17 established in chapter 82.32 RCW. The penalty imposed under this
18 section is in addition to any other civil or criminal penalty imposed
19 by law.

1 NEW SECTION. **Sec. 2.** A new section is added to chapter 88.02 RCW
2 to read as follows:

3 (1) A marina that leases permanent moorage to vessels must require
4 the following information from the lessee as a condition of leasing
5 moorage space:

6 (a) The name, address, and telephone number of the legal owner of
7 the vessel;

8 (b) The name of the lessee, if different than the owner;

9 (c) The vessel's hull identification number;

10 (d) The vessel's Coast Guard registration (if applicable);

11 (e) The date on which the moorage lease began; and

12 (f) The vessel's country or state of registration and registration
13 number.

14 A marina shall make available copies of these records, or shall
15 permit any authorized agent of the department of revenue to inspect
16 these records at a mutually agreed time, within thirty days of request
17 by the department.

18 (2) A marina that leases permanent moorage to vessels must require
19 proof of vessel registration or a written statement of intent to
20 register a vessel as a condition of leasing moorage space. If the
21 applicant's vessel is not registered in this state, the marina must
22 inform the moorage applicant of the state law requiring vessel
23 registration and the penalties assessed for failure to comply with the
24 state's vessel registration laws. After this, it is the moorage
25 applicant's responsibility to register the vessel.

26 NEW SECTION. **Sec. 3.** Section 1 of this act applies to any
27 violation that occurs on or after the effective date of this act.
28 Section 2 of this act applies to any lease of permanent moorage that
29 continues in effect beyond or is entered into, renewed, or extended on
30 or after the effective date of this act.

31 NEW SECTION. **Sec. 4.** This act takes effect August 1, 2005.
