**Background:** Adult Family Home providers currently are required to complete a basic training course approved by the Department of Social and Health Services (DSHS). Providers who were licensed after September 1, 2001, must complete at least 320 hours of successful, direct care giving experience obtained after 18 years of age. Providers applying for a license after January 1, 2007 must complete a department-approved 48-hour Adult Family Home administration and business planning class.

**Summary of Second Substitute Bill:** A voluntary certification program through the University of Washington Geriatric Education Center is available to Adult Family Home Providers in addition to the existing minimum requirements for state licensure. The voluntary certification program will include 52 hours of class requirements covering physical and mental health conditions that can be prevented, postponed, or alleviated by health promotion activities. Individuals successfully completing the voluntary program will be issued a certified Adult Family Home license by the DSHS.
