1 AN ACT Relating to tuition waivers for veterans' families; and 2 amending RCW 28B.15.621, 28B.15.910, and 28B.15.385.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 Sec. 1. RCW 28B.15.621 and 2005 c 249 s 1 are each amended to read 5 as follows:

(1) The legislature finds that active military and naval veterans, 6 7 reserve military and naval veterans, and national guard members called 8 to active duty have served their country and have risked their lives to 9 defend the lives of all Americans and the freedoms that define and 10 distinguish our nation. The legislature intends to honor active military and naval veterans, reserve military and naval veterans, and 11 12 national guard members who have served on active military or naval duty for the public service they have provided to this country. 13

14 (2) Subject to the limitations in RCW 28B.15.910, the governing
15 boards of the state universities, the regional universities, The
16 Evergreen State College, and the community colleges, may waive all or
17 a portion of tuition and fees for ((the following persons:

18 (a))) <u>an eligible veteran or national guard member((\div </u>

(b) A child and the spouse of an eligible veteran or national guard member who became totally disabled as defined in RCW 28B.15.385 while engaged in active federal military or naval service, or who is determined by the federal government to be a prisoner of war or missing in action;

6 (c) A child and the surviving spouse of an eligible veteran or 7 national guard member who lost his or her life while engaged in active 8 federal military or naval service. However, upon remarriage, the 9 surviving spouse of an eligible veteran or national guard member is 10 ineligible for a waiver under this section)).

(3) The governing boards of the state universities, the regional 11 12 universities, The Evergreen State College, and the community colleges, 13 may waive all or a portion of tuition and fees for a military or naval veteran who is a Washington domiciliary, but who did not serve on 14 foreign soil or in international waters or in another location in 15 support of those serving on foreign soil or in international waters and 16 17 who does not qualify as an eligible veteran or national guard member under subsection $\left(\left(\frac{5}{5}\right)\right)$ <u>(7)</u> of this section. However, there shall be 18 state general fund support for waivers granted under this 19 no subsection. 20

(4) <u>Subject to the conditions in subsection (5) of this section,</u> <u>the governing boards of the state universities, the regional</u> <u>universities, The Evergreen State College, and the community colleges,</u> <u>shall waive all tuition and fees for the following persons:</u>

25 (a) A child and the spouse of an eligible veteran or national guard 26 member who became totally disabled as defined in RCW 28B.15.385 while 27 engaged in active federal military or naval service, or who is 28 determined by the federal government to be a prisoner of war or missing 29 in action; and

30 (b) A child and the surviving spouse of an eligible veteran or 31 national guard member who lost his or her life while engaged in active 32 federal military or naval service.

33 (5) The conditions in this subsection (5) apply to waivers under 34 subsection (4) of this section.

35 (a) A child must be a Washington domiciliary between the age of 36 seventeen and twenty-six to be eligible for the tuition waiver and a 37 child's marital status does not affect eligibility.

1 (b) A surviving spouse must be a Washington domiciliary, and has 2 ten years from the date of the death, total disability as defined in 3 RCW 28B.15.385, or federal determination of prisoner of war or missing 4 in action status of the eligible veteran or national guard member to 5 receive the benefit. Upon remarriage, the surviving spouse is 6 ineligible for the tuition waiver.

7 (c) Each recipient's continued participation is subject to the
 8 school's satisfactory progress policy.

9 <u>(6)</u> Private vocational schools and private higher education 10 institutions are encouraged to provide waivers consistent with the 11 terms in subsections (2) ((and (3))) through (5) of this section.

12 (((5) As used in)) (7) The definitions in this subsection apply
13 throughout this section.

14 (a) "Eligible veteran or national guard member" means a Washington domiciliary who was an active or reserve member of the United States 15 military or naval forces, or a national guard member called to active 16 17 duty, who served in active federal service, under either Title 10 or Title 32 of the United States Code, in a war or conflict fought on 18 foreign soil or in international waters or in another location in 19 support of those serving on foreign soil or in international waters, 20 21 and if discharged from service, has received an honorable discharge.

(b) "Washington domiciliary" means a person whose true, fixed, and
 permanent house and place of habitation is the state of Washington.

24 **Sec. 2.** RCW 28B.15.910 and 2006 c 229 s 2 are each amended to read 25 as follows:

26 (1) For the purpose of providing state general fund support to 27 public institutions of higher education, except for revenue waived under programs listed in subsections (3) and (4) of this section, and 28 unless otherwise expressly provided in the omnibus state appropriations 29 30 act, the total amount of operating fees revenue waived, exempted, or 31 reduced by a state university, a regional university, The Evergreen State College, or the community colleges as a whole, shall not exceed 32 the percentage of total gross authorized operating fees revenue in this 33 subsection. As used in this section, "gross authorized operating fees 34 35 revenue" means the estimated gross operating fees revenue as estimated 36 under RCW 82.33.020 or as revised by the office of financial

management, before granting any waivers. 1 (4) The total amount of operating fees revenue waived, exempted, or 2 reduced by institutions of higher education participating in the 3 western interstate commission for higher education western 4 undergraduate exchange program under RCW 28B.15.544 shall not exceed 5 the percentage of total gross authorized operating fees revenue in this 6 subsection.

10 (5) The institutions of higher education will participate in outreach activities to increase the number of veterans who receive 11 12 tuition waivers. Colleges and universities shall revise the 13 application for admissions so that all applicants shall have the opportunity to advise the institution that they are veterans who need 14 15 assistance. If a person indicates on the application for admissions that the person is a veteran who is in need of assistance, then the 16 17 institution of higher education shall ask the person whether they have any funds disbursed in accordance with the Montgomery GI Bill available 18 to them. Each institution shall encourage veterans to utilize funds 19 available to them in accordance with the Montgomery GI Bill prior to 20 21 providing the veteran a tuition waiver.

22 Sec. 3. RCW 28B.15.385 and 1973 1st ex.s. c 191 s 5 are each 23 amended to read as follows:

For the purposes of RCW 28B.15.380, ((28B.15.385,)) 28B.15.520, and ((28B.40.361)) 28B.15.621, the phrase "totally disabled" ((as used in RCW 28B.15.380, 28B.15.520 and 28B.40.361 shall)) means a person who has become totally and permanently disabled for life by bodily injury or disease, and is thereby prevented from performing any occupation or gainful pursuit.
