## HOUSE BILL 1866

State of Washington 60th Legislature 2007 Regular Session

AN ACT Relating to purple heart special license plates; amending RCW 46.16.237 and 46.16.270; reenacting and amending RCW 46.16.305; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 46.16.237 and 2005 c 314 s 301 are each amended to 6 read as follows:

7 (1) All vehicle license number plates issued after January 1, 1968, 8 or such earlier date as the director may prescribe with respect to 9 plates issued in any county, shall be treated with fully reflectorized 10 materials designed to increase the visibility and legibility of such 11 plates at night.

12 (2) In addition to all other fees prescribed by law, there shall be 13 paid and collected for each vehicle license number plate treated with 14 such materials, the sum of two dollars and for each set of two plates, 15 the sum of four dollars. However, one plate is available only to those 16 vehicles that by law require only one plate. Such fees shall be 17 deposited in the motor vehicle fund. <u>Purple heart special license</u> 18 plates authorized by RCW 46.16.305 are exempt from this fee. 1 **Sec. 2.** RCW 46.16.270 and 2005 c 314 s 302 are each amended to 2 read as follows:

3 The total replacement plate fee shall be deposited in the motor 4 vehicle fund.

Upon the loss, defacement, or destruction of one or both of the 5 vehicle license number plates issued for any vehicle where more than 6 7 one plate was originally issued or where one or both have become so illegible or in such a condition as to be difficult to distinguish, or 8 upon the owner's option, the owner of the vehicle shall make 9 10 application for new vehicle license number plates upon a form furnished by the director. The application shall be filed with the director or 11 12 the director's authorized agent, accompanied by the certificate of 13 license registration of the vehicle and a fee in the amount of ten 14 dollars per plate, whereupon the director, or the director's authorized agent, shall issue new vehicle license number plates to the applicant. 15 It shall be accompanied by a fee of two dollars for a new motorcycle 16 17 license number plate. In the event the director has issued license period tabs or a windshield emblem instead of vehicle license number 18 plates, and upon the loss, defacement, or destruction of the tabs or 19 windshield emblem, application shall be made on a form provided by the 20 21 director and in the same manner as above described, and shall be 22 accompanied by a fee of one dollar for each pair of tabs or for each windshield emblem, whereupon the director shall issue to the applicant 23 24 a duplicate pair of tabs, year tabs, and when necessary month tabs or 25 a windshield emblem to replace those lost, defaced, or destroyed. For vehicles owned, rented, or leased by the state of Washington or by any 26 27 county, city, town, school district, or other political subdivision of the state of Washington or United States government, or owned or leased 28 by the governing body of an Indian tribe as defined in RCW 46.16.020, 29 a fee shall be charged for replacement of a vehicle license number 30 31 plate only to the extent required by the provisions of RCW 46.16.020, 32 46.16.237, and 46.01.140. For vehicles owned, rented, or leased by foreign countries or international bodies to which the United States 33 government is a signatory by treaty, the payment of any fee for the 34 35 replacement of a vehicle license number plate shall not be required. 36 The reissuance of purple heart special license plates authorized by RCW 37 46.16.305 are exempt from any fees required under this section.

Sec. 3. RCW 46.16.305 and 1997 c 291 s 6 and 1997 c 241 s 10 are each reenacted and amended to read as follows:

The department shall continue to issue the categories of special 3 plates issued by the department under the sections repealed under 4 5 section 12 (1) through (7), chapter 250, Laws of 1990. Special license plates issued under those repealed sections before January 1, 1991, are б 7 valid to the extent and under the conditions provided in those repealed sections. The following conditions, limitations, or requirements apply 8 9 to certain special license plates issued after January 1, 1991:

(1) A horseless carriage plate and a plate or plates issued for 10 collectors' vehicles more than thirty years old, upon payment of the 11 initial fees required by law and the additional special license plate 12 fee established by the department, are valid for the life of the 13 vehicle for which application is approved by the department. 14 When a single plate is issued, it shall be displayed on the rear of the 15 16 vehicle.

17 (2) The department may issue special license plates denoting amateur radio operator status only to persons having a valid official 18 radio operator license issued by the federal communications commission. 19

(3) The department shall issue one set of special license plates to 20 21 each resident of this state who has been awarded the Congressional 22 Medal of Honor for use on a passenger vehicle registered to that 23 person. The department shall issue the plate without the payment of 24 licensing fees and motor vehicle excise tax.

25 (4) The department may issue for use on only one motor vehicle owned by the qualified applicant special license plates denoting that 26 27 the recipient of the plate is a survivor of the attack on Pearl Harbor on December 7, 1941, to persons meeting all of the following criteria: 28 29

(a) Is a resident of this state;

(b) Was a member of the United States Armed Forces on December 7, 30 31 1941;

(c) Was on station on December 7, 1941, during the hours of 7:55 32 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor, the island of Oahu, or 33 offshore at a distance not to exceed three miles; 34

(d) Received an honorable discharge from the United States Armed 35 Forces; and 36

37 (e) Is certified by a Washington state chapter of the Pearl Harbor survivors association as satisfying the qualifications in (c) of this subsection.

3 The department may issue such plates to the surviving spouse of any deceased Pearl Harbor survivor who met the requirements of this 4 subsection. If the surviving spouse remarries, he or she shall return 5 the special plates to the department within fifteen days and apply for 6 7 regular plates. The surviving spouse must be a resident of this state. The department shall issue these plates upon payment by the 8 applicant of all other license fees, but the department may not set or 9 10 charge an additional fee for these special license plates.

(5) The department may issue a purple heart special license plate that may be used in lieu of regular or personalized license plates for vehicles required to display one or two vehicle license plates, excluding vehicles registered under chapter 46.87 RCW. The department may issue the special license plate, denoting that the applicant of the plate has been awarded the purple heart medal, if the applicant:

17 <u>(a) Is a Washington resident;</u>

18 (b) Was issued the purple heart medal by any branch of the United 19 States armed forces, including the merchant marines and the women's air 20 forces service pilots;

21 (c) Was wounded during one of this nation's wars or conflicts
22 identified in RCW 41.04.005; and

23

(d) Owns, co-owns, leases, or coleases the vehicle.

24 The department may issue such plates to the surviving spouse of any deceased purple heart medal recipient who met the requirements of this 25 26 subsection. If the surviving spouse remarries, he or she shall return 27 the special plates to the department within fifteen days and apply for regular plates. The surviving spouse must be a resident of this state. 28 The department shall issue these plates upon payment by the 29 applicant of all other license fees, but the department may not set or 30 charge plate fees or additional fees for these special license plates. 31

32 (6) The department shall replace, free of charge, special license 33 plates issued under subsections (3) and (4) of this section if they are 34 lost, stolen, damaged, defaced, or destroyed. Such plates shall remain 35 with the persons upon transfer or other disposition of the vehicle for 36 which they were initially issued, and may be used on another vehicle 37 registered to the recipient in accordance with the provisions of RCW 38 46.16.316(1). <u>NEW SECTION.</u> Sec. 4. This act applies to vehicle registrations
 that are due or become due on or after January 1, 2008.
