- AN ACT Relating to "Autism Awareness" special license plates; amending RCW 46.16.745 and 46.16.316; reenacting and amending RCW

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 46.16 RCW to read as follows:
- 8 In cooperation with the department, the Washington Autism Awareness
- 9 Society shall create and design, and the department shall issue, a
- 10 special license plate displaying the Washington Autism Awareness
- 11 Society logo that may be used in lieu of regular or personalized
- 12 license plates for vehicles required to display one or two vehicle
- 13 license plates, excluding vehicles registered under chapter 46.87 RCW,
- 14 upon terms and conditions established by the department. The special
- 15 license plate created under this section shall be exempt from review by
- 16 the special license plate review board and the provisions of RCW
- 17 46.16.725 and 46.16.745, except as provided in this section.

NEW SECTION. Sec. 2. A new section is added to chapter 46.04 RCW to read as follows:

"Autism Awareness license plates" means license plates issued under section 1 of this act that display the Washington Autism Awareness Society logo.

This fee is in addition to all other fees required to register and license the vehicle for which the plates have been requested. All such additional special license plate fees collected by the department shall be deposited in the state treasury and credited to the motor vehicle fund.
 - (2) In addition to all fees and taxes required to be paid upon application and registration of a motor vehicle, the holder of a collegiate license plate shall pay an initial fee of forty dollars. The department shall deduct an amount not to exceed twelve dollars of each fee collected under this subsection for administration and collection expenses incurred by it. The remaining proceeds shall be remitted to the custody of the state treasurer with a proper identifying detailed report. The state treasurer shall credit the funds to the appropriate collegiate license plate fund as provided in RCW 28B.10.890.
 - (3) In addition to all fees and taxes required to be paid upon renewal of a motor vehicle registration, the holder of a collegiate license plate shall pay a fee of thirty dollars. The department shall deduct an amount not to exceed two dollars of each fee collected under this subsection for administration and collection expenses incurred by it. The remaining proceeds shall be remitted to the custody of the state treasurer with a proper identifying detailed report. The state

treasurer shall credit the funds to the appropriate collegiate license plate fund as provided in RCW 28B.10.890.

- (4) In addition to all fees and taxes required to be paid upon application and registration of a motor vehicle, the holder of a special baseball stadium license plate shall pay an initial fee of forty dollars. The department shall deduct an amount not to exceed twelve dollars of each fee collected under this subsection for administration and collection expenses incurred by it. The remaining proceeds, minus the cost of plate production, shall be distributed to a county for the purpose of paying the principal and interest payments on bonds issued by the county to construct a baseball stadium, as defined in RCW 82.14.0485, including reasonably preconstruction costs, while the taxes are being collected under RCW 82.14.360. After this date, the state treasurer shall credit the funds to the state general fund.
- (5) In addition to all fees and taxes required to be paid upon renewal of a motor vehicle registration, the holder of a special baseball stadium license plate shall pay a fee of thirty dollars. The department shall deduct an amount not to exceed two dollars of each fee collected under this subsection for administration and collection expenses incurred by it. The remaining proceeds shall be distributed to a county for the purpose of paying the principal and interest payments on bonds issued by the county to construct a baseball stadium, as defined in RCW 82.14.0485, including reasonably necessary preconstruction costs, while the taxes are being collected under RCW 82.14.360. After this date, the state treasurer shall credit the funds to the state general fund.
- (6) Effective with vehicle registrations due or to become due on January 1, 2005, in addition to all fees and taxes required to be paid upon application and registration of a vehicle, the holder of a professional fire fighters and paramedics license plate shall pay an initial fee of forty dollars. The department shall deduct an amount not to exceed twelve dollars of each fee collected under this subsection for administration and collection expenses incurred by it. The remaining proceeds must be remitted to the custody of the state treasurer with a proper identifying detailed report. Under RCW 46.16.755, the state treasurer shall credit the proceeds to the motor vehicle account until the department determines that the state has been

- 3 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 46.16 RCW 4 to read as follows:
- (1) The "Autism Awareness" account is created in the custody of the 5 6 state treasurer. Upon the department's determination that the state 7 had been reimbursed for the cost of implementing the "Autism Awareness" 8 special license plate, all receipts, except as provided in RCW 46.16.313(25) (a) and (b), from "Autism Awareness" license plates must 9 be deposited in the account.  - (b) Development of an autism information pamphlet.
 - Sec. 5. RCW 46.16.725 and 2005 c 319 s 119 and 2005 c 210 s 7 are each reenacted and amended to read as follows:
 - (1) The creation of the board does not in any way preclude the authority of the legislature to independently propose and enact special license plate legislation.
 - (2) The board must review and either approve or reject special license plate applications submitted by sponsoring organizations.

- (c) Issue approval and rejection notification letters to sponsoring organizations, the department, the chairs of the senate and house of representatives transportation committees, and the legislative sponsors identified in each application. The letters must be issued within seven days of making a determination on the status of an application;
- (d) Review annually the number of plates sold for each special license plate series created after January 1, 2003. The board may submit a recommendation to discontinue a special plate series to the chairs of the senate and house of representatives transportation committees;
- (e) Provide policy guidance and directions to the department concerning the adoption of rules necessary to limit the number of special license plates that an organization or a governmental entity may apply for.
- (4) In order to assess the effects and impact of the proliferation 18 of special license plates, the legislature declares a temporary 19 moratorium on the issuance of any additional plates until June 1, 2007. 20 21 During this period of time, the special license plate review board 22 created in RCW 46.16.705 and the department of licensing are prohibited from accepting, reviewing, processing, or approving any applications. 23 24 Additionally, no special license plate may be enacted by the 25 legislature during the moratorium, unless the proposed license plate has been approved by the board before February 15, 2005. 26
- 27 (5) The special license plates created under section 1 of this act 28 are exempt from the requirements of this section.

- 23 (4) The special license plates created under section 1 of this act 24 are exempt from the requirements of this section.

27 Except as provided in RCW 46.16.305:

(1) When a person who has been issued a special license plate or plates: (a) Under RCW 46.16.30901, 46.16.30903, 46.16.30905, section 1 of this act, or 46.16.301 as it existed before amendment by section 5, chapter 291, Laws of 1997, or under RCW 46.16.305(2) or 46.16.324; (b) approved by the special license plate review board under RCW 46.16.715 through 46.16.775; or (c) under RCW 46.16.601 sells, trades, or otherwise transfers or releases ownership of the vehicle upon which the special license plate or plates have been displayed, he or she shall immediately report the transfer of such plate or plates to an acquired vehicle or vehicle eligible for such plates pursuant to

departmental rule, or he or she shall surrender such plates to the department immediately if such surrender is required by departmental rule. If a person applies for a transfer of the plate or plates to another eligible vehicle, a transfer fee of ten dollars shall be charged in addition to all other applicable fees. Such transfer fees shall be deposited in the motor vehicle fund. Failure to surrender the plates when required is a traffic infraction.

(2) If the special license plate or plates issued by the department become lost, defaced, damaged, or destroyed, application for a replacement special license plate or plates shall be made and fees paid as provided by law for the replacement of regular license plates.
