AN ACT Relating to establishing a state tax policy that prohibits 1 2 employers claiming certain tax incentives from requiring employees to 3 participate in certain communications about political, religious, or matters; amending 82.32.545, 4 labor organizing RCW 82.04.250, 82.04.4461, 82.04.4463, 82.04.4487, 82.08.975, 82.08.980, 82.08.981, 5 6 82.12.975, 82.12.981, 84.36.655, and 82.29A.137; adding new sections to 7 chapter 82.32 RCW; prescribing penalties; providing an effective date; providing an expiration date; and declaring an emergency. 8

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

- NEW SECTION. Sec. 1. A new section is added to chapter 82.32 RCW to read as follows:
- The definitions in this section apply throughout sections 1 through 4 of this act unless the context clearly requires otherwise.
- 14 (1) "Employer" means an employer, as defined in RCW 15 49.12.005(3)(b), who is claiming a tax incentive, and includes any 16 person acting in the interest of such an employer.
  - (2) "Employee" means the same as provided in RCW 49.12.005(4).
- 18 (3) "Labor organization" means any organization that exists for the 19 purpose, in whole or in part, of collective bargaining or of dealing

- with employers concerning grievances, terms or conditions of employment, or of other mutual aid or protection in connection with employment.
  - (4) "Political matters" includes political party affiliation or the decision to join or not join a lawful, political, social, or community group or activity, or a labor organization.
  - (5) "Tax incentive" means an exemption, credit, or preferential tax rate under this title or Title 84 RCW for persons who are manufacturers or processors for hire of commercial airplanes, or components of such airplanes, including but not limited to an exemption, credit, or preferential tax rate under RCW 82.04.250, 82.04.4461, 82.04.4463, 82.04.4487, 82.08.975, 82.08.980, 82.08.981, 82.12.975, 82.12.980, 82.12.981, 82.29A.137, or 84.36.655.
- NEW SECTION. Sec. 2. A new section is added to chapter 82.32 RCW to read as follows:
- 16 (1)(a) It is unlawful for an employer to require its employees to
  17 attend an employer-sponsored meeting or to participate in any
  18 communications with the employer if the primary purpose is to
  19 communicate the employer's opinion about religious or political
  20 matters.
  - (b) This subsection does not:

- (i) Apply to communications about religious or political matters that the employer is required by law to communicate to employees, but only to the extent of such requirement;
  - (ii) Prohibit a religious organization from requiring its employees to attend an employer-sponsored meeting or to participate in any communications with the employer if the primary purpose is to communicate the employer's religious beliefs, practices, or tenets;
  - (iii) Prohibit a political organization from requiring its employees to attend an employer-sponsored meeting or to participate in any communications with the employer if the primary purpose is to communicate the employer's political tenets or purposes; or
- (iv) Prohibit an educational institution from requiring student instructors to attend lectures on political or religious matters that are part of the regular coursework at such institution.
- 36 (2) An employer may not discharge or in any manner discriminate 37 against, or threaten to discharge or discriminate against, an employee

- 1 because the employee, or a person acting on behalf of the employee,
- 2 makes a good faith report, orally or in writing, of a violation or a
- 3 suspected violation of this section. This subsection does not apply
- 4 when the employee knows that such report is false.

- 5 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 82.32 RCW 6 to read as follows:
  - (1) An employee aggrieved by a violation of section 2 of this act may, within ninety days after the date of the alleged violation, bring a civil action in the superior court for the county where the violation is alleged to have occurred or where the employer has its principal office. The court may award a prevailing employee all appropriate relief, including rehiring or reinstatement of the employee to the employee's former position with back pay and without loss of seniority or benefits to which the employee would otherwise have been eligible if such violation had not occurred. The court shall award a prevailing employee treble damages, together with reasonable attorneys' fees and costs.
  - (2) This section does not limit an employee's right to bring a common law cause of action against an employer for wrongful termination or diminish or impair the rights of a person under a collective bargaining agreement.
- NEW SECTION. Sec. 4. A new section is added to chapter 82.32 RCW to read as follows:

A taxpayer may, within ninety days after the date of an alleged violation of section 2 of this act, bring a civil action in the superior court for the county where the violation is alleged to have occurred or where the employer has its principal office. The court may award a prevailing taxpayer all appropriate relief, including injunctive relief and other appropriate equitable relief. The court shall declare the amount of any tax incentives taken for that year to be immediately due and payable, order payment of a civil penalty equal to twice the amount of any tax incentives taken for the remainder of the year, bar the employer from claiming any tax incentives for that year and the following calendar year, and award the prevailing taxpayer reasonable attorneys' fees and costs.

- (1) The legislature finds that accountability and effectiveness are important aspects of setting tax policy. In order to make policy choices regarding the best use of limited state resources the legislature needs information on how a tax incentive is used.
- (2)(a) A person who reports taxes under RCW  $82.04.260((\frac{13}{(13)}))$  (11) or who claims an exemption or credit under RCW 82.04.4461, 82.08.980, 82.12.980, 82.29A.137, 84.36.655, and 82.04.4463 shall make an annual report to the department detailing employment, wages, and employerprovided health and retirement benefits per job at the manufacturing site. The report shall not include names of employees. The report shall also detail employment by the total number of full-time, parttime, and temporary positions. The first report filed under this subsection shall include employment, wage, and benefit information for the twelve-month period immediately before first use of a preferential tax rate under RCW  $82.04.260((\frac{(13)}{(13)}))$  (11), or tax exemption or credit under RCW 82.04.4461, 82.08.980, 82.12.980, 82.29A.137, 84.36.655, and 82.04.4463. The report is due by March 31st following any year in which a preferential tax rate under RCW  $82.04.260((\frac{(13)}{(11)}))$  is used, or tax exemption or credit under RCW 82.04.4461, 82.08.980, 82.12.980, 82.29A.137, 84.36.655, and 82.04.4463 is taken. This information is not subject to the confidentiality provisions of RCW 82.32.330 and may be disclosed to the public upon request.
  - (b) If a person fails to submit an annual report under (a) of this subsection by the due date of the report, the department shall declare the amount of taxes exempted or credited, or reduced in the case of the preferential business and occupation tax rate, for that year to be immediately due and payable. Excise taxes payable under this subsection are subject to interest but not penalties, as provided under this chapter. This information is not subject to the confidentiality provisions of RCW 82.32.330 and may be disclosed to the public upon request.
- (3) By November  $((\frac{1}{2010}, \frac{1}{2010}, \frac{1}{2010}, \frac{1}{2023}))$  1st of each even-numbered year from 2008 through 2022, the fiscal committees of the house of representatives and the senate, in consultation with the department, shall report to the legislature on the effectiveness of chapter 1, Laws of 2003 2nd sp. sess. in regard to keeping Washington

- competitive. The report shall measure the effect of chapter 1, Laws of 2003 2nd sp. sess. on job retention, net jobs created for Washington residents, company growth, diversification of the state's economy, cluster dynamics, and other factors as the committees select. The reports shall include a discussion of principles to apply in evaluating whether the legislature should reenact any or all of the tax preferences in chapter 1, Laws of 2003 2nd sp. sess.
- **Sec. 6.** RCW 82.04.250 and 2006 c 177 s 5 are each amended to read 9 as follows:

- (1) Upon every person engaging within this state in the business of making sales at retail, except persons taxable as retailers under other provisions of this chapter, as to such persons, the amount of tax with respect to such business shall be equal to the gross proceeds of sales of the business, multiplied by the rate of 0.471 percent.
- (2) Upon every person engaging within this state in the business of making sales at retail that are exempt from the tax imposed under chapter 82.08 RCW by reason of RCW 82.08.0261, 82.08.0262, or 82.08.0263, except persons taxable under RCW 82.04.260(11) or subsection (3) of this section, as to such persons, the amount of tax with respect to such business shall be equal to the gross proceeds of sales of the business, multiplied by the rate of 0.484 percent.
- (3) Upon every person engaging within this state in the business of making sales at retail that are exempt from the tax imposed under chapter 82.08 RCW by reason of RCW 82.08.0261, 82.08.0262, or 82.08.0263, that is classified by the federal aviation administration as a FAR part 145 certificated repair station with airframe and instrument ratings and limited ratings for nondestructive testing, radio, Class 3 Accessory, and specialized services, as to such persons, the amount of tax with respect to such business shall be equal to the gross proceeds of sales of the business, multiplied by the rate of .2904 percent. Every person taxed at the preferential tax rate under this subsection must comply with section 2 of this act.
- **Sec. 7.** RCW 82.04.4461 and 2003 2nd sp.s. c 1 s 7 are each amended to read as follows:
  - (1)(a) In computing the tax imposed under this chapter, a credit is

- (b) Before July 1, 2005, any credits earned under this section must be accrued and carried forward and may not be used until July 1, 2005. These carryover credits may be used at any time thereafter, and may be carried over until used. Refunds may not be granted in the place of a credit.
- 8 (2) The credit is equal to the amount of qualified preproduction 9 development expenditures of a person, multiplied by the rate of 1.5 10 percent.
  - (3) Except as provided in subsection (1)(b) of this section the credit shall be taken against taxes due for the same calendar year in which the qualified preproduction development expenditures are incurred. Credit earned on or after July 1, 2005, may not be carried over. The credit for each calendar year shall not exceed the amount of tax otherwise due under this chapter for the calendar year.   - (b) "Person" means a person as defined in RCW 82.04.030, who is a manufacturer or processor for hire of commercial airplanes, or components of such airplanes, as those terms are defined in RCW 82.32.550.
- 33 (c) "Preproduction development" means research, design, and 34 engineering activities performed in relation to the development of a 35 product, product line, model, or model derivative, including prototype 36 development, testing, and certification. The term includes the 37 discovery of technological information, the translating of 38 technological information into new or improved products, processes,

- techniques, formulas, or inventions, and the adaptation of existing products and models into new products or new models, or derivatives of products or models. The term does not include manufacturing activities or other production-oriented activities, however the term does include tool design and engineering design for the manufacturing process. term does not include surveys and studies, social science and humanities research, market research or testing, quality control, sale promotion and service, computer software developed for internal use, and research in areas such as improved style, taste, and seasonal design.
  - (d) "Preproduction development spending" means qualified preproduction development expenditures plus eighty percent of amounts paid to a person other than a public educational or research institution to conduct qualified preproduction development.
  - (e) "Qualified preproduction development" means preproduction development performed within this state in the field of aeronautics.
  - (f) "Qualified preproduction development expenditures" means operating expenses, including wages, compensation of a proprietor or a partner in a partnership as determined by the department, benefits, supplies, and computer expenses, directly incurred in qualified preproduction development by a person claiming the credit provided in this section. The term does not include amounts paid to a person other than a public educational or research institution to conduct qualified preproduction development. The term does not include capital costs and overhead, such as expenses for land, structures, or depreciable property.
  - (g) "Taxable amount" means the taxable amount subject to the tax imposed in this chapter required to be reported on the person's tax returns during the year in which the credit is claimed, less any taxable amount for which a credit is allowed under RCW 82.04.440.
  - (6) In addition to all other requirements under this title, a person taking the credit under this section must ((report as required under)) comply with RCW 82.32.545 and section 2 of this act.
- 34 (7) Credit may not be claimed for expenditures for which a credit 35 is claimed under RCW 82.04.4452.
  - (8) This section expires July 1, 2024.

  - (1) In computing the tax imposed under this chapter, a credit is allowed for property taxes and leasehold excise taxes paid during the calendar year.

- (a)(i)(A) Property taxes paid on new buildings, and land upon which this property is located, built after December 1, 2003, and used exclusively in manufacturing commercial airplanes or components of such airplanes; and
- (B) Leasehold excise taxes paid with respect to a building built after January 1, 2006, the land upon which the building is located, or both, if the building is used exclusively in manufacturing commercial airplanes or components of such airplanes; or

- calendar year may be carried over to be credited against taxes incurred in a subsequent calendar year, but may not be carried over a second year. No refunds may be granted for credits under this section.
  - (5) In addition to all other requirements under this title, a person taking the credit under this section must ((report as required under)) comply with RCW 82.32.545 and section 2 of this act.
    - (6) This section expires July 1, 2024.
