AN ACT Relating to requiring the electronic monitoring of all registered sex offenders who are classified as risk level III, have registered as homeless or transient, or have a prior conviction for failure to register as a sex offender; adding a new section to chapter 72.09 RCW; adding a new section to chapter 43.43 RCW; and making appropriations.

- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 8 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 72.09 RCW 9 to read as follows:
- 10 (1) The department shall electronically monitor every offender 11 serving a term of community custody on or after the effective date of 12 this act who is required to register as a sex offender under RCW 13 9A.44.130 and:
- 14 (a) Has been classified as risk level III;

- (b) Has registered as lacking a fixed residence; or
- 16 (c) Has a prior conviction for failure to register as a sex 17 offender under RCW 9A.44.130.
- 18 (2) All electronic monitoring under this section shall be carried 19 out using an active global positioning system.

- NEW SECTION. Sec. 2. A new section is added to chapter 43.43 RCW to read as follows:
 - (1) Except as provided in subsection (2) of this section, the Washington state patrol shall electronically monitor every offender who is required to register as a sex offender under RCW 9A.44.130 and:
 - (a) Has been classified as risk level III;

- (b) Has registered as lacking a fixed residence; or
- 8 (c) Has a prior conviction for failure to register as a sex 9 offender under RCW 9A.44.130.
- 10 (2) This section does not apply to an offender being electronically 11 monitored by the department of corrections under section 1 of this act.
- 12 (3) All electronic monitoring under this section shall be carried 13 out using an active global positioning system.
- NEW SECTION. Sec. 3. The sum of . . . dollars, or as much thereof as may be necessary, is appropriated for the fiscal year ending June 30, 2009, from the general fund to the department of corrections for the purposes of this act.
- NEW SECTION. Sec. 4. The sum of . . . dollars, or as much thereof as may be necessary, is appropriated for the fiscal year ending June 30, 2009, from the general fund to the Washington state patrol for the purposes of this act.
