## HOUSE BILL 3254

AN ACT Relating to accountability for persons driving under the influence of intoxicating liquor or drugs; amending RCW 46.20.342, 46.20.391, 46.20.400, 46.20.410, 46.20.720, 46.20.740, and 46.61.5055; reenacting and amending RCW 46.20.308 and 46.63.020; adding a new section to chapter 46.04 RCW; adding a new section to chapter 46.68 RCW; adding new sections to chapter 46.20 RCW; and providing an effective date.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

9 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 46.04 RCW 10 to read as follows:

"Ignition interlock driver's license" means a permit issued to a person by the department that allows the person to operate a noncommercial motor vehicle with an ignition interlock device while the person's regular driver's license is suspended, revoked, or denied.

15 Sec. 2. RCW 46.20.308 and 2005 c 314 s 307 and 2005 c 269 s 1 are 16 each reenacted and amended to read as follows:

(1) Any person who operates a motor vehicle within this state isdeemed to have given consent, subject to the provisions of RCW

46.61.506, to a test or tests of his or her breath or blood for the 1 2 purpose of determining the alcohol concentration or presence of any drug in his or her breath or blood if arrested for any offense where, 3 at the time of the arrest, the arresting officer has reasonable grounds 4 5 to believe the person had been driving or was in actual physical control of a motor vehicle while under the influence of intoxicating б 7 liquor or any drug or was in violation of RCW 46.61.503. Neither consent nor this section precludes a police officer from obtaining a 8 search warrant for a person's breath or blood. 9

(2) The test or tests of breath shall be administered at the 10 direction of a law enforcement officer having reasonable grounds to 11 believe the person to have been driving or in actual physical control 12 13 of a motor vehicle within this state while under the influence of intoxicating liquor or any drug or the person to have been driving or 14 in actual physical control of a motor vehicle while having alcohol in 15 a concentration in violation of RCW 46.61.503 in his or her system and 16 17 being under the age of twenty-one. However, in those instances where the person is incapable due to physical injury, physical incapacity, or 18 other physical limitation, of providing a breath sample or where the 19 20 person is being treated in a hospital, clinic, doctor's office, 21 emergency medical vehicle, ambulance, or other similar facility or 22 where the officer has reasonable grounds to believe that the person is 23 under the influence of a drug, a blood test shall be administered by a 24 qualified person as provided in RCW 46.61.506(5). The officer shall 25 inform the person of his or her right to refuse the breath or blood test, and of his or her right to have additional tests administered by 26 27 any qualified person of his or her choosing as provided in RCW The officer shall warn the driver, in substantially the 46.61.506. 28 29 following language, that:

30 (a) If the driver refuses to take the test, the driver's license,
31 permit, or privilege to drive will be revoked or denied for at least
32 one year; and

33 (b) If the driver refuses to take the test, the driver's refusal to 34 take the test may be used in a criminal trial; and

35 (c) If the driver submits to the test and the test is administered, 36 the driver's license, permit, or privilege to drive will be suspended, 37 revoked, or denied for at least ninety days if the driver is age 38 twenty-one or over and the test indicates the alcohol concentration of

the driver's breath or blood is 0.08 or more, or if the driver is under age twenty-one and the test indicates the alcohol concentration of the driver's breath or blood is 0.02 or more, or if the driver is under age twenty-one and the driver is in violation of RCW 46.61.502 or 46.61.504; and

6 (d) If the driver's license, permit, or privilege to drive is
7 suspended, revoked, or denied the driver may be eligible to immediately
8 apply for an ignition interlock driver's license.

(3) Except as provided in this section, the test administered shall 9 10 be of the breath only. If an individual is unconscious or is under arrest for the crime of vehicular homicide as provided in RCW 46.61.520 11 12 or vehicular assault as provided in RCW 46.61.522, or if an individual 13 is under arrest for the crime of driving while under the influence of intoxicating liquor or drugs as provided in RCW 46.61.502, which arrest 14 results from an accident in which there has been serious bodily injury 15 16 to another person, a breath or blood test may be administered without 17 the consent of the individual so arrested.

18 (4) Any person who is dead, unconscious, or who is otherwise in a 19 condition rendering him or her incapable of refusal, shall be deemed 20 not to have withdrawn the consent provided by subsection (1) of this 21 section and the test or tests may be administered, subject to the 22 provisions of RCW 46.61.506, and the person shall be deemed to have 23 received the warnings required under subsection (2) of this section.

(5) If, following his or her arrest and receipt of warnings under subsection (2) of this section, the person arrested refuses upon the request of a law enforcement officer to submit to a test or tests of his or her breath or blood, no test shall be given except as authorized under subsection (3) or (4) of this section.

(6) If, after arrest and after the other applicable conditions and 29 requirements of this section have been satisfied, a test or tests of 30 the person's blood or breath is administered and the test results 31 32 indicate that the alcohol concentration of the person's breath or blood is 0.08 or more if the person is age twenty-one or over, or 0.02 or 33 more if the person is under the age of twenty-one, or the person 34 refuses to submit to a test, the arresting officer or other law 35 enforcement officer at whose direction any test has been given, or the 36 37 department, where applicable, if the arrest results in a test of the 38 person's blood, shall:

1 (a) Serve notice in writing on the person on behalf of the 2 department of its intention to suspend, revoke, or deny the person's 3 license, permit, or privilege to drive as required by subsection (7) of 4 this section;

5 (b) Serve notice in writing on the person on behalf of the 6 department of his or her right to a hearing, specifying the steps he or 7 she must take to obtain a hearing as provided by subsection (8) of this 8 section and that the person waives the right to a hearing if he or she 9 receives an ignition interlock driver's license;

10 (c) Mark the person's Washington state driver's license or permit 11 to drive, if any, in a manner authorized by the department;

12 (d) Serve notice in writing that the marked license or permit, if 13 any, is a temporary license that is valid for sixty days from the date 14 of arrest or from the date notice has been given in the event notice is given by the department following a blood test, or until the 15 suspension, revocation, or denial of the person's license, permit, or 16 17 privilege to drive is sustained at a hearing pursuant to subsection (8) of this section, whichever occurs first. No temporary license is valid 18 to any greater degree than the license or permit that it replaces; and 19 20 (e) Immediately notify the department of the arrest and transmit to 21 the department within seventy-two hours, except as delayed as the 22 result of a blood test, a sworn report or report under a declaration 23 authorized by RCW 9A.72.085 that states:

(i) That the officer had reasonable grounds to believe the arrested
person had been driving or was in actual physical control of a motor
vehicle within this state while under the influence of intoxicating
liquor or drugs, or both, or was under the age of twenty-one years and
had been driving or was in actual physical control of a motor vehicle
while having an alcohol concentration in violation of RCW 46.61.503;

(ii) That after receipt of the warnings required by subsection (2) of this section the person refused to submit to a test of his or her blood or breath, or a test was administered and the results indicated that the alcohol concentration of the person's breath or blood was 0.08 or more if the person is age twenty-one or over, or was 0.02 or more if the person is under the age of twenty-one; and

(iii) Any other information that the director may require by rule.
(7) The department of licensing, upon the receipt of a sworn report
or report under a declaration authorized by RCW 9A.72.085 under

subsection (6)(e) of this section, shall suspend, revoke, or deny the 1 2 person's license, permit, or privilege to drive or any nonresident operating privilege, as provided in RCW 46.20.3101, such suspension, 3 revocation, or denial to be effective beginning sixty days from the 4 5 date of arrest or from the date notice has been given in the event notice is given by the department following a blood test, or when б 7 sustained at a hearing pursuant to subsection (8) of this section, whichever occurs first. 8

(8) A person receiving notification under subsection (6)(b) of this 9 10 section may, within ((thirty)) twenty days after the notice has been given, request in writing a formal hearing before the department. 11 The 12 person shall pay a fee of two hundred dollars as part of the request. 13 If the request is mailed, it must be postmarked within ((thirty)) 14 twenty days after receipt of the notification. Upon timely receipt of such a request for a formal hearing, including receipt of the required 15 two hundred dollar fee, the department shall afford the person an 16 17 opportunity for a hearing. The department may waive the required two hundred dollar fee if the person is an indigent as defined in RCW 18 10.101.010. Except as otherwise provided in this section, the hearing 19 is subject to and shall be scheduled and conducted in accordance with 20 21 RCW 46.20.329 and 46.20.332. The hearing shall be conducted in the 22 county of the arrest, except that all or part of the hearing may, at the discretion of the department, be conducted by telephone or other 23 24 electronic means. The hearing shall be held within sixty days 25 following the arrest or following the date notice has been given in the event notice is given by the department following a blood test, unless 26 27 otherwise agreed to by the department and the person, in which case the action by the department shall be stayed, and any valid temporary 28 license marked under subsection (6)(c) of this section extended, if the 29 person is otherwise eligible for licensing. For the purposes of this 30 31 section, the scope of the hearing shall cover the issues of whether a 32 law enforcement officer had reasonable grounds to believe the person had been driving or was in actual physical control of a motor vehicle 33 within this state while under the influence of intoxicating liquor or 34 any drug or had been driving or was in actual physical control of a 35 motor vehicle within this state while having alcohol in his or her 36 37 system in a concentration of 0.02 or more if the person was under the 38 age of twenty-one, whether the person was placed under arrest, and (a)

whether the person refused to submit to the test or tests upon request 1 2 of the officer after having been informed that such refusal would result in the revocation of the person's license, permit, or privilege 3 to drive, or (b) if a test or tests were administered, whether the 4 5 applicable requirements of this section were satisfied before the administration of the test or tests, whether the person submitted to 6 7 the test or tests, or whether a test was administered without express consent as permitted under this section, and whether the test or tests 8 indicated that the alcohol concentration of the person's breath or 9 10 blood was 0.08 or more if the person was age twenty-one or over at the time of the arrest, or 0.02 or more if the person was under the age of 11 twenty-one at the time of the arrest. The sworn report or report under 12 a declaration authorized by RCW 9A.72.085 submitted by a 13 law 14 enforcement officer is prima facie evidence that the officer had reasonable grounds to believe the person had been driving or was in 15 actual physical control of a motor vehicle within this state while 16 17 under the influence of intoxicating liquor or drugs, or both, or the person had been driving or was in actual physical control of a motor 18 vehicle within this state while having alcohol in his or her system in 19 a concentration of 0.02 or more and was under the age of twenty-one and 20 21 that the officer complied with the requirements of this section.

22 A hearing officer shall conduct the hearing, may issue subpoenas for the attendance of witnesses and the production of documents, and 23 24 shall administer oaths to witnesses. The hearing officer shall not issue a subpoena for the attendance of a witness at the request of the 25 person unless the request is accompanied by the fee required by RCW 26 27 5.56.010 for a witness in district court. The sworn report or report under a declaration authorized by RCW 9A.72.085 of the law enforcement 28 officer and any other evidence accompanying the report shall be 29 further evidentiary foundation 30 admissible without and the certifications authorized by the criminal rules for courts of limited 31 32 jurisdiction shall be admissible without further evidentiary The person may be represented by counsel, may question 33 foundation. witnesses, may present evidence, and may testify. The department shall 34 order that the suspension, revocation, or denial either be rescinded or 35 sustained. 36

37 (9) If the suspension, revocation, or denial is sustained after38 such a hearing, the person whose license, privilege, or permit is

suspended, revoked, or denied has the right to file a petition in the 1 2 superior court of the county of arrest to review the final order of revocation by the department in the same manner as an appeal from a 3 decision of a court of limited jurisdiction. Notice of appeal must be 4 5 filed within thirty days after the date the final order is served or the right to appeal is waived. Notwithstanding RCW 46.20.334, RALJ 6 7 1.1, or other statutes or rules referencing de novo review, the appeal shall be limited to a review of the record of the administrative 8 hearing. The appellant must pay the costs associated with obtaining 9 10 the record of the hearing before the hearing officer. The filing of the appeal does not stay the effective date of the suspension, 11 12 revocation, or denial. A petition filed under this subsection must include the petitioner's grounds for requesting review. Upon granting 13 14 petitioner's request for review, the court shall review the department's final order of suspension, revocation, or denial as 15 The review must be limited to a 16 expeditiously as possible. determination of whether the department has committed any errors of 17 The superior court shall accept those factual determinations 18 law. supported by substantial evidence in the record: (a) That were 19 expressly made by the department; or (b) that may reasonably be 20 21 inferred from the final order of the department. The superior court 22 may reverse, affirm, or modify the decision of the department or remand the case back to the department for further proceedings. The decision 23 24 of the superior court must be in writing and filed in the clerk's 25 office with the other papers in the case. The court shall state the reasons for the decision. If judicial relief is sought for a stay or 26 27 other temporary remedy from the department's action, the court shall not grant such relief unless the court finds that the appellant is 28 likely to prevail in the appeal and that without a stay the appellant 29 will suffer irreparable injury. If the court stays the suspension, 30 31 revocation, or denial it may impose conditions on such stay.

(10)(a) If a person whose driver's license, permit, or privilege to drive has been or will be suspended, revoked, or denied under subsection (7) of this section, other than as a result of a breath or blood test refusal, and who has not committed an offense for which he or she was granted a deferred prosecution under chapter 10.05 RCW, petitions a court for a deferred prosecution on criminal charges arising out of the arrest for which action has been or will be taken

under subsection (7) of this section, or notifies the department of 1 2 licensing of the intent to seek such a deferred prosecution, then the license suspension or revocation shall be stayed pending entry of the 3 deferred prosecution. The stay shall not be longer than one hundred 4 fifty days after the date charges are filed, or two years after the 5 date of the arrest, whichever time period is shorter. If the court 6 7 stays the suspension, revocation, or denial, it may impose conditions on such stay. If the person is otherwise eligible for licensing, the 8 9 department shall issue a temporary license, or extend any valid 10 temporary license marked under subsection (6) of this section, for the period of the stay. If a deferred prosecution treatment plan is not 11 12 recommended in the report made under RCW 10.05.050, or if treatment is 13 rejected by the court, or if the person declines to accept an offered 14 treatment plan, or if the person violates any condition imposed by the court, then the court shall immediately direct the department to cancel 15 the stay and any temporary marked license or extension of a temporary 16 17 license issued under this subsection.

(b) A suspension, revocation, or denial imposed under this section, 18 other than as a result of a breath or blood test refusal, shall be 19 stayed if the person is accepted for deferred prosecution as provided 20 21 in chapter 10.05 RCW for the incident upon which the suspension, 22 revocation, or denial is based. If the deferred prosecution is terminated, the stay shall be lifted and the suspension, revocation, or 23 24 denial reinstated. If the deferred prosecution is completed, the stay 25 shall be lifted and the suspension, revocation, or denial canceled.

(c) The provisions of (b) of this subsection relating to a stay of a suspension, revocation, or denial and the cancellation of any suspension, revocation, or denial do not apply to the suspension, revocation, denial, or disqualification of a person's commercial driver's license or privilege to operate a commercial motor vehicle.

(11) When it has been finally determined under the procedures of this section that a nonresident's privilege to operate a motor vehicle in this state has been suspended, revoked, or denied, the department shall give information in writing of the action taken to the motor vehicle administrator of the state of the person's residence and of any state in which he or she has a license.

<u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 46.68 RCW
 to read as follows:

The ignition interlock device revolving fund is created in the 3 custody of the state treasurer to assist in covering the monetary costs 4 5 of installing, removing, and leasing an ignition interlock device for indigent people who are required under section 8 of this act and RCW 6 7 46.61.5055 to install an ignition interlock device in all vehicles owned or operated by the person. The director, or his or her designee, 8 9 is authorized to expend money from the ignition interlock device 10 revolving fund. The account is subject to allotment procedures under chapter 43.88 RCW, but an appropriation is not required for 11 12 expenditures.

13 Sec. 4. RCW 46.20.342 and 2004 c 95 s 5 are each amended to read 14 as follows:

(1) It is unlawful for any person to drive a motor vehicle in this state while that person is in a suspended or revoked status or when his or her privilege to drive is suspended or revoked in this or any other state. Any person who has a valid Washington driver's license is not guilty of a violation of this section.

20 (a) A person found to be an habitual offender under chapter 46.65 21 RCW, who violates this section while an order of revocation issued under chapter 46.65 RCW prohibiting such operation is in effect, is 22 23 guilty of driving while license suspended or revoked in the first 24 degree, a gross misdemeanor. Upon the first such conviction, the person shall be punished by imprisonment for not less than ten days. 25 26 Upon the second conviction, the person shall be punished by 27 imprisonment for not less than ninety days. Upon the third or subsequent conviction, the person shall be punished by imprisonment for 28 not less than one hundred eighty days. If the person is also convicted 29 30 of the offense defined in RCW 46.61.502 or 46.61.504, when both 31 convictions arise from the same event, the minimum sentence of confinement shall be not less than ninety days. The minimum sentence 32 of confinement required shall not be suspended or deferred. 33 Α conviction under this subsection does not prevent a person from 34 petitioning for reinstatement as provided by RCW 46.65.080. 35

36 (b) A person who violates this section while an order of suspension 37 or revocation prohibiting such operation is in effect and while the

person is not eligible to reinstate his or her driver's license or driving privilege, other than for a suspension for the reasons described in (c) of this subsection, is guilty of driving while license suspended or revoked in the second degree, a gross misdemeanor. This subsection applies when a person's driver's license or driving privilege has been suspended or revoked by reason of:

7 (i) A conviction of a felony in the commission of which a motor 8 vehicle was used;

(ii) A previous conviction under this section;

10 (iii) A notice received by the department from a court or diversion 11 unit as provided by RCW 46.20.265, relating to a minor who has 12 committed, or who has entered a diversion unit concerning an offense 13 relating to alcohol, legend drugs, controlled substances, or imitation 14 controlled substances;

(iv) A conviction of RCW 46.20.410, relating to the violation of restrictions of an occupational ((<del>or</del>)) <u>driver's license</u>, a temporary restricted driver's license, or an ignition interlock <u>driver's license</u>;

18 (v) A conviction of RCW 46.20.345, relating to the operation of a 19 motor vehicle with a suspended or revoked license;

20 (vi) A conviction of RCW 46.52.020, relating to duty in case of 21 injury to or death of a person or damage to an attended vehicle;

(vii) A conviction of RCW 46.61.024, relating to attempting to
 elude pursuing police vehicles;

(viii) A conviction of RCW 46.61.500, relating to reckless driving;
 (ix) A conviction of RCW 46.61.502 or 46.61.504, relating to a
 person under the influence of intoxicating liquor or drugs;

27 (x) A conviction of RCW 46.61.520, relating to vehicular homicide;

28 (xi) A conviction of RCW 46.61.522, relating to vehicular assault; 29 (xii) A conviction of RCW 46.61.527(4), relating to reckless 30 endangerment of roadway workers;

31 (xiii) A conviction of RCW 46.61.530, relating to racing of 32 vehicles on highways;

33 (xiv) A conviction of RCW 46.61.685, relating to leaving children34 in an unattended vehicle with motor running;

35 (xv) A conviction of RCW 46.61.740, relating to theft of motor 36 vehicle fuel;

37 (xvi) A conviction of RCW 46.64.048, relating to attempting,
 38 aiding, abetting, coercing, and committing crimes;

(xvii) An administrative action taken by the department under
 chapter 46.20 RCW; or

3 (xviii) A conviction of a local law, ordinance, regulation, or 4 resolution of a political subdivision of this state, the federal 5 government, or any other state, of an offense substantially similar to 6 a violation included in this subsection.

7 (c) A person who violates this section when his or her driver's license or driving privilege is, at the time of the violation, 8 suspended or revoked solely because (i) the person must furnish proof 9 of satisfactory progress in a required alcoholism or drug treatment 10 program, (ii) the person must furnish proof of financial responsibility 11 12 for the future as provided by chapter 46.29 RCW, (iii) the person has 13 failed to comply with the provisions of chapter 46.29 RCW relating to 14 uninsured accidents, (iv) the person has failed to respond to a notice of traffic infraction, failed to appear at a requested hearing, 15 16 violated a written promise to appear in court, or has failed to comply 17 with the terms of a notice of traffic infraction or citation, as provided in RCW 46.20.289, (v) the person has committed an offense in 18 another state that, if committed in this state, would not be grounds 19 for the suspension or revocation of the person's driver's license, (vi) 20 21 the person has been suspended or revoked by reason of one or more of 22 the items listed in (b) of this subsection, but was eligible to reinstate his or her driver's license or driving privilege at the time 23 24 of the violation, or (vii) the person has received traffic citations or 25 notices of traffic infraction that have resulted in a suspension under RCW 46.20.267 relating to intermediate drivers' licenses, or any 26 27 combination of (i) through (vii), is guilty of driving while license suspended or revoked in the third degree, a misdemeanor. 28

(2) Upon receiving a record of conviction of any person or upon receiving an order by any juvenile court or any duly authorized court officer of the conviction of any juvenile under this section, the department shall:

(a) For a conviction of driving while suspended or revoked in the first degree, as provided by subsection (1)(a) of this section, extend the period of administrative revocation imposed under chapter 46.65 RCW for an additional period of one year from and after the date the person would otherwise have been entitled to apply for a new license or have his or her driving privilege restored; or 1 (b) For a conviction of driving while suspended or revoked in the 2 second degree, as provided by subsection (1)(b) of this section, not 3 issue a new license or restore the driving privilege for an additional 4 period of one year from and after the date the person would otherwise 5 have been entitled to apply for a new license or have his or her 6 driving privilege restored; or

7 (c) Not extend the period of suspension or revocation if the 8 conviction was under subsection (1)(c) of this section. If the 9 conviction was under subsection (1)(a) or (b) of this section and the 10 court recommends against the extension and the convicted person has 11 obtained a valid driver's license, the period of suspension or 12 revocation shall not be extended.

13 Sec. 5. RCW 46.20.391 and 2004 c 95 s 7 are each amended to read 14 as follows:

15  $(1)((\frac{1}{2}))$  Any person licensed under this chapter who is convicted 16 of an offense relating to motor vehicles for which suspension or 17 revocation of the driver's license is mandatory, other than vehicular homicide ((or)), vehicular assault, ((or who has had his or her license 18 suspended, revoked, or denied under RCW 46.20.3101)) driving while 19 20 under the influence of intoxicating liquor or any drug, or being in actual physical control of a motor vehicle while under the influence of 21 intoxicating liquor or any drug, may submit to the department an 22 23 application for a temporary restricted driver's license. The 24 department, upon receipt of the prescribed fee and upon determining that the petitioner is eligible to receive the license, may issue a 25 26 temporary restricted driver's license and may set definite restrictions as provided in RCW 46.20.394. ((No person may petition for, and the 27 department shall not issue, a temporary restricted driver's license 28 29 that is effective during the first thirty days of any suspension or 30 revocation imposed for a violation of RCW 46.61.502 or 46.61.504 or, 31 for a suspension, revocation, or denial imposed under RCW 46.20.3101, during the required minimum portion of the periods of suspension, 32 revocation, or denial established under (c) of this subsection. 33

34 (b) An applicant under this subsection whose driver's license is
 35 suspended or revoked for an alcohol-related offense shall provide proof
 36 to the satisfaction of the department that a functioning ignition

1 interlock device has been installed on a vehicle owned or operated by

2 the person.

3 (i) The department shall require the person to maintain such a 4 device on a vehicle owned or operated by the person and shall restrict 5 the person to operating only vehicles equipped with such a device, for 6 the remainder of the period of suspension, revocation, or denial.

7 (ii) Subject to any periodic renewal requirements established by 8 the department pursuant to this section and subject to any applicable compliance requirements under this chapter or other law, a temporary 9 10 restricted driver's license granted after a suspension or revocation 11 under RCW 46.61.5055 or 46.20.3101 extends through the remaining 12 portion of any concurrent or consecutive suspension or revocation that 13 may be imposed as the result of administrative action and criminal 14 conviction arising out of the same incident.

15 (iii) The time period during which the person is licensed under 16 this section shall apply on a day for day basis toward satisfying the 17 period of time the ignition interlock device restriction is required 18 under RCW 46.20.720 (1) and (2) (a), (b), and (c).

(c) The department shall provide by rule the minimum portions of 19 the periods of suspension, revocation, or denial set forth in RCW 20 21 46.20.3101 after which a person may apply for a temporary restricted driver's license under this section. 10 (b) In the case of a person whose alcohol concentration was at 11 least 0.15, or for whom by reason of the person's refusal to take a 12 test offered pursuant to RCW 46.20.308 there is no test result 13 indicating the person's alcohol concentration:

(i) By imprisonment for not less than forty-five days nor more than 14 one year and ninety days of electronic home monitoring. The offender 15 shall pay for the cost of the electronic monitoring. The county or 16 17 municipality where the penalty is being imposed shall determine the The court may also require the offender's electronic home 18 cost. monitoring device include an alcohol detection breathalyzer, and may 19 restrict the amount of alcohol the offender may consume during the time 20 21 the offender is on electronic home monitoring. Forty-five days of 22 imprisonment and ninety days of electronic home monitoring may not be suspended or deferred unless the court finds that the imposition of 23 24 this mandatory minimum sentence would impose a substantial risk to the 25 offender's physical or mental well-being. Whenever the mandatory minimum sentence is suspended or deferred, the court shall state in 26 27 writing the reason for granting the suspension or deferral and the facts upon which the suspension or deferral is based; and 28

(ii) By a fine of not less than seven hundred fifty dollars nor more than five thousand dollars. Seven hundred fifty dollars of the fine may not be suspended or deferred unless the court finds the offender to be indigent.

33 (3) Except as provided in RCW 46.61.502(6) or 46.61.504(6), a 34 person who is convicted of a violation of RCW 46.61.502 or 46.61.504 35 and who has two or three prior offenses within seven years shall be 36 punished as follows:

(a) In the case of a person whose alcohol concentration was less

1 than 0.15, or for whom for reasons other than the person's refusal to 2 take a test offered pursuant to RCW 46.20.308 there is no test result 3 indicating the person's alcohol concentration:

(ii) By a fine of not less than one thousand dollars nor more than five thousand dollars. One thousand dollars of the fine may not be suspended or deferred unless the court finds the offender to be indigent; or

(b) In the case of a person whose alcohol concentration was at least 0.15, or for whom by reason of the person's refusal to take a test offered pursuant to RCW 46.20.308 there is no test result indicating the person's alcohol concentration:

(i) By imprisonment for not less than one hundred twenty days nor 28 more than one year and one hundred fifty days of electronic home 29 monitoring. The offender shall pay for the cost of the electronic 30 31 monitoring. The county or municipality where the penalty is being 32 imposed shall determine the cost. The court may also require the offender's electronic home monitoring device include an alcohol 33 detection breathalyzer, and may restrict the amount of alcohol the 34 offender may consume during the time the offender is on electronic home 35 monitoring. One hundred twenty days of imprisonment and one hundred 36 37 fifty days of electronic home monitoring may not be suspended or 38 deferred unless the court finds that the imposition of this mandatory 1 minimum sentence would impose a substantial risk to the offender's 2 physical or mental well-being. Whenever the mandatory minimum sentence 3 is suspended or deferred, the court shall state in writing the reason 4 for granting the suspension or deferral and the facts upon which the 5 suspension or deferral is based; and

6 (ii) By a fine of not less than one thousand five hundred dollars 7 nor more than five thousand dollars. One thousand five hundred dollars 8 of the fine may not be suspended or deferred unless the court finds the 9 offender to be indigent.

10 (4) A person who is convicted of a violation of RCW 46.61.502 or 11 46.61.504 and who has four or more prior offenses within ten years, or 12 who has ever previously been convicted of a violation of RCW 46.61.520 13 committed while under the influence of intoxicating liquor or any drug 14 or RCW 46.61.522 committed while under the influence of intoxicating 15 liquor or any drug, shall be punished in accordance with chapter 9.94A 16 RCW.

17 (5)(a) The court shall require any person convicted of a violation 18 of RCW 46.61.502 or 46.61.504 to apply for an ignition interlock 19 driver's license from the department under section 8 of this act and to 20 have a functioning ignition interlock device installed on all motor 21 vehicles operated by the person.

(b) The installation of an ignition interlock device is not
 necessary on vehicles owned by a person's employer and driven as a
 requirement of employment during working hours.

(c) An ignition interlock device imposed under this section shall
 be calibrated to prevent a motor vehicle from being started when the
 breath sample provided has an alcohol concentration of 0.025 or more.

(d) The court may waive the requirement that a person obtain an ignition interlock driver's license and operate only vehicles equipped with a functioning ignition interlock device if the court makes a specific finding in writing that the devices are not reasonably available in the local area, that the person does not operate a vehicle, or the person is not eligible to receive an ignition interlock driver's license under section 8 of this act.

35 (e) When the requirement that a person obtain an ignition interlock 36 driver's license and operate only vehicles equipped with a functioning 37 ignition interlock device is waived by the court, the court shall order the person to submit to alcohol monitoring through an alcohol detection breathalyzer device, transdermal sensor device, or other technology designed to detect alcohol in a person's system.

4 (f) The period of time for which ignition interlock use or alcohol
5 monitoring is required will be as follows:

6 (i) For a person who has not previously been restricted under this
7 section, a period of one year;

8 (ii) For a person who has previously been restricted under (f)(i)
9 of this subsection, a period of five years;

10 (iii) For a person who has previously been restricted under (f)(ii) 11 of this subsection, a period of ten years.

12 (6) If a person who is convicted of a violation of RCW 46.61.502 or 13 46.61.504 committed the offense while a passenger under the age of 14 sixteen was in the vehicle, the court shall:

(a) In any case in which the installation and use of an interlock or other device is not mandatory under RCW 46.20.720 or other law, order the use of such a device for not less than sixty days following the restoration of the person's license, permit, or nonresident driving privileges; and

20 (b) In any case in which the installation and use of such a device 21 is otherwise mandatory, order the use of such a device for an 22 additional sixty days.

23 (((-6))) (7) In exercising its discretion in setting penalties 24 within the limits allowed by this section, the court shall particularly 25 consider the following:

(a) Whether the person's driving at the time of the offense was
 responsible for injury or damage to another or another's property; and

(b) Whether at the time of the offense the person was driving or inphysical control of a vehicle with one or more passengers.

30 (((7))) <u>(8)</u> An offender punishable under this section is subject to 31 the alcohol assessment and treatment provisions of RCW 46.61.5056.

32 ((<del>(8)</del>)) <u>(9)</u> The license, permit, or nonresident privilege of a 33 person convicted of driving or being in physical control of a motor 34 vehicle while under the influence of intoxicating liquor or drugs must:

35 (a) If the person's alcohol concentration was less than 0.15, or if 36 for reasons other than the person's refusal to take a test offered 37 under RCW 46.20.308 there is no test result indicating the person's 38 alcohol concentration: (i) Where there has been no prior offense within seven years, be
 suspended or denied by the department for ninety days;

3 (ii) Where there has been one prior offense within seven years, be
4 revoked or denied by the department for two years; or

5 (iii) Where there have been two or more prior offenses within seven 6 years, be revoked or denied by the department for three years;

(b) If the person's alcohol concentration was at least 0.15:

8 (i) Where there has been no prior offense within seven years, be 9 revoked or denied by the department for one year;

10 (ii) Where there has been one prior offense within seven years, be 11 revoked or denied by the department for nine hundred days; or

(iii) Where there have been two or more prior offenses within sevenyears, be revoked or denied by the department for four years; or

14 (c) If by reason of the person's refusal to take a test offered 15 under RCW 46.20.308, there is no test result indicating the person's 16 alcohol concentration:

(i) Where there have been no prior offenses within seven years, berevoked or denied by the department for two years;

(ii) Where there has been one prior offense within seven years, be revoked or denied by the department for three years; or

(iii) Where there have been two or more previous offenses withinseven years, be revoked or denied by the department for four years.

The department shall grant credit on a day-for-day basis for any portion of a suspension, revocation, or denial already served under this subsection for a suspension, revocation, or denial imposed under RCW 46.20.3101 arising out of the same incident.

For purposes of this subsection  $((\frac{(8)}{)})$  (9), the department shall refer to the driver's record maintained under RCW 46.52.120 when determining the existence of prior offenses.

30 ((<del>(9)</del>)) <u>(10)</u> After expiration of any period of suspension, 31 revocation, or denial of the offender's license, permit, or privilege 32 to drive required by this section, the department shall place the 33 offender's driving privilege in probationary status pursuant to RCW 34 46.20.355.

35 (((10))) (11)(a) In addition to any nonsuspendable and 36 nondeferrable jail sentence required by this section, whenever the 37 court imposes less than one year in jail, the court shall also suspend 38 but shall not defer a period of confinement for a period not exceeding

five years. The court shall impose conditions of probation that 1 2 include: (i) Not driving a motor vehicle within this state without a valid license to drive and proof of financial responsibility for the 3 future; (ii) not driving a motor vehicle within this state while having 4 an alcohol concentration of 0.08 or more within two hours after 5 driving; and (iii) not refusing to submit to a test of his or her 6 7 breath or blood to determine alcohol concentration upon request of a law enforcement officer who has reasonable grounds to believe the 8 person was driving or was in actual physical control of a motor vehicle 9 10 within this state while under the influence of intoxicating liquor. impose conditions of probation 11 The court may that include 12 nonrepetition, installation of an ignition interlock device on the probationer's motor vehicle, alcohol or drug treatment, supervised 13 14 probation, or other conditions that may be appropriate. (b) For each violation of mandatory conditions of probation under (a)(i), (ii), or (iii) of this subsection, the court shall order the convicted person to be confined for thirty days, which shall not be suspended or deferred.

21 (c) For each incident involving a violation of a mandatory 22 condition of probation imposed under this subsection, the license, permit, or privilege to drive of the person shall be suspended by the 23 24 court for thirty days or, if such license, permit, or privilege to 25 drive already is suspended, revoked, or denied at the time the finding of probation violation is made, the suspension, revocation, or denial 26 27 then in effect shall be extended by thirty days. 31 (((11))) (12) A court may waive the electronic home monitoring
32 requirements of this chapter when:

33 (a) The offender does not have a dwelling, telephone service, or34 any other necessity to operate an electronic home monitoring system;

35 (b) The offender does not reside in the state of Washington; or 36 (c) The court determines that there is reason to believe that the 37 offender would violate the conditions of the electronic home monitoring 38 penalty. 1 Whenever the mandatory minimum term of electronic home monitoring 2 is waived, the court shall state in writing the reason for granting the 3 waiver and the facts upon which the waiver is based, and shall impose 4 an alternative sentence with similar punitive consequences. The 5 alternative sentence may include, but is not limited to, additional 6 jail time, work crew, or work camp.

7 Whenever the combination of jail time and electronic home 8 monitoring or alternative sentence would exceed three hundred sixty-9 five days, the offender shall serve the jail portion of the sentence 10 first, and the electronic home monitoring or alternative portion of the 11 sentence shall be reduced so that the combination does not exceed three 12 hundred sixty-five days.

13 ((<del>(12)</del>)) <u>(13)</u> An offender serving a sentence under this section, 14 whether or not a mandatory minimum term has expired, may be granted an 15 extraordinary medical placement by the jail administrator subject to 16 the standards and limitations set forth in RCW 9.94A.728(4).

17 ((<del>(13)</del>)) <u>(14)</u> For purposes of this section and RCW 46.61.502 and 18 46.61.504:

(a) A "prior offense" means any of the following:

(i) A conviction for a violation of RCW 46.61.502 or an equivalent
 local ordinance;

(ii) A conviction for a violation of RCW 46.61.504 or an equivalentlocal ordinance;

(iii) A conviction for a violation of RCW 46.61.520 committed whileunder the influence of intoxicating liquor or any drug;

26 (iv) A conviction for a violation of RCW 46.61.522 committed while 27 under the influence of intoxicating liquor or any drug;

(v) A conviction for a violation of RCW 46.61.5249, 46.61.500, or 9A.36.050 or an equivalent local ordinance, if the conviction is the result of a charge that was originally filed as a violation of RCW 46.61.502 or 46.61.504, or an equivalent local ordinance, or of RCW 46.61.520 or 46.61.522;

33 (vi) An out-of-state conviction for a violation that would have 34 been a violation of (a)(i), (ii), (iii), (iv), or (v) of this 35 subsection if committed in this state;

36 (vii) A deferred prosecution under chapter 10.05 RCW granted in a 37 prosecution for a violation of RCW 46.61.502, 46.61.504, or an 38 equivalent local ordinance; or

1 (viii) A deferred prosecution under chapter 10.05 RCW granted in a 2 prosecution for a violation of RCW 46.61.5249, or an equivalent local 3 ordinance, if the charge under which the deferred prosecution was 4 granted was originally filed as a violation of RCW 46.61.502 or 5 46.61.504, or an equivalent local ordinance, or of RCW 46.61.520 or 6 46.61.522;

7 (b) "Within seven years" means that the arrest for a prior offense
8 occurred within seven years of the arrest for the current offense; and
9 (c) "Within ten years" means that the arrest for a prior offense
10 occurred within ten years of the arrest for the current offense.
