SENATE BILL 5479

State of Washington 60th Legislature 2007 Regular Session

- AN ACT Relating to classified staff to student ratios; amending RCW 28A.150.260; and creating a new section.
- 2 Zok. 130. 2007 and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. Sec. 1. The legislature finds that classified school 4 5 employees are an integral part of the K-12 school system of services and supports to students. The public school system would not function 6 7 without the significant contributions of these employees. 8 services range from maintaining our investment in the physical plants; 9 keeping our schools sanitary and clean; getting students safely to and from school; maintaining a safe and secure environment; providing 10 health services, food services, and clerical and financial support 11 12 services; and providing library assistance and instructional assistance 13 to students in the classroom, as well as many other invaluable supports to students, parents, and other staff within the school community. The 14 15 legislature believes the contribution of classified school employees can and should be enhanced to help all students succeed. 16
- 17 **Sec. 2.** RCW 28A.150.260 and 2006 c 263 s 322 are each amended to 18 read as follows:

p. 1 SB 5479

The basic education allocation for each annual average full_time equivalent student shall be determined in accordance with the following procedures:

- (1) The governor shall and the superintendent of public instruction may recommend to the legislature a formula based on a ratio of students to staff for the distribution of a basic education allocation for each annual average full_time equivalent student enrolled in a common school. The distribution formula shall have the primary objective of equalizing educational opportunities and shall provide appropriate recognition of the following costs among the various districts within the state:
 - (a) Certificated instructional staff and their related costs;
 - (b) Certificated administrative staff and their related costs;
 - (c) Classified staff and their related costs;
 - (d) Nonsalary costs;

- (e) Extraordinary costs, including school facilities, of remote and necessary schools as judged by the superintendent of public instruction, with recommendations from the school facilities citizen advisory panel under RCW 28A.525.025, and small high schools, including costs of additional certificated and classified staff; and
- (f) The attendance of students pursuant to RCW 28A.335.160 and 28A.225.250 who do not reside within the servicing school district.
- (2)(a) This formula for distribution of basic education funds shall be reviewed biennially by the superintendent and governor. The recommended formula shall be subject to approval, amendment or rejection by the legislature. The formula shall be for allocation purposes only. While the legislature intends that the allocations for additional instructional staff be used to increase the ratio of such staff to students, nothing in this section shall require districts to reduce the number of administrative staff below existing levels.
- (b) The formula adopted by the legislature shall reflect the following ratios at a minimum: (i) Forty-nine certificated instructional staff to one thousand annual average full_time equivalent students enrolled in grades kindergarten through three; (ii) forty-six certificated instructional staff to one thousand annual average full_time equivalent students in grades four through twelve; (iii) four certificated administrative staff to one thousand annual average full_time equivalent students in grades kindergarten through twelve;

and (iv) ((sixteen and sixty seven one-hundredths classified personnel to one thousand)) one classified staff unit for each forty annual average full_time equivalent students enrolled in grades kindergarten through twelve.

- (c) In the event the legislature rejects the distribution formula 5 recommended by the governor, without adopting a new distribution 6 7 formula, the distribution formula for the previous school year shall 8 remain in effect: PROVIDED, That the distribution formula developed pursuant to this section shall be for state apportionment and 9 equalization purposes only and shall not be construed as mandating 10 specific operational functions of local school districts other than 11 12 those program requirements identified in RCW 28A.150.220 13 28A.150.100. The enrollment of any district shall be the annual average number of full-time equivalent students and part-time students 14 as provided in RCW 28A.150.350, enrolled on the first school day of 15 each month and shall exclude full_time equivalent students with 16 disabilities recognized for the purposes of allocation of state funds 17 for programs under RCW 28A.155.010 through 28A.155.100. The definition 18 of full_time equivalent student shall be determined by rules of the 19 superintendent of public instruction: PROVIDED, That the definition 20 21 shall be included as part of the superintendent's biennial budget 22 PROVIDED, FURTHER, That any revision of the present definition shall not take effect until approved by the house 23 24 appropriations committee and the senate ways and means committee: PROVIDED, FURTHER, That the office of financial management shall make 25 26 a monthly review of the superintendent's reported full-time equivalent 27 students in the common schools in conjunction with RCW 43.62.050.
 - (3)(a) Certificated instructional staff shall include those persons employed by a school district who are nonsupervisory employees within the meaning of RCW 41.59.020(8): PROVIDED, That in exceptional cases, people of unusual competence but without certification may teach students so long as a certificated person exercises general supervision: PROVIDED, FURTHER, That the hiring of such classified people shall not occur during a labor dispute and such classified people shall not be hired to replace certificated employees during a labor dispute.
 - (b) Certificated administrative staff shall include all those

- 1 persons who are chief executive officers, chief administrative
- 2 officers, confidential employees, supervisors, principals, or assistant
- 3 principals within the meaning of RCW 41.59.020(4).
