1 INTENT

NEW SECTION. Sec. 1. It is fundamental to our constitutional 2 3 system to have checks and balances. Washington state's Constitution 4 states, "All political power is inherent in the people, and governments derive their just powers from the consent of the governed, and are 5 established to protect and maintain individual rights." The people may, 6 7 through their representatives of the legislature or through the ballot, 8 function as another check in government. The legislature intends to return to the people their voice by structuring this act in such a way 9 10 as to preserve, one way or another, the individual's right to vote for the person and not the party. Therefore, the legislature intends to 11 reinstitute the blanket primary to honor the rights of the people to 12 13 vote for the person instead of the party.

Given that the judiciary has ruled in favor of the constitutional rights of the political parties, the legislature intends to check not only the judicial branch of the federal government but also check the political parties.

The legislature intends to give the political parties a choice to either choose to side with the people and voluntarily restrict their constitutional right or endure an alternative which follows a suggestion by the United States supreme court in administering a nonpartisan primary. A nonpartisan primary will also allow the people to vote for the person instead of the party.

The legislature intends to restrict standing to challenge the constitutionality of this act to a state chair of the different political parties in Washington state. This will ensure any court filing would constitute an official act of that state party.

- (4) "Sample ballot" means a printed facsimile of all the issues and offices on the ballot in a jurisdiction and is intended to give voters notice of the issues, offices, and candidates that are to be voted on at a particular primary, general election, or special election;
- (5) "Provisional ballot" means a ballot issued at the polling place on election day by the precinct election board to a voter who would otherwise be denied an opportunity to vote a regular ballot, for any reason authorized by the Help America Vote Act, including but not limited to the following:
 - (a) The voter's name does not appear in the poll book;
- (b) There is an indication in the poll book that the voter has requested an absentee ballot, but the voter wishes to vote at the polling place;
- (c) There is a question on the part of the voter concerning the issues or candidates on which the voter is qualified to vote;
 - (d) Any other reason allowed by law(($\dot{\tau}$
- (6) "Party ballot" means a primary election ballot specific to a particular major political party that lists all partisan offices to be voted on at that primary, and the candidates for those offices who affiliate with that same major political party;
 - (7) "Nonpartisan ballot" means a primary election ballot that lists

No record may be created or maintained by a state or local governmental agency or a political organization that identifies a voter with the information marked on the voter's ballot((, including the choice that a voter makes on a partisan primary ballot regarding political party affiliation)).

The county auditor shall send each absentee voter a ballot, a security envelope in which to seal the ballot after voting, a larger envelope in which to return the security envelope, and instructions on how to mark the ballot and how to return it to the county auditor. A summary of the applicable penalty provisions of this chapter must be printed on the return envelope immediately adjacent to the space for the voter's signature. signature of the voter on the return envelope must affirm and attest to the statements regarding the qualifications of that voter and to the

validity of the ballot. The return envelope must also have a secrecy flap that the voter may seal that will cover the voter's signature and optional telephone number. For out-of-state voters, overseas voters, and service voters, the signed declaration on the return envelope constitutes the equivalent of a voter registration for the election or primary for which the ballot has been issued. The voter must be instructed to either return the ballot to the county auditor by whom it was issued or attach sufficient first class postage, if applicable, and mail the ballot to the appropriate county auditor no later than the day of the election or primary for which the ballot was issued.

If the county auditor chooses to forward absentee ballots, he or she must include with the ballot a clear explanation of the qualifications necessary to vote in that election and must also advise a voter with questions about his or her eligibility to contact the county auditor. This explanation may be provided on the ballot envelope, on an enclosed insert, or printed directly on the ballot itself. If the information is not included, the envelope must clearly indicate that the ballot is not to be forwarded and that return postage is guaranteed.

Sec. 5. RCW 29A.44.201 and 2004 c 271 s 136 are each amended to 21 read as follows:

A voter desiring to vote shall give his or her name to the precinct election officer who has the precinct list of registered voters. An application for a recount of the votes cast for an office or on a ballot measure must be filed with the officer with whom filings are made for the jurisdiction.

An application for a recount must specify whether the recount will be done manually or by the vote tally system. A recount done by the vote tally system must use programming that recounts and reports only the office or ballot measure in question. The county shall also provide for a test of the logic and accuracy of that program.

An application for a recount must be filed within three business days after the county canvassing board or secretary of state has declared the official results of the primary or election for the office or issue for which the recount is requested.

This chapter applies to the recounting of votes cast by paper ballots and to the recounting of votes recorded on ballots counted by a vote tally system.

Sec. 64. RCW 29A.64.030 and 2005 c 243 s 20 are each amended to 24 read as follows:

An application for a recount shall state the office for which a recount is requested and whether the request is for all or only a portion of the votes cast in that jurisdiction of that office. The person filing an application for a manual recount shall, at the same time, deposit with the county canvassing board or secretary of state, in cash or by certified check, a sum equal to twenty-five cents for each ballot cast in the jurisdiction or portion of the jurisdiction for which the recount is requested as security for the payment of any costs of conducting the recount. If the application is for a machine recount, the deposit must be equal to fifteen cents for each ballot. These charges shall be determined by the county canvassing board or boards under RCW 29A.64.081.

The county canvassing board shall determine the date, time, and 1 2 place or places at which the recount will be conducted. Not less than two days before the date of the recount, the county auditor shall mail 3 a notice of the time and place of the recount to the applicant ((or 4 5 affected parties)) and, if the recount involves an office, to any person for whom votes were cast for that office. The county auditor 6 7 shall also notify the ((affected parties)) applicant and other persons by either telephone, fax, e-mail, or other electronic means at the time 8 9 of mailing. At least three attempts must be made over a two-day period to notify the ((affected parties)) applicant and other persons or until 10 the ((affected parties)) applicant and other persons have received the 11 notification. Each attempt to notify ((affected parties)) the 12 applicant and other persons must request a return response indicating 13 that the notice has been received. Each person entitled to receive 14 notice of the recount may attend, witness the recount, and be 15 16 accompanied by counsel.

Proceedings of the canvassing board are public under chapter 42.30 RCW. Subject to reasonable and equitable guidelines adopted by the canvassing board, all interested persons may attend and witness a recount.

The county legislative authority in each county shall, at its next regular or special meeting after being appraised of any vacancy in any county, township, precinct, or road district office of the county, fill the vacancy by the appointment of some person qualified to hold such office, and the officers thus appointed shall hold office until the next general election, and until their successors are elected and qualified.

If a vacancy occurs in a partisan county office after the general election in a year that the position appears on the ballot and before the start of the next term, the term of the successor who is of the same party as the incumbent may commence once he or she has qualified as defined in RCW ((29.01.135)) 29A.04.133 and shall continue through the term for which he or she was elected.
