- 1 AN ACT Relating to the taxation of beekeepers; adding new sections
- 2 to chapter 82.04 RCW; adding a new section to chapter 82.08 RCW; adding
- 3 a new section to chapter 82.12 RCW; and providing an effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.04 RCW to read as follows:
- 7 This chapter does not apply to amounts derived from the wholesale
- 8 sale of bee products by a person who owns or keeps forty-five or more
- 9 bee colonies used for pollination and is registered under RCW
- 10 15.60.021. For the purposes of this section, "bee products" means
- 11 queen bees, packaged bees, honey, pollen, bee's wax, propolis, or other
- 12 substances obtained from honey bees. Bee products do not include
- 13 manufactured substances or articles.
- 14 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 82.04 RCW
- 15 to read as follows:
- 16 This chapter does not apply to amounts received by any apiarist
- 17 registered under RCW 15.60.021 from providing bee pollination services

- 6 The tax levied by RCW 82.08.020 does not apply to the sale of
- 7 pollinating bees to an apiarist registered under RCW 15.60.021 if the
- 8 apiarist owns or keeps forty-five or more bee colonies used for
- 9 pollination.
- 10 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 82.12 RCW
- 11 to read as follows:
- 12 The provisions of this chapter do not apply in respect to the use
- of pollinating bees by an apiarist registered under RCW 15.60.021 if
- 14 the apiarist owns or keeps forty-five or more bee colonies used for
- 15 pollination.
- 16 <u>NEW SECTION.</u> **Sec. 5.** This act takes effect July 1, 2008.
