- 1 AN ACT Relating to the taxation of honey beekeepers; amending RCW
- 2 82.04.330, 82.08.865, and 82.12.865; adding a new section to chapter

- 6 **Sec. 1.** RCW 82.04.330 and 2001 c 118 s 3 are each amended to read 7 as follows:
- 8 <u>(1)(a)</u> This chapter shall not apply to any farmer ((that)) who:
- 9 <u>(i) S</u>ells any agricultural product at wholesale<u>;</u> or ((to any farmer 10 who))
- 11 <u>(ii) G</u>rows, raises, or produces agricultural products owned by others, such as custom feed operations.
- 13 <u>(b)</u> This <u>chapter shall not apply to amounts derived from the</u>
- 14 wholesale sale of honey bee products by an eligible apiarist, as
- defined in RCW 82.08.865, who owns or keeps bee colonies and who does
- 16 not qualify for an exemption under (a) of this subsection in respect to

This exemption applies to a 12 fuel blend if all of the component fuels of the blend would otherwise be exempt under this subsection if the component fuels were sold as 13 separate products. This exemption is available only if the buyer 14 15 provides the seller with an exemption certificate in a form and manner 16 prescribed by the department. Fuel used for space or water heating for 17 human habitation is not exempt under this section.

This exemption applies to a fuel blend if all of the component fuels of the blend would otherwise be exempt under this subsection if the component fuels were acquired as separate products. Fuel used for space or water heating for human habitation is not exempt under this section)) use of the following fuels by a farm fuel user for agricultural purposes:
