- AN ACT Relating to allowing voter registration up to and on 1 2 election day; amending RCW 29A.08.145 and 29A.08.820; reenacting and 3 amending RCW 29A.04.611; and adding a new section to chapter 29A.08

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- Sec. 1. 6 RCW 29A.08.145 and 2006 c 97 s 2 are each amended to read 7 as follows:
- (1) This section establishes a special procedure which an elector not registered in the state may use to register to vote during the 10 period beginning after the closing of registration for voting at the polls under RCW 29A.08.140 and ending on the fifteenth day before a 11 12 primary, special election, or general election or, for elections held after August 1, 2009, ending on the day of a primary, special election, 13 or general election. 14
- 15 (2) A qualified elector in the state may register to vote in person in the office of the county auditor of the county in which the 16 applicant resides, or at a voter registration location specifically 17 designated for this purpose by the county auditor or secretary of 18 19 state, and apply for an absentee ballot for that primary or election.

- NEW SECTION. **Sec. 2.** A new section is added to chapter 29A.08 RCW to read as follows:
- 9 If a voter registration application submitted pursuant to RCW
- 29A.08.145 is not complete under RCW 29A.08.110, or if the information
- 11 on the voter registration application cannot be matched by the
- 12 secretary of state pursuant to RCW 29A.08.107, and the deficiency or
- 13 discrepancy has not been resolved prior to certification of the
- 14 election, the ballot submitted by the applicant shall not be counted.
- 15 **Sec. 3.** RCW 29A.08.820 and 2006 c 320 s 5 are each amended to read 16 as follows:
  - (1) Except for subsection (4) of this section, challenges initiated by a registered voter against a voter who registered to vote less than sixty days before the election, or who changed residence less than sixty days before the election without transferring his or her registration, must be filed not later than ten days before any primary or election, general or special, or within ten days of the voter being added to the voter registration data base, whichever is later, at the office of the appropriate county auditor. Challenges initiated by a registered voter against any other voter must be filed not later than forty-five days before the election. Challenges initiated by the office of the county prosecuting attorney must be filed in the same manner as challenges initiated by a registered voter.
    - (2)(a) If the challenge is filed within forty-five days before an election at which the challenged voter is eligible to vote, a notation of the challenge must be made immediately in the poll book or voter registration system, and the county canvassing board presides over the hearing.
- 34 (b) If the challenge is filed before the challenged voter's ballot 35 is received, the ballot must be treated as a challenged ballot. A

challenged ballot received at a polling place must be placed in a sealed envelope separate from other voted ballots.

3 (c) If the challenge is filed after the challenged voter's ballot 4 is received, the challenge cannot affect the current election.

- (3) If the challenge is filed at least forty-five days before an election at which the challenged voter is eligible to vote, the county auditor presides over the hearing.
- 8 (4) Challenges initiated by a registered voter against a voter who
  9 registered to vote on or less than fourteen days before the day of the
  10 election must be filed at a time as prescribed in rules adopted by the
  11 secretary of state pursuant to RCW 29A.04.611.
- 12 **Sec. 4.** RCW 29A.04.611 and 2006 c 207 s 1 and 2006 c 206 s 2 are 13 each reenacted and amended to read as follows:

The secretary of state as chief election officer shall make reasonable rules in accordance with chapter 34.05 RCW not inconsistent with the federal and state election laws to effectuate any provision of this title and to facilitate the execution of its provisions in an orderly, timely, and uniform manner relating to any federal, state, county, city, town, and district elections. To that end the secretary shall assist local election officers by devising uniform forms and procedures.

In addition to the rule-making authority granted otherwise by this section, the secretary of state shall make rules governing the following provisions:

- (1) The maintenance of voter registration records;
- 26 (2) The preparation, maintenance, distribution, review, and filing 27 of precinct maps;
  - (3) Standards for the design, layout, and production of ballots;
- 29 (4) The examination and testing of voting systems for 30 certification;
- 31 (5) The source and scope of independent evaluations of voting 32 systems that may be relied upon in certifying voting systems for use in 33 this state;
- 34 (6) Standards and procedures for the acceptance testing of voting systems by counties;
- 36 (7) Standards and procedures for testing the programming of vote 37 tallying software for specific primaries and elections;

1 (8) Standards and procedures for the preparation and use of each 2 type of certified voting system including procedures for the operation 3 of counting centers where vote tallying systems are used;

- (9) Standards and procedures to ensure the accurate tabulation and canvassing of ballots;
- (10) Consistency among the counties of the state in the preparation of ballots, the operation of vote tallying systems, and the canvassing of primaries and elections;
- 9 (11) Procedures to ensure the secrecy of a voter's ballot when a 10 small number of ballots are counted at the polls or at a counting 11 center;
  - (12) The use of substitute devices or means of voting when a voting device at the polling place is found to be defective, the counting of votes cast on the defective device, the counting of votes cast on the substitute device, and the documentation that must be submitted to the county auditor regarding such circumstances;
- 17 (13) Procedures for the transportation of sealed containers of voted ballots or sealed voting devices;
- 19 (14) The acceptance and filing of documents via electronic 20 facsimile;
  - (15) Voter registration applications and records;
- 22 (16) The use of voter registration information in the conduct of elections;
  - (17) The coordination, delivery, and processing of voter registration records accepted by driver licensing agents or the department of licensing;
  - (18) The coordination, delivery, and processing of voter registration records accepted by agencies designated by the governor to provide voter registration services;
- 30 (19) Procedures to receive and distribute voter registration 31 applications by mail;
- 32 (20) Procedures for a voter to change his or her voter registration 33 address within a county by telephone;
- 34 (21) Procedures for a voter to change the name under which he or 35 she is registered to vote;
- 36 (22) Procedures for canceling dual voter registration records and 37 for maintaining records of persons whose voter registrations have been 38 canceled;

  - (51) Defining the interaction of electronic voter registration election management systems employed by each county auditor to maintain a local copy of each county's portion of the official state list of registered voters;
