- 1 AN ACT Relating to the licensing of home inspectors; amending RCW
- 2 18.235.020 and 43.24.150; adding a new section to chapter 15.58 RCW;
- 3 adding a new section to chapter 18.85 RCW; adding a new chapter to
- 4 Title 18 RCW; creating a new section; and prescribing penalties.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** DEFINITIONS. The definitions in this
- 7 section apply throughout this chapter unless the context clearly
- 8 requires otherwise.
- 9 (1) "Board" means the home inspector advisory licensing board.
- 10 (2) "Department" means the department of licensing.
- 11 (3) "Director" means the director of the department of licensing.
- 12 (4) "Entity" or "entities" means educational groups or
- 13 organizations, national organizations or associations, or a national
- 14 test organization.
- 15 (5) "Home inspection" means a professional examination of the
- 16 current condition of a house.
- 17 (6) "Home inspector" means a person who carries out a noninvasive
- 18 examination of the condition of a home, often in connection with the

- sale of that home, using special training and education to carry out the inspection.
- 3 (7) "Report" means a written report prepared and issued after a 4 home inspection.
 - (8) "Wood destroying organism" means insects or fungi that consume, excavate, develop in, or otherwise modify the integrity of wood or wood products. "Wood destroying organism" includes but is not limited to carpenter ants, moisture ants, subterranean termites, dampwood termites, beetles in the family Anobiidae, and wood decay fungi, known as wood rot.
- NEW SECTION. Sec. 2. LICENSURE REQUIRED. (1) Beginning September 1, 2009, a person shall not engage in or conduct, or advertise or hold himself or herself out as engaging in or conducting, the business of or acting in the capacity of a home inspector within this state without first obtaining a license as provided in this chapter.
 - (2) Any person performing the duties of a home inspector on the effective date of this act has until July 1, 2010, to meet the licensing requirements of this chapter. However, if a person performing the duties of a home inspector on the effective date of this act has proof that he or she has worked as a home inspector for at least two years and has conducted at least one hundred home inspections, he or she may apply to the board before September 1, 2009, for licensure without meeting the instruction and training requirements of this chapter.
- 25 (3) The director may begin issuing licenses under this section 26 beginning on July 1, 2009.

NEW SECTION. Sec. 3. DUTIES OF A LICENSED HOME INSPECTOR. A 27 person licensed under this chapter is responsible for performing a 28 29 visual and noninvasive inspection of the following readily accessible 30 systems and components of a home and reporting on the general condition of those systems and components at the time of the inspection in his or 31 her written report: The roof, foundation, exterior, heating system, 32 air-conditioning system, structure, plumbing and electrical systems, 33 34 and other aspects of the home as may be identified by the board. 35 inspection must include looking for certain fire and safety hazards as 36 defined by the board. The standards of practice to be developed by the

- 1 board will be used as the minimum standards for an inspection. The
- 2 duties of the home inspector with regard to wood destroying organisms
- 3 are provided in section 19 of this act.
- 4 <u>NEW SECTION.</u> **Sec. 4.** HOME INSPECTOR ADVISORY LICENSING BOARD.
- 5 (1) The state home inspector advisory licensing board is created. The
- 6 board consists of seven members appointed by the governor, who shall
- 7 advise the director concerning the administration of this chapter. Of
- 8 the appointments to this board, six must be actively engaged as home
- 9 inspectors immediately prior to their appointment to the board, and one
- 10 must be currently teaching in a home inspector education program.
- 11 Insofar as possible, the composition of the appointed home inspector
- 12 members of the board must be generally representative of the geographic
- 13 distribution of home inspectors licensed under this chapter. No more
- 14 than two board members may be members of a particular national home
- 15 inspector association or organization.

- 16 (2) A home inspector must have the following qualifications to be 17 appointed to the board:
- 18 (a) Actively engaged as a home inspector in the state of Washington 19 for five years;
- 20 (b) Licensed as a home inspector under this chapter, except for 21 initial appointments; and
- 22 (c) Performed a minimum of five hundred home inspections in the 23 state of Washington.
 - (3) Members of the board are appointed for three-year terms. Terms must be staggered so that not more than two appointments are scheduled to be made in any calendar year. Members hold office until the expiration of the terms for which they were appointed. The governor may remove a board member for just cause. The governor may appoint a new member to fill a vacancy on the board for the remainder of the unexpired term. All board members are limited to two consecutive terms.
- 32 (4) Each board member is entitled to compensation for each day 33 spent conducting official business and to reimbursement for travel 34 expenses in accordance with RCW 43.03.240, 43.03.050, and 43.03.060.
- 35 <u>NEW SECTION.</u> **Sec. 5.** DIRECTOR'S AUTHORITY. The director has the following authority in administering this chapter:

- 1 (1) To adopt, amend, and rescind rules approved by the board as deemed necessary to carry out this chapter;
- 3 (2) To administer licensing examinations approved by the board and 4 to adopt or recognize examinations prepared by other entities as 5 approved by the board;
- 6 (3) To adopt standards of professional conduct, practice, and 7 ethics as approved by the board; and
- 8 (4) To adopt fees as provided in RCW 43.24.086.
- 9 <u>NEW SECTION.</u> **Sec. 6.** BOARD'S AUTHORITY. The board has the following authority in administering this chapter:
- 11 (1) To establish rules, including board organization and assignment 12 of terms, and meeting frequency and timing, for adoption by the 13 director;
- 14 (2) To establish the minimum qualifications for licensing 15 applicants as provided in this chapter;
- 16 (3) To approve the method of administration of examinations 17 required by this chapter or by rule as established by the director;
- 18 (4) To approve the content of or recognition of examinations 19 prepared by other entities for adoption by the director;
- 20 (5) To set the time and place of examinations with the approval of the director; and
- (6) To establish and review standards of professional conduct, practice, and ethics for adoption by the director. These standards must address what constitutes certain fire and safety hazards as used in section 3 of this act.
- NEW SECTION. Sec. 7. QUALIFICATIONS FOR LICENSURE. In order to become licensed as a home inspector, an applicant must submit the following to the department:
 - (1) An application on a form developed by the department;
- 30 (2) Proof of a minimum of one hundred twenty hours of classroom 31 instruction approved by the board;
- 32 (3) Proof of up to forty hours of field training supervised by a licensed home inspector;
- 34 (4) Evidence of successful passage of the written exam as required 35 in section 8 of this act; and
- 36 (5) The fee in the amount set by the department.

- NEW SECTION. Sec. 8. WRITTEN EXAMS. Applicants for licensure must pass an exam that is psychometrically valid, reliable, and legally defensible by the state. The exam is to be developed, maintained, and administered by the department. The board shall recommend to the director whether to use an exam that is prepared by a national entity. If an exam prepared by a national entity is used, a section specific to Washington shall be developed by the director and included as part of
- 9 <u>NEW SECTION.</u> **Sec. 9.** LICENSE LENGTH AND RENEWAL. Licenses are 10 issued for a term of two years and expire on the applicant's second 11 birthday following issuance of the license.

the entire exam.

- NEW SECTION. Sec. 10. ADVERTISING. The term "licensed home inspector" and the license number of the inspector must appear on all advertising, correspondence, and documents incidental to a home inspection. However, businesses and organizations that conduct national or interstate general marketing and advertising campaigns may omit the license number of the inspector in advertising so long as it is included on all documents incident to a home inspection.
- NEW SECTION. Sec. 11. CONTINUING EDUCATION REQUIREMENTS. (1) As a condition of renewing a license under this chapter, a licensed home inspector shall present satisfactory evidence to the board of having completed the continuing education requirements provided for in this section.
- 24 (2) Each applicant for license renewal shall complete at least 25 twenty-four hours of instruction in courses approved by the board every 26 two years.
- NEW SECTION. Sec. 12. WRITTEN REPORTS. (1) A licensed home inspector shall provide a written report of the home inspection to each person for whom the inspector performs a home inspection within a time period set by the board in rule. The issues to be addressed in the report shall be set by the board in rule.
- 32 (2) A licensed home inspector, or other licensed home inspectors or 33 employees who work for the same company or for any company in which the 34 home inspector has a financial interest, shall not, from the time of

- 1 the inspection until one year from the date of the report, perform any
- 2 work other than home inspection-related consultation on the home upon
- 3 which he or she has performed a home inspection.
- NEW SECTION. Sec. 13. SUSPENSION OF LICENSE. (1) The director 4 shall immediately suspend the license of a person who has been 5 certified pursuant to RCW 74.20A.320 by the department of social and 6 7 health services as a person who is not in compliance with a child support order. If the person has continued to meet all other 8 requirements for a license under this chapter during the suspension, 9 reissuance of the license is automatic upon the board's receipt of a 10 release issued by the department of social and health services stating 11 12 that the licensee is in compliance with the child support order. procedure in RCW 74.20A.320 is the exclusive administrative remedy for 13 contesting the establishment of noncompliance with a child support 14 15 order, and suspension of a license under this subsection, and satisfies 16 the requirements of RCW 34.05.422.
 - (2) The director, with the assistance of the board, shall establish by rule under what circumstances a home inspector license may be suspended or revoked. These circumstances shall be based upon accepted industry standards and the board's cumulative experience.
 - (3) Any person aggrieved by a decision of the director under this section may appeal the decision as provided in chapter 34.05 RCW. The adjudicative proceeding shall be conducted under chapter 34.05 RCW by an administrative law judge appointed pursuant to RCW 34.12.030.
- NEW SECTION. Sec. 14. CIVIL INFRACTIONS. The department has the authority to issue civil infractions under chapter 7.80 RCW in the following instances:
- 28 (1) Conducting or offering to conduct a home inspection without 29 being licensed in accordance with this chapter;
 - (2) Presenting or attempting to use as his or her own the home inspector license of another;
- 32 (3) Giving any false or forged evidence of any kind to the director 33 or his or her authorized representative in obtaining a license;
 - (4) Falsely impersonating any other licensee; or
- 35 (5) Attempting to use an expired or revoked license.

- All fines and penalties collected or assessed by a court because of a violation of this section must be remitted to the department to be deposited into the business and professions account created in RCW
- 4 43.24.150.
- 5 <u>NEW SECTION.</u> **Sec. 15.** The uniform regulation of business and
- 6 professions act, chapter 18.235 RCW, governs unlicensed practice, the
- 7 issuance and denial of licenses, and the discipline of licensees under
- 8 this chapter.
- NEW SECTION. Sec. 16. RELIEF BY INJUNCTION. 9 The director is authorized to apply for relief by injunction without bond, to restrain 10 11 a person from the commission of any act that is prohibited under section 14 of this act. In such a proceeding, it is not necessary to 12 allege or prove either that an adequate remedy at law does not exist, 13 14 or that substantial or irreparable damage would result from continued 15 violation. The director, individuals acting on the director's behalf, and members of the board are immune from suit in any action, civil or 16 criminal, based on disciplinary proceedings or other official acts 17 performed in the course of their duties in the administration and 18
- NEW SECTION. Sec. 17. EXEMPTION FROM LICENSING. The following persons are exempt from the licensing requirements of this chapter when acting within the scope of their license or profession:
- 23 (1) Engineers;

- 7 to rot or conducive conditions for wood destroying organisms and shall
- 8 refer the identification of or damage by wood destroying insects to a

- 10 <u>NEW SECTION.</u> **Sec. 20.** Captions used in this chapter are not any
- 11 part of the law.

This chapter also governs 33 any investigation, hearing, or proceeding relating to denial of 34 licensure or issuance of a license conditioned on the applicant's 35 compliance with an order entered under RCW 18.235.110 by the 36 37 disciplinary authority.

- Moneys in the account may be spent only after appropriation. Expenditures from the account may be used only for expenses incurred in carrying out these business and professions licensing activities of the department. Any residue in the account shall be accumulated and shall not revert to the general fund at the end of the biennium.
- 28 (2) The director shall biennially prepare a budget request based on 29 the anticipated costs of administering the business and professions 30 licensing activities listed in subsection (1) of this section, which 31 shall include the estimated income from these business and professions 32 fees.
- NEW SECTION. Sec. 23. A new section is added to chapter 15.58 RCW to read as follows:
- A person licensed as a home inspector under chapter 18.--- RCW (the new chapter created in section 25 of this act) is exempt from licensing

- 1 as a structural pest inspector except when reporting on the
- 2 identification of or damage by wood destroying insects.
- 3 <u>NEW SECTION.</u> **Sec. 24.** A new section is added to chapter 18.85 RCW 4 to read as follows:
- 5 The commission must establish procedures, to be adopted in rule by
- 6 the director, for real estate agents to follow when providing potential
- 7 home buyers with home inspector referrals.
- 8 <u>NEW SECTION.</u> **Sec. 25.** Sections 1 through 20 of this act
- 9 constitute a new chapter in Title 18 RCW.
- 10 <u>NEW SECTION.</u> **Sec. 26.** If specific funding for the purposes of
- 11 this act, referencing this act by bill or chapter number, is not
- 12 provided by June 30, 2008, in the omnibus appropriations act, this act
- is null and void.
