1 On page 3, line 25, after "(2)" insert "The department of commerce 2 shall develop performance measures and targets. The performance 3 measures and targets shall be tracked annually and a report shall be 4 submitted annually to the legislature and the governor.

5 (3)(a) All K-12 public school districts, public higher education 6 institutions, and other state and locally owned public facilities, and 7 public facilities owned by subdivisions of the state that receive 8 grants in the amount of five hundred thousand dollars or more must 9 apply to the Washington state quality award or similar organization 10 for an organization-wide performance assessment within two years and a 11 full assessment every two years for three years after receiving the 12 grant thereafter, in order to improve the efficiency and effectiveness 13 of public entity. Each K-12 public school district, public higher 14 education institution, other state and local government, and 15 subdivision of the state shall commit and plan to become a high 16 performance, high integrity organization and reach a score of sixty 17 percent in ten years. The performance assessment in this section must 18 use the same criteria as the performance assessment program created by 19 congress in 1987 which is managed and updated by the national 20 institute of standards and technology and assisted by the American 21 society for quality and with annual awards presented by the United 22 States president or commerce secretary to enhance United States 23 competitiveness and quality that includes identical criteria in the 24 following categories for examination: leadership; strategic planning; 25 customer focus; measurement, analysis and knowledge management; 26 workforce focus; process management; and results. Various 27 accreditations are not equivalent to this quality assessment.

Washington state quality award application, 1 (b) assessment 2 feedback reports, and corrective action plans shall: (i) Be posted on 3 the websites of individual K-12 public school district, public higher 4 education institution, other state and local government, and 5 subdivision of the state, and on the Washington state general 6 management accountability and performance website to insure public 7 accountability, sharing of best practices among public agencies and 8 adequate performance management improvement; (ii) be electronically 9 sent to the Washington state auditor's office to assist in its 10 analysis of departmental performance data, performance measures, and 11 self-assessment systems; and (iii) be used for identification of best 12 practices for the chapter 43.09 RCW performance audits. Public 13 agencies may use grant funding for application fee and quality 14 training. 15 (c) State agencies shall monitor implementation and consider 16 assessment results as criteria in grant funding. 17 (4)" 18 Renumber the sections consecutively and correct any 19 internal 20 references accordingly. 21 On page 7, line 16, strike "\$858,500,000" and insert "858,425,000" 22 23 On page 7, after line 16, insert the following: 24 "NEW SECTION. EFFECT: Requires the Department of Commerce to develop performance measures and targets to be tracked annually and submit a report annually to the Legislature and the Governor.

Requires K-12 public school districts, public higher education institutions, and other state and locally owned public facilities, and public facilities owned by subdivisions of the state that receive grants in the amount of \$500,000 or more to apply to the Washington State Quality Award or similar organization for an organization-wide performance assessment within two years and a full assessment every three years thereafter.

Appropriates \$75,000 from the Washington Works Account, created in the bill, to the Office of Financial Management for the Washington State Quality Award, including training.
