director of financial 4 (1)The management shall prescribe 5 reasonable allowances to cover reasonable and necessary subsistence 6 and lodging expenses for elective and appointive officials and state 7 employees while engaged on official business away from their 8 designated posts of duty. The director of financial management may 9 prescribe and regulate the allowances provided in lieu of subsistence 10 and lodging expenses and may prescribe the conditions under which 11 reimbursement for subsistence and lodging may be allowed. The 12 schedule of allowances adopted by the office of financial management 13 may include special allowances for foreign travel and other travel 14 involving higher than usual costs for subsistence and lodging. The 15 allowances established by the director shall not exceed the rates set 16 by the federal government for federal employees. However, during the 17 2003-05 fiscal biennium, the allowances for any county that is part of 18 a metropolitan statistical area, the largest city of which is in 19 another state, shall equal the allowances prescribed for that larger 20 city.

(2) Those persons appointed to serve without compensation on any 22 state board, commission, or committee, if entitled to payment of 23 travel expenses, shall be paid pursuant to special per diem rates 24 prescribed in accordance with subsection (1) of this section by the 25 office of financial management.

26 (3) The director of financial management may prescribe reasonable 27 allowances to cover reasonable expenses for meals, coffee, and light 1 refreshment served to elective and appointive officials and state 2 employees regardless of travel status at a meeting where: (a) The 3 purpose of the meeting is to conduct official state business or to 4 provide formal training to state employees or state officials; (b) the 5 meals, coffee, or light refreshment are an integral part of the 6 meeting or training session; (c) the meeting or training session takes 7 place away from the employee's or official's regular workplace; and 8 (d) the agency head or authorized designee approves payments in 9 advance for the meals, coffee, or light refreshment. In order to 10 prevent abuse, the director may regulate such allowances and prescribe 11 additional conditions for claiming the allowances.

12 (4) Upon approval of the agency head or authorized designee, an 13 agency may serve coffee or light refreshments at a meeting where: (a) 14 The purpose of the meeting is to conduct state business or to provide 15 formal training that benefits the state; and (b) the coffee or light 16 refreshment is an integral part of the meeting or training session. 17 The director of financial management shall adopt requirements 18 necessary to prohibit abuse of the authority authorized in this 19 subsection.

20 (5) The schedule of allowances prescribed by the director under 21 the terms of this section and any subsequent increases in any maximum 22 allowance or special allowances for areas of higher than usual costs 23 shall be reported to the ways and means committees of the house of 24 representatives and the senate at each regular session of the 25 legislature.

26 (6) Beginning July 1, 2010, through June 30, 2011, no person 27 designated as a member of a class one through class three or class 28 five board, commission, council, committee, or similar group may 29 receive an allowance for subsistence, lodging, or travel expenses if 30 the allowance cost is funded by the state general fund. Exceptions 31 may be granted under section 605, chapter 3, Laws of 2010.

3 (1) Any part-time board, commission, council, committee, or other 4 similar group which is established by the executive, legislative, or 5 judicial branch to participate in state government and which functions 6 primarily in an advisory, coordinating, or planning capacity shall be 7 identified as a class one group.

8 (2) Absent any other provision of law to the contrary, no money 9 beyond the customary reimbursement or allowance for expenses may be 10 paid by or through the state to members of class one groups for 11 attendance at meetings of such groups.

(3) Beginning July 1, 2010, through June 30, 2011, no person designated as a member of a class one board, commission, council, committee, or similar group may receive an allowance for subsistence, lodging, or travel expenses if the allowance cost is funded by the state general fund. Exceptions may be granted under section 605, chapter 3, Laws of 2010. Class one groups, when feasible, shall use an alternative means of conducting a meeting that does not require travel while still maximizing member and public participation and may use a meeting format that requires members to be physically present at one location only when necessary or required by law. Meetings that require a member's physical presence at one location must be held in state facilities whenever possible, and meetings conducted using private facilities must be approved by the director of the office of financial management.

(a) Has rule-making authority, performs quasi-judicial functions,
or has responsibility for the administration or policy direction of a
state agency or program;

(b) Has duties that are deemed by the legislature to be of overriding sensitivity and importance to the public welfare and the dependence of state government; and

(c) Requires service from its members representing a significant demand on their time that is normally in excess of one hundred hours of meeting time per year.

(2) Each member of a class four group is eligible to receive compensation in an amount not to exceed one hundred dollars for each day during which the member attends an official meeting of the group reforms statutorily prescribed duties approved by the chairperson of the group. A person shall not receive compensation for a day of service under this section if the person (a) occupies a position, normally regarded as full-time in nature, in any agency of the federal 1 government, Washington state government, or Washington state local 2 government; and (b) receives any compensation from such government for 3 working that day.

4 (3) Compensation may be paid a member under this section only if 5 it is authorized under the law dealing in particular with the specific 6 group to which the member belongs or dealing in particular with the 7 members of that specific group.

(2) Except as otherwise provided in this section, each member of a class five group is eligible to receive compensation in an amount not to exceed two hundred fifty dollars for each day during which the member attends an official meeting of the group or performs statutorily prescribed duties approved by the chairperson of the group. A person shall not receive compensation for a day of service under this section if the person (a) occupies a position, normally regarded as full-time in nature, in any agency of the federal government, Washington state government, or Washington state local

(4) Beginning July 1, 2010, through June 30, 2011, no person 7 8 designated as a member of a class five board, commission, council, 9 committee, or similar group may receive an allowance for 10 subsistence, lodging, or travel expenses if the allowance cost is 11 funded by the state general fund. Exceptions may be granted under 12 section 605, chapter 3, Laws of 2010. Class five groups, when 13 feasible, shall use an alternative means of conducting a meeting 14 that does not require travel while still maximizing member and 15 public participation and may use a meeting format that requires 16 members to be physically present at one location only when necessary 17 or required by law. (1) Eliminates lodging, subsistence, and travel EFFECT: allowances for members of class one through class three and class five boards, commissions, councils, committees or similar groups whose allowance costs are funded by the State General Fund, beginning July 1, 2010, through June 30, 2011, and provides for exceptions; (2) Directs groups in classes one through five using general fund state money to (a) use alternate methods of conducting meetings that do not require travel and lodging expenses, (b) reduce the number of meetings where a members physical presence is required, and (c) use state facilities for meeting whenever possible, and get approval from the Office of Financial Management (OFM) for meetings conducted in private facilities; (3) Encourages class one through three and class five groups that are funded by sources other than the State General Fund to reduce travel, lodging, and other costs associated with conducting business; and (4) Directs OFM to report to the appropriate fiscal and policy committees of the Legislature on actual costs to operate each board, committee, commission, or council and the funding source for payment of costs.
