5 (1) Except as provided in this section, the juvenile courts in this 6 state shall have exclusive original jurisdiction over all proceedings:

7 (a) Under the interstate compact on placement of children as
8 provided in chapter 26.34 RCW;

9 (b) Relating to children alleged or found to be dependent as 10 provided in chapter 26.44 RCW and in RCW 13.34.030 through 11 ((<del>13.34.170</del>)) <u>13.34.161</u>;

12 (c) Relating to the termination of a parent and child relationship13 as provided in RCW 13.34.180 through 13.34.210;

14 (d) To approve or disapprove out-of-home placement as provided in 15 RCW 13.32A.170;

16 (e) Relating to juveniles alleged or found to have committed 17 offenses, traffic or civil infractions, or violations as provided in 18 RCW 13.40.020 through 13.40.230, unless:

(i) The juvenile court transfers jurisdiction of a particularjuvenile to adult criminal court pursuant to RCW 13.40.110;

(ii) The statute of limitations applicable to adult prosecution forthe offense, traffic or civil infraction, or violation has expired;

23 (iii) The alleged offense or infraction is a traffic, fish, 24 boating, or game offense, or traffic or civil infraction committed by 25 a juvenile sixteen years of age or older and would, if committed by an adult, be tried or heard in a court of limited jurisdiction, in which 26 27 instance the appropriate court of limited jurisdiction shall have jurisdiction over the alleged offense or infraction, and no guardian ad 28 29 litem is required in any such proceeding due to the juvenile's age((+ PROVIDED, - That)). (iv) The alleged offense is a traffic or civil infraction, a violation of compulsory school attendance provisions under chapter 28A.225 RCW, or a misdemeanor, and a court of limited jurisdiction has assumed concurrent jurisdiction over those offenses as provided in RCW 13.04.0301; or

16 (v) The juvenile is sixteen or seventeen years old on the date the 17 alleged offense is committed and the alleged offense is:

(A) A serious violent offense as defined in RCW 9.94A.030;

(B) A violent offense as defined in RCW 9.94A.030 and the juvenile has a criminal history consisting of: (I) One or more prior serious violent offenses; (II) two or more prior violent offenses; or (III) three or more of any combination of the following offenses: Any class A felony, any class B felony, vehicular assault, or manslaughter in the second degree, all of which must have been committed after the juvenile's thirteenth birthday and prosecuted separately;

(C) Robbery in the first degree, rape of a child in the firstdegree, or drive-by shooting, committed on or after July 1, 1997;

(D) Burglary in the first degree committed on or after July 1,
 1997, and the juvenile has a criminal history consisting of one or more
 prior felony or misdemeanor offenses; or

31 (E) Any violent offense as defined in RCW 9.94A.030 committed on or 32 after July 1, 1997, and the juvenile is alleged to have been armed with 33 a firearm.

(I) In such a case the adult criminal court shall have exclusive
 original jurisdiction, except as provided in (e)(v)(E)(II) and (III) of
 this subsection.

(II) The juvenile court shall have exclusive jurisdiction over thedisposition of any remaining charges in any case in which the juvenile

is found not guilty in the adult criminal court of the charge or 1 charges for which he or she was transferred, or is convicted in the 2 adult criminal court of a lesser included offense that is not also an 3 offense listed in (e)(v) of this subsection. The juvenile court shall 4 5 enter an order extending juvenile court jurisdiction if the juvenile has turned eighteen years of age during the adult criminal court 6 7 proceedings pursuant to RCW 13.40.300. However, once the case is returned to juvenile court, the court may hold a decline hearing 8 pursuant to RCW 13.40.110 to determine whether to retain the case in 9 juvenile court for the purpose of disposition or return the case to 10 adult criminal court for sentencing. 11

12 (III) The prosecutor and respondent may agree to juvenile court 13 jurisdiction and waive application of exclusive adult criminal 14 jurisdiction in (e)(v)(A) through (E) of this subsection and remove the 15 proceeding back to juvenile court with the court's approval.

16 If the juvenile challenges the state's determination of the 17 juvenile's criminal history under (e)(v) of this subsection, the state 18 may establish the offender's criminal history by a preponderance of the 19 evidence. If the criminal history consists of adjudications entered 20 upon a plea of guilty, the state shall not bear a burden of 21 establishing the knowing and voluntariness of the plea;

13.40.080, including a proceeding in which the divertee has attained
eighteen years of age;

(h) Relating to court validation of a voluntary consent to an outof-home placement under chapter 13.34 RCW, by the parent or Indian custodian of an Indian child, except if the parent or Indian custodian and child are residents of or domiciled within the boundaries of a federally recognized Indian reservation over which the tribe exercises exclusive jurisdiction;

36 (j) Relating to judicial determinations and permanency planning 37 hearings involving developmentally disabled children who have been 1 placed in out-of-home care pursuant to a voluntary placement agreement 2 between the child's parent, guardian, or legal custodian and the 3 department of social and health services.

4 (2) The family court shall have concurrent original jurisdiction
5 with the juvenile court over all proceedings under this section if the
6 superior court judges of a county authorize concurrent jurisdiction as
7 provided in RCW 26.12.010.

8 (3) The juvenile court shall have concurrent original jurisdiction 9 with the family court over child custody proceedings under chapter 10 26.10 RCW as provided for in RCW 13.34.155.

(4) A juvenile subject to adult superior court jurisdiction under subsection (1)(e)(i) through (v) of this section, who is detained pending trial, may be detained in a detention facility as defined in RCW 13.40.020 pending sentencing or a dismissal.

For the purposes of this chapter:

(1) "Community-based rehabilitation" means one or more of the 18 following: Employment; attendance of information classes; literacy 19 20 classes; counseling, outpatient substance abuse treatment programs, outpatient mental health programs, anger management classes, education 21 22 or outpatient treatment programs to prevent animal cruelty, or other 23 services; or attendance at school or other educational programs appropriate for the juvenile as determined by the school district. 24 Placement in community-based rehabilitation programs is subject to 25 26 available funds;

27 (2) Community-based sanctions may include one or more of the 28 following:

(a) A fine, not to exceed five hundred dollars;

30 (b) Community restitution not to exceed one hundred fifty hours of 31 community restitution;

32 (3) "Community restitution" means compulsory service, without 33 compensation, performed for the benefit of the community by the 34 offender as punishment for committing an offense. Community 35 restitution may be performed through public or private organizations or 36 through work crews;

(4) "Community supervision" means an order of disposition by the 1 2 court of an adjudicated youth not committed to the department or an order granting a deferred disposition. A community supervision order 3 for a single offense may be for a period of up to two years for a sex 4 offense as defined by RCW 9.94A.030 and up to one year for other 5 offenses. As a mandatory condition of any term of community 6 7 supervision, the court shall order the juvenile to refrain from committing new offenses. As a mandatory condition of community 8 supervision, the court shall order the juvenile to comply with the 9 10 mandatory school attendance provisions of chapter 28A.225 RCW and to inform the school of the existence of this requirement. Community 11 12 supervision is an individualized program comprised of one or more of 13 the following:

14 (a) Community-based sanctions;

15 (b) Community-based rehabilitation;

16 (c) Monitoring and reporting requirements;

17 (d) Posting of a probation bond;

(5) "Confinement" means physical custody by the department of 18 social and health services in a facility operated by or pursuant to a 19 contract with the state, or physical custody in a detention facility 20 21 operated by or pursuant to a contract with any county. The county may contract with vendors to operate county detention 22 operate or The department may operate or contract to operate 23 facilities. 24 detention facilities for juveniles committed to the department. 25 Pretrial confinement or confinement of less than thirty-one days imposed as part of a disposition or modification order may be served 26 27 consecutively or intermittently, in the discretion of the court;

28 (6) "Court," when used without further qualification, means the 29 juvenile court judge(s) or commissioner(s);

30 (7) "Criminal history" includes all criminal complaints against the31 respondent for which, prior to the commission of a current offense:

(a) The allegations were found correct by a court. If a respondent
 is convicted of two or more charges arising out of the same course of
 conduct, only the highest charge from among these shall count as an
 offense for the purposes of this chapter; or

(b) The criminal complaint was diverted by a prosecutor pursuant to
 the provisions of this chapter on agreement of the respondent and after
 an advisement to the respondent that the criminal complaint would be

1 considered as part of the respondent's criminal history. A
2 successfully completed deferred adjudication that was entered before
3 July 1, 1998, or a deferred disposition shall not be considered part of
4 the respondent's criminal history;

5 (8) "Department" means the department of social and health 6 services;

7 (9) "Detention facility" means a county facility, paid for by the 8 county, for the physical confinement of a juvenile alleged to have 9 committed an offense or an adjudicated offender subject to a 10 disposition or modification order. "Detention facility" includes 11 county group homes, inpatient substance abuse programs, juvenile basic 12 training camps, and electronic monitoring;

13 (10) "Diversion unit" means any probation counselor who enters into 14 a diversion agreement with an alleged youthful offender, or any other person, community accountability board, youth court under the 15 supervision of the juvenile court, or other entity except a law 16 17 enforcement official or entity, with whom the juvenile court administrator has contracted to arrange and supervise such agreements 18 pursuant to RCW 13.40.080, or any person, community accountability 19 board, or other entity specially funded by the legislature to arrange 20 21 and supervise diversion agreements in accordance with the requirements this chapter. For purposes of this subsection, "community 22 of accountability board" means a board comprised of members of the local 23 24 community in which the juvenile offender resides. The superior court 25 shall appoint the members. The boards shall consist of at least three and not more than seven members. If possible, the board should include 26 27 a variety of representatives from the community, such as a law enforcement officer, teacher or school administrator, high school 28 student, parent, and business owner, and should represent the cultural 29 30 diversity of the local community;

(11) "Foster care" means temporary physical care in a foster family home or group care facility as defined in RCW 74.15.020 and licensed by the department, or other legally authorized care;

(12) "Institution" means a juvenile facility established pursuant
 to chapters 72.05 and 72.16 through 72.20 RCW;

36 (13) "Intensive supervision program" means a parole program that 37 requires intensive supervision and monitoring, offers an array of 1 individualized treatment and transitional services, and emphasizes 2 community involvement and support in order to reduce the likelihood a 3 juvenile offender will commit further offenses;

4 (14) "Juvenile," "youth," and "child" mean any individual who is
5 under the chronological age of eighteen years and who has not been
6 previously transferred to adult court pursuant to RCW 13.40.110, unless
7 the individual was convicted of a lesser charge or acquitted of the
8 charge for which he or she was previously transferred pursuant to RCW
9 13.40.110 or who is not otherwise under adult court jurisdiction;

10 (15) "Juvenile offender" means any juvenile who has been found by 11 the juvenile court to have committed an offense, including a person 12 eighteen years of age or older over whom jurisdiction has been extended 13 under RCW 13.40.300;

(16) "Local sanctions" means one or more of the following: (a) 0-30 days of confinement; (b) 0-12 months of community supervision; (c) 0-150 hours of community restitution; or (d) \$0-\$500 fine;

17 (17) "Manifest injustice" means a disposition that would either 18 impose an excessive penalty on the juvenile or would impose a serious, 19 and clear danger to society in light of the purposes of this chapter;

(18) "Monitoring and reporting requirements" means one or more of 20 21 the following: Curfews; requirements to remain at home, school, work, 22 court-ordered treatment programs during specified hours; or restrictions from leaving or entering specified geographical areas; 23 24 requirements to report to the probation officer as directed and to 25 remain under the probation officer's supervision; and other conditions or limitations as the court may require which may not include 26 27 confinement;

(19) "Offense" means an act designated a violation or a crime if committed by an adult under the law of this state, under any ordinance of any city or county of this state, under any federal law, or under the law of another state if the act occurred in that state;

(20) "Probation bond" means a bond, posted with sufficient security by a surety justified and approved by the court, to secure the offender's appearance at required court proceedings and compliance with court-ordered community supervision or conditions of release ordered pursuant to RCW 13.40.040 or 13.40.050. It also means a deposit of cash or posting of other collateral in lieu of a bond if approved by the court; (21) "Respondent" means a juvenile who is alleged or proven to have
 committed an offense;

(22) "Restitution" means financial reimbursement by the offender to 3 the victim, and shall be limited to easily ascertainable damages for 4 5 injury to or loss of property, actual expenses incurred for medical treatment for physical injury to persons, lost wages resulting from 6 7 physical injury, and costs of the victim's counseling reasonably related to the offense. Restitution shall not include reimbursement 8 9 for damages for mental anguish, pain and suffering, or other intangible losses. Nothing in this chapter shall limit or replace civil remedies 10 or defenses available to the victim or offender; 11

12 (23) "Secretary" means the secretary of the department of social 13 and health services. "Assistant secretary" means the assistant 14 secretary for juvenile rehabilitation for the department;

15 (24) "Services" means services which provide alternatives to 16 incarceration for those juveniles who have pleaded or been adjudicated 17 guilty of an offense or have signed a diversion agreement pursuant to 18 this chapter;

(1) If a respondent is adjudicated of taking a motor vehicle without permission in the first degree as defined in RCW 9A.56.070, the court shall impose the following minimum sentence, in addition to any restitution the court may order payable to the victim:

(a) Juveniles with a prior criminal history score of zero to onehalf points shall be sentenced to a standard range sentence that includes no less than ((five days of home detention)) three months of community\_supervision, forty-five hours of community restitution, ((and)) a two hundred dollar fine, and a requirement that the juvenile remain\_at\_home\_such\_that\_the\_juvenile\_is\_confined\_to\_a\_private 1 residence for no less than five days. The juvenile may be subject to
2 electronic monitoring where available. If the juvenile is enrolled in
3 school, the confinement shall be served on nonschool days;

(b) Juveniles with a prior criminal history score of three-quarters
to one and one-half points shall be sentenced to ((<del>[a]</del>)) <u>a</u> standard
range sentence that includes <u>six months of community supervision</u>, no
less than ten days of detention, ninety hours of community restitution,
and a four hundred dollar fine; and

The juvenile may be subject to 28 electronic monitoring where available; 29

30 (b) Juveniles with a prior criminal history score of three-quarters 31 to one and one-half points shall be sentenced to ((<del>[a]</del>)) <u>a</u> standard 32 range sentence that includes <u>no\_less\_than\_six\_months\_of\_community</u> 33 <u>supervision</u>, no less than ten days of detention, ninety hours of 34 community restitution, and a four hundred dollar fine; and

35 (c) Juveniles with a prior criminal history score of two or more 36 points shall be sentenced to no less than fifteen to thirty-six weeks 37 ((of-confinement,-seven-days-of-home-detention)) commitment\_to\_the <u>juvenile\_rehabilitation\_administration</u>, four months of <u>parole</u> supervision, ninety hours of community restitution, and a four hundred dollar fine.

5 without permission in the second degree as defined in RCW 9A.56.075,
6 the court shall impose a standard range as follows:

7 (a) Juveniles with a prior criminal history score of zero to onehalf points shall be sentenced to a standard range sentence that 8 includes ((either: (i) No less than one day of home detention, one)) 9 three months of community supervision, ((and)) fifteen hours of 10 community restitution((+-or-(ii)-no-home-detention,-one-month-of 11 12 supervision, - and - thirty - hours - of - community - restitution)), \_ and \_ a 13 requirement that the juvenile remain at home such that the juvenile is 14 confined in a private residence for no less than one day. If the juvenile is enrolled in school, the confinement shall be served on 15 nonschool days. The juvenile may be subject to electronic monitoring 16 17 where available;

(b) Juveniles with a prior criminal history score of three-quarters 18 to one and one-half points shall be sentenced to a standard range 19 sentence that includes no less than one day of detention, ((two days of 20 21 home-detention,-two)) three months of community supervision, thirty 22 hours of community restitution, ((and)) a one hundred fifty dollar fine, and a requirement that the juvenile remain at home such that the 23 24 juvenile is confined in a private residence for no less than two days. If the juvenile is enrolled in school, the confinement shall be served 25 on nonschool days. The juvenile may be subject to electronic 26 27 monitoring where available; and

(c) Juveniles with a prior criminal history score of two or more 28 points shall be sentenced to no less than three days of detention, 29 ((seven-days-of-home-detention,-three)) six months of community 30 supervision, forty-five hours of community restitution, ((and)) a one 31 hundred fifty dollar fine, and a requirement that the juvenile remain 32 at home such that the juvenile is confined in a private residence for 33 no less than seven days.
