- (1)(a) The Washington professional educator standards board is created, consisting of ((twenty)) twelve members to be appointed by the governor to four-year terms and the superintendent of public instruction. On August 1, 2009, the board shall be reduced to twelve members.
- (b) ((As the four year terms of the first appointees expire or))

 Yacancies ((to)) on the board ((occur for the first time,)) shall be

 filled by appointment or reappointment by the governor ((shall appoint

 or reappoint the members of the board to one year to four year

 staggered terms. Once the one year to three year terms expire, all

 subsequent terms shall be for)) to terms of four years((, with the

terms expiring on June 30th of the applicable year. The terms shall be staggered—in—such—a—way—that,—where—possible,—the—terms—of—members representing a specific group do not expire simultaneously)).

- (c) No person may serve as a member of the board for more than two consecutive full four-year terms.
- (d) The governor shall ((annually)) biennially appoint the chair of the board ((from among the teachers and principals on the board)). No board member may serve as chair for more than ((two)) four consecutive years.
- (2) ((Seven-of-the-members-shall-be-public-school-teachers, one shall-be-a-private-school-teacher,-three-shall-represent-higher education-educator-preparation-programs,-four-shall-be-school administrators, two shall be educational staff associates, one shall be a classified employee who assists in public school student instruction, one shall be a parent, and one shall be a member of the public.

 - (5) Appointees from higher education educator preparation programs must include two representatives from institutions of higher education as defined in RCW 28B.10.016 and one representative from an institution of higher education as defined in RCW 28B.07.020(4).
 - (6) School administrators appointed to the board must:
- 34 (a) Have at least three years of administrative experience in a 35 Washington public school district;
- 36 (b)—Be—currently—certificated—and—actively—employed—in—a—school 37 administrator position; and

1 (c) Include two public school principals, one Washington approved 2 private school principal, and one superintendent.

- (7) Educational staff associates appointed to the board must:
- (a)-Have-at-least-three-years-of-educational-staff-associate experience in a Washington public school district; and
- (b) Be currently certificated and actively employed in an educational staff associate position.
 - (8) Public school classified employees appointed to the board must:
- 9 (a) Have at least three years of experience in assisting in the
 10 instruction of students in a Washington public school; and
 - (b) Be currently employed in a position that requires the employee to assist in the instruction of students.
 - (9)—Each—major—caucus—of—the—house—of—representatives—and—the senate shall submit a list of at least—one public school teacher.  - (b) Experience providing or leading a state-approved teacher or educator preparation program;

 - (d) Education-related community experience.
- 37 (3) In appointing board members, the governor shall consider the 38 individual's commitment to guality education and the ongoing

improvement of instruction, experiences in the public schools, involvement in developing quality teaching preparation and support programs, and vision for the most effective yet practical system of assuring teaching quality. The governor shall also consider the diversity of the population of the state.

- (4) Each member of the board shall be compensated in accordance with RCW 43.03.240 and shall be reimbursed for travel expenses incurred in carrying out the duties of the board in accordance with RCW 43.03.050 and 43.03.060.
- ((\(\frac{(14)}{14}\))) (5) The governor may remove a member of the board for neglect of duty, misconduct, malfeasance or misfeasance in office, or for incompetency or unprofessional conduct as defined in chapter 18.130 RCW. In such a case, the governor shall file with the secretary of state a statement of the causes for and the order of removal from office, and the secretary of state shall send a certified copy of the statement of causes and order of removal to the last known post office address of the member.
 - (((15) If a vacancy occurs on the board, the governor shall appoint a replacement member from the nominees as specified in subsection (9) of—this—section—to—fill—the—remainder—of—the—unexpired—term. When filling—a—vacancy—of—a—member—nominated—by—a—major—caucus—of—the legislature, the governor shall select the new member from a list of at least one name submitted by the same caucus that provided the list from which the retiring member was appointed.
- (16))) (6) Members of the board shall hire an executive director and an administrative assistant to reside in the office of the superintendent of public instruction for administrative purposes only.

- Any teacher whose certificate to teach has been questioned under RCW 28A.410.090 shall have a right to be heard by the issuing authority before his or her certificate is revoked. ((Any-teacher-whose certificate to teach has been revoked shall have a right of appeal to the-Washington-professional-educator-standards-board-if-notice-of

appeal is given by written affidavit to the board within thirty days 1 after the certificate is revoked.

7 Sec. 4. RCW 28A.410.210 and 2008 c 176 s 1 are each amended to 8 read as follows:

The purpose of the professional educator standards board is to establish policies and requirements for the preparation and certification of educators that provide standards for competency in professional knowledge and practice in the areas of certification; a foundation of skills, knowledge, and attitudes necessary to help students with diverse needs, abilities, cultural experiences, and learning styles meet or exceed the learning goals outlined in RCW 28A.150.210; knowledge of research-based practice; and professional development throughout a career. The Washington professional educator standards board shall:

- (1) Establish policies and practices for the approval of programs of courses, requirements, and other activities leading to educator certification including teacher, school administrator, and educational staff associate certification;
- (2) Establish policies and practices for the approval of the character of work required to be performed as a condition of entrance to and graduation from any educator preparation program including teacher, school administrator, and educational staff preparation program as provided in subsection (1) of this section;
- (3) Establish a list of accredited institutions of higher education of this and other states whose graduates may be awarded educator certificates as teacher, school administrator, and educational staff associate and establish criteria and enter into agreements with other states to acquire reciprocal approval of educator preparation programs and certification, including teacher certification from the national board for professional teaching standards;
- (4) Establish policies for approval of nontraditional educator 35 36 preparation programs;

1 (5) Conduct a review of educator program approval standards at 2 least every five years, beginning in 2006, to reflect research findings 3 and assure continued improvement of preparation programs for teachers, 4 administrators, and school specialized personnel;

- 10 (8))) Apply for and receive federal or other funds on behalf of the state for purposes related to the duties of the board;

- ((\(\frac{(14)}{)}\)) (13) By January 2010, set performance standards and develop, pilot, and implement a uniform and externally administered professional-level certification assessment based on demonstrated teaching skill. In the development of this assessment, consideration shall be given to changes in professional certification program components such as the culminating seminar; and

- 5 Correct the title.

Retains underlying bill with the following changes: Removes specific direction regarding how the reduction from 20 board members to 12 board members is to be accomplished.

Clarifies that a majority of board members must have classroom experience but that it is not necessary that they be currently working in a classroom.

Provides greater specificity with respect to the membership criterion regarding a state-approved preparation program, clarifying that it means a state-approved teacher or educator preparation program.
