EFFECT: (1) Changes the structure of the penalties imposed for parking infractions related to the unauthorized use of placards and license plates, blocking access aisles of parking spaces reserved for persons with disabilities, and unlawfully parking in a space reserved for a person with a physical disability. Instead

of a \$450 penalty, a \$250 penalty for the parking infraction plus a separate \$200 assessment will be imposed.

(1) The \$200 assessment, or any proportion imposed, will be divided between the Accessible Communities Account and the Multimodal Account.
