- "(1) ((Each)) The growth management hearings board shall consist of ((three)) seven members qualified by experience or training in matters pertaining to land use planning and ((residing within the jurisdictional boundaries of the applicable board. At least one member of each board must be admitted to practice law in this state and at least one member must have been a city or county elected official. Each board shall be appointed by the governor and not more than two members at the time of appointment or during their term shall be members of the same political party)) as appointed in RCW 36.70A.250. No more than two members at the time of appointment or
- (2) Each member of a board shall be appointed for a term of six years and shall not serve more than two terms. A vacancy shall be filled ((by appointment by the governor for the unexpired portion of the term in which the vacancy occurs. The terms of the first three members of a board shall be staggered so that one member is appointed to serve until July 1, 1994, one member until July 1, 1996, and one member until July 1, 1998)) in accordance with RCW 36.70A.250(2)"
