- 1 AN ACT Relating to eliminating the Columbia River Gorge Compact;
- 2 creating a new section; and repealing RCW 43.97.015, 43.97.025,
- 3 43.97.035, 35.22.700, 35.63.150, 35.63.200, 36.32.550, 36.70.980, and
- 4 90.58.600.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** It is the intent of the legislature to
- 7 repeal the Columbia River Gorge Compact with the Congress of the United
- 8 States and the state of Oregon due to the financial constraints facing
- 9 the state. While the legislature recognizes the importance of the
- 10 Columbia River Gorge National Scenic Area Act, P.L. 99-963, it finds it
- 11 can no longer support the financial obligations under this interstate
- 12 compact. The legislature intends to renegotiate the compact when
- 13 financial circumstances improve.
- 14 <u>NEW SECTION.</u> **Sec. 2.** The following acts or parts of acts are each
