- 6 **Sec. 1.** RCW 71.09.2501 and 2002 c 68 s 11 are each amended to read 7 as follows:
- 8 ((An emergency has been caused by the)) The department has a need
- 9 to expeditiously site and construct facilities to house sexually
- 10 violent predators who have been committed under this chapter. To meet
- 11 this ((emergency)) need, for purposes of RCW 71.09.250 and 71.09.342,
- 12 "all other laws" means the state environmental policy act, the
- 13 shoreline management act, the hydraulics code, and all other state laws
- 14 regulating the protection and use of the water, land, and air.
