- AN ACT Relating to aggravated retail theft; amending RCW 9A.56.360;
- 2 reenacting and amending RCW 9.94A.515; and prescribing penalties.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 9A.56.360 and 2006 c 277 s 3 are each amended to read 5 as follows:
 - (1) A person commits <u>aggravated</u> retail theft ((with extenuating circumstances)) if he or she commits theft of property from a mercantile establishment with one of the following ((extenuating)) aggravating circumstances:
 - (a) To facilitate the theft, the person leaves the mercantile establishment through a designated emergency exit;
- 12 (b) The person was, at the time of the theft, in possession of an 13 item, article, implement, or device designed to overcome security 14 systems including, but not limited to, lined bags or tag removers; or
- 15 (c) The person committed theft at three or more separate and 16 distinct mercantile establishments within a one hundred eighty-day 17 period.
- 18 (2) A person is guilty of <u>aggravated</u> retail theft ((with

extenuating circumstances)) in the first degree if the theft involved constitutes theft in the first degree. Aggravated retail theft ((with extenuating circumstances)) in the first degree is a class B felony.

- (3) A person is guilty of <u>aggravated</u> retail theft ((with extenuating circumstances)) in the second degree if the theft involved constitutes theft in the second degree. <u>Aggravated retail</u> theft ((with extenuating circumstances)) in the second degree is a class C felony.
- (4) A person is guilty of <u>aggravated</u> retail theft ((with extenuating circumstances)) in the third degree if the theft involved constitutes theft in the third degree. <u>Aggravated retail</u> theft ((with extenuating circumstances)) in the third degree is a class C felony.
