2 **MISCELLANEOUS AND SUPPLEMENTAL PROVISIONS**

3 **Sec. 6001.** 2009 c 497 s 6009 (uncodified) is amended to read as
4 follows:

5 ACQUISITION OF PROPERTIES AND FACILITIES THROUGH FINANCIAL
6 CONTRACTS. The following agencies may enter into financial contracts,
7 paid from any funds of an agency, appropriated or nonappropriated, for
8 the purposes indicated and in not more than the principal amounts
9 indicated, plus financing expenses and required reserves pursuant to
10 chapter 39.94 RCW. When securing properties under this section,
11 agencies shall use the most economical financial contract option
12 available, including long-term leases, lease-purchase agreements,
13 lease-development with option to purchase agreements or financial
14 contracts using certificates of participation. Expenditures made by an
15 agency for one of the indicated purposes before the issue date of the
16 authorized financial contract and any certificates of participation
17 therein are intended to be reimbursed from proceeds of the financial
18 contract and any certificates of participation therein to the extent
19 provided in the agency's financing plan approved by the state finance
20 committee.

21 State agencies may enter into agreements with the department of
22 general administration and the state treasurer's office to develop
23 requests to the legislature for acquisition of properties and
24 facilities through financial contracts. The agreements may include
25 charges for services rendered.

26 Those noninstructional facilities of higher education institutions
27 authorized in this section to enter into financial contracts are not
28 eligible for state funded maintenance and operations. Instructional
29 space that is available for regularly scheduled classes for academic
30 transfer, basic skills, and workforce training programs may be eligible
31 for state funded maintenance and operations.

32 (1) Department of corrections: Enter into a financing contract for
33 up to \$17,958,000 plus financing expenses and required reserves
34 pursuant to chapter 39.94 RCW to purchase or build work release beds,
35 violator beds, or other community-based re-entry facilities.

1 (a) Enter into a financing contract on behalf of Walla Walla
2 Community College for up to \$1,000,000 plus financing expenses and
3 required reserves pursuant to chapter 39.94 RCW to purchase up to 40
4 acres of land.

5 (b) Enter into a financing contract on behalf of Bellingham
6 Technical College for up to \$1,390,000 plus financing expenses and
7 required reserves pursuant to chapter 39.94 RCW to develop an
8 instructional resource center.

9 (c) Enter into a financing contract on behalf of Bellingham
10 Technical College for up to \$28,968,000 plus financing expenses and
11 required reserves pursuant to chapter 39.94 RCW to develop an
12 instructional resource center. The cost of this financing contract
13 shall be paid from the community and technical colleges capital
14 projects account. This facility shall be eligible for maintenance and
15 operations funding on the same terms as if constructed with state
16 general obligation bonds.

17 (d) Enter into a financing contract on behalf of Edmonds Community
18 College for up to \$5,000,000 plus financing expenses and required
19 reserves pursuant to chapter 39.94 RCW to provide space for allied
20 health and construction industry.

21 (e) Contingent upon the sale and purchase specified in section 5071
22 of this act, enter into a financing contract on behalf of Spokane
23 Community College for up to \$3,400,000 plus financing expenses and
24 required reserves pursuant to chapter 39.94 RCW to purchase the
25 Riverpoint One building.

26 (f) Enter into a financing contract on behalf of North Seattle
27 Community College for up to \$8,900,000 plus financing expenses and
28 required reserves pursuant to chapter 39.94 RCW to develop an
29 employment resource center.

30 (g) Enter into a financing contract on behalf of Everett Community
31 College for up to \$25,000,000 plus financing expenses and required
32 reserves pursuant to chapter 39.94 RCW to develop a student fitness and
33 health center.

34 (h) Enter into a financing contract on behalf of Wenatchee Valley
35 Community College for up to \$2,700,000 plus financing expenses and
36 required reserves pursuant to chapter 39.94 RCW to purchase a music and
37 art center.

1 (i) Enter into a financing contract on behalf of Green River
2 Community College for up to \$20,000,000 plus financing expenses and
3 required reserves pursuant to chapter 39.94 RCW to develop a 40,000
4 square foot addition to Green River Kent station.

5 (j) Enter into a financing contract on behalf of Walla Walla
6 Community College for up to \$1,000,000 plus financing expenses and
7 required reserves pursuant to chapter 39.94 RCW for the water and
8 environment center.

9 (k) Enter into a financing contract pursuant to chapter 39.94 RCW
10 on behalf of Green River Community College for up to \$26,532,000 plus
11 financing expenses and required reserves to construct a new classrooms
12 facility as specified in project 20061205. The cost of this financing
13 contract shall be paid from the community and technical colleges
14 capital projects account. This facility shall be eligible for
15 maintenance and operations funding on the same terms as if constructed
16 with state general obligation bonds.

17 (3) Parks and recreation commission: Enter into a financing
18 contract for up to \$2,500,000 plus financing expenses and required
19 reserves pursuant to chapter 39.94 RCW for the Mount Spokane lodge.
20 The parks and recreation commission shall use energy savings
21 performance contracting if practicable. The lodge shall be operated by
22 a private concessionaire under a contract with the parks and recreation
23 commission that is a qualified management contract under the applicable
24 internal revenue service guidelines.

25 (4) Department of general administration: Enter into a financing
26 contract for up to \$27,144,000 plus financing expenses and required
27 reserves pursuant to chapter 39.94 RCW for the rehabilitation of the
28 John L. O'Brien building, subject to approval of the project scope by
29 the speaker of the house of representatives and the chief clerk of the
30 house of representatives.

31 (5) Department of ecology: Enter into a financing contract for up
32 to \$11,000,000 plus financing expenses and required reserves pursuant
33 to chapter 39.94 RCW to rebuild the east wall of the department of
34 ecology's headquarters building in Lacey, Washington.

35 (6) Washington State University: Enter into a financing contract
36 for up to \$15,000,000 plus financing expenses and required reserve
37 pursuant to chapter 39.94 RCW for a student information system.

1 NEW SECTION. **Sec. 6002.** If any provision of this act or its
2 application to any person or circumstance is held invalid, the
3 remainder of the act or the application of the provision to other
4 persons or circumstances is not affected.

5 NEW SECTION. **Sec. 6003.** This act is necessary for the immediate
6 preservation of the public peace, health, or safety, or support of the
7 state government and its existing public institutions, and takes effect
8 immediately.
