27 Sec. 1001. RCW 10.01.050 and Code 1881 s 770 are each amended to 28 read as follows:

No person charged with any offense against the law shall be punished for such offense, unless he <u>or she</u> shall have been duly and legally convicted thereof in a court having competent jurisdiction of the case and of the person.

33 Sec. 1002. RCW 10.01.060 and 1951 c 52 s 1 are each amended to 34 read as follows:

No person informed against or indicted for a crime shall be convicted thereof, unless by admitting the truth of the charge in his <u>or her</u> plea, by confession in open court, or by the verdict of a jury, accepted and recorded by the court: PROVIDED HOWEVER, That except in capital cases, where the person informed against or indicted for a crime is represented by counsel, such person may, with the assent of the court, waive trial by jury and submit to trial by the court.

8 Sec. 1003. RCW 10.01.120 and Code 1881 s 1136 are each amended to 9 read as follows:

Whenever a prisoner has been sentenced to death, the governor shall 10 11 have power to commute such sentence to imprisonment for life at hard labor; and in all cases in which the governor is authorized to grant 12 13 pardons or commute sentence of death, he or she may, upon the petition of the person convicted, commute a sentence or grant a pardon, upon 14 such conditions, and with such restrictions, and under such limitations 15 16 as he or she may think proper; and he or she may issue his or her 17 warrant to all proper officers to carry into effect such pardon or commutation, which warrant shall be obeyed and executed, instead of the 18 19 sentence, if any, which was originally given. The governor may also, 20 on good cause shown, grant respites or reprieves from time to time as 21 he or she may think proper.

22 **Sec. 1004.** RCW 10.01.140 and 1895 c 10 s 2 are each amended to 23 read as follows:

No allowance of mileage shall be made to a juror or witness who has not verified his <u>or her</u> claim of mileage under oath before the clerk of the court on which he <u>or she</u> is in attendance.

27 **Sec. 1005.** RCW 10.01.150 and 1999 c 163 s 6 are each amended to 28 read as follows:

Whenever a state officer or employee is charged with a criminal offense arising out of the performance of an official act which was fully in conformity with established written rules, policies, and guidelines of the state or state agency, the employing agency may request the attorney general to defend the officer or employee. If the agency finds, and the attorney general concurs, that the officer's or employee's conduct was fully in accordance with established written

rules, policies, and guidelines of the state or a state agency and the 1 2 act performed was within the scope of employment, then the request shall be granted and the costs of defense shall be paid by the 3 requesting agency: PROVIDED, HOWEVER, If the agency head is the person 4 charged, then approval must be obtained from both the attorney general 5 and the state auditor. If the court finds that the officer or employee б 7 was performing an official act, or was within the scope of employment, 8 and that his or her actions were in conformity with the established rules, regulations, policies, and guidelines of the state and the state 9 10 agency, the cost of any monetary fine assessed shall be paid from the liability account. 11

12 Sec. 1006. RCW 10.01.180 and 1989 c 373 s 13 are each amended to 13 read as follows:

(1) A defendant sentenced to pay a fine or costs who defaults in
the payment thereof or of any installment is in contempt of court as
provided in chapter 7.21 RCW. The court may issue a warrant of arrest
for his <u>or her</u> appearance.

18 (2) When a fine or assessment of costs is imposed on a corporation 19 or unincorporated association, it is the duty of the person authorized 20 to make disbursement from the assets of the corporation or association 21 to pay the fine or costs from those assets, and his <u>or her</u> failure to 22 do so may be held to be contempt.

23 (3) If a term of imprisonment for contempt for nonpayment of a fine 24 or costs is ordered, the term of imprisonment shall be set forth in the 25 commitment order, and shall not exceed one day for each twenty-five dollars of the fine or costs, thirty days if the fine or assessment of 26 27 costs was imposed upon conviction of a violation or misdemeanor, or one year in any other case, whichever is the shorter period. A person 28 29 committed for nonpayment of a fine or costs shall be given credit 30 toward payment for each day of imprisonment at the rate specified in 31 the commitment order.

(4) If it appears to the satisfaction of the court that the default in the payment of a fine or costs is not contempt, the court may enter an order allowing the defendant additional time for payment, reducing the amount thereof or of each installment or revoking the fine or costs or the unpaid portion thereof in whole or in part.

1 (5) A default in the payment of a fine or costs or any installment 2 thereof may be collected by any means authorized by law for the 3 enforcement of a judgment. The levy of execution for the collection of 4 a fine or costs shall not discharge a defendant committed to 5 imprisonment for contempt until the amount of the fine or costs has 6 actually been collected.

7 Sec. 1007. RCW 10.04.110 and 1987 c 202 s 153 are each amended to 8 read as follows:

In all cases of conviction, unless otherwise provided in this 9 chapter, the judge shall enter judgment for the fine and costs against 10 11 the defendant, and may commit him or her to jail until the amount of 12 such fine and costs owing are paid, or the payment thereof be secured 13 as provided by RCW 10.04.120. The amount of such fine and costs owing 14 shall be computed as provided for superior court cases in RCW 10.82.030 Further proceedings therein shall be had as in like 15 and 10.82.040. 16 cases in the superior court: PROVIDED, That all fees, fines, 17 forfeitures and penalties collected or assessed by a district court because of the violation of a state law shall be remitted as provided 18 in chapter 3.62 RCW as now exists or is later amended. 19

20 **Sec. 1008.** RCW 10.10.060 and 1891 c 29 s 7 are each amended to 21 read as follows:

22 The appellant in a criminal action shall not be required to advance any fees in claiming his or her appeal nor in prosecuting the same; but 23 24 if convicted in the appellate court, or if sentenced for failing to 25 prosecute his or her appeal, he or she may be required as a part of the 26 sentence to pay the costs of the prosecution. If the appellant shall 27 fail to enter and prosecute his or her appeal he or she shall be 28 defaulted of his or her recognizance, if any was taken, and the superior court may award sentence against him or her for the offense 29 30 whereof he or she was convicted in like manner as if he or she had been convicted thereof in that court; and if he or she be not then in 31 custody process may be issued to bring him or her into court to receive 32 33 sentence.

34 Sec. 1009. RCW 10.16.080 and Code 1881 s 1925 are each amended to 35 read as follows:

If it should appear upon the whole examination that no offense has been committed, or that there is not probable cause for charging the defendant with an offense, he <u>or she</u> shall be discharged, and if in the opinion of the magistrate, the complaint was malicious, or without probable cause, and there was no reasonable ground therefor, the costs shall be taxed against the party making the complaint.

7 Sec. 1010. RCW 10.16.110 and 1890 p 102 s 6 are each amended to 8 read as follows:

9 It shall be the duty of the prosecuting attorney of the proper county to inquire into and make full examination of all the facts and 10 11 circumstances connected with any case of preliminary examination, as 12 provided by law, touching the commission of any offense wherein the 13 offender shall be committed to jail, or become recognized or held to bail; and if the prosecuting attorney shall determine in any such case 14 that an information ought not to be filed, he or she shall make, 15 16 subscribe, and file with the clerk of the court a statement in writing containing his or her reasons, in fact and in law, for not filing an 17 information in such case, and such statement shall be filed at and 18 during the session of court at which the offender shall be held for his 19 20 or her appearance: PROVIDED, That in such case such court may examine 21 such statement, together with the evidence filed in the case, and if upon such examination the court shall not be satisfied with such 22 23 statement, the prosecuting attorney shall be directed by the court to 24 file the proper information and bring the case to trial.

If the magistrate shall be satisfied that there is good cause to believe that any such witness will not perform the condition of his <u>or</u> <u>her</u> recognizance unless other security be given, such magistrate may order the witness to enter into recognizance with such sureties as may be deemed necessary for his <u>or her</u> appearance at court.

32 **Sec. 1012.** RCW 10.16.150 and 1973 1st ex.s. c 154 s 19 are each 33 amended to read as follows:

When any minor is a material witness, any other person may be allowed to recognize for the appearance of such witness, or the 1 magistrate may, in his <u>or her</u> discretion, take the recognizance of such 2 minor in a sum not exceeding fifty dollars which shall be valid and 3 binding in law, notwithstanding the disability of minority.

4 Sec. 1013. RCW 10.19.040 and Code 1881 s 1034 are each amended to 5 read as follows:

Any officer authorized to execute a warrant in a criminal action, may take the recognizance and justify and approve the bail; he <u>or she</u> may administer an oath and examine the bail as to its sufficiency.

9 Sec. 1014. RCW 10.19.060 and Code 1881 s 1035 are each amended to 10 read as follows:

Every recognizance taken by any peace officer must be certified by him <u>or her</u> forthwith to the clerk of the court to which the defendant is recognized. The clerk must thereupon record the recognizance in the order book, and, from the time of filing, it has the same effect as if taken in open court.

16 Sec. 1015. RCW 10.22.010 and 2008 c 276 s 308 are each amended to 17 read as follows:

18 When a defendant is prosecuted in a criminal action for a 19 misdemeanor, other than a violation of RCW 9A.48.105, for which the 20 person injured by the act constituting the offense has a remedy by a 21 civil action, the offense may be compromised as provided in RCW 22 10.22.020, except when it was committed:

(1) By or upon an officer while in the execution of the duties ofhis <u>or her</u> office;

In such case, if the party injured appear in the court in which the cause is pending at any time before the final judgment therein, and acknowledge, in writing, that he <u>or she</u> has received satisfaction for

the injury, the court may, in its discretion, on payment of the costs incurred, order all proceedings to be discontinued and the defendant to be discharged. The reasons for making the order must be set forth therein and entered in the minutes. Such order is a bar to another prosecution for the same offense.

6 **Sec. 1017.** RCW 10.25.070 and 1891 c 28 s 7 are each amended to 7 read as follows:

substantially conform to the requirements of chapter 2.36 RCW; or

(2) At any time after a grand juror is drawn, refuse to swear him or her, or discharge him or her after he or she has been sworn, upon a finding that he or she is disqualified from service pursuant to chapter 2.36 RCW, or incapable of performing his or her duties because of bias or prejudice, or guilty of misconduct in the performance of his or her duties such as to impair the proper functioning of the grand jury.

31 **Sec. 1019.** RCW 10.27.070 and 1971 ex.s. c 67 s 7 are each amended 32 to read as follows:

33 (1) When the grand jury is impaneled, the court shall appoint one 34 of the jurors to be ((foreman)) foreperson, and also another of the jurors to act as ((foreman)) foreperson in case of the absence of the ((foreman)) foreperson.

In addition, the ((foreman)) foreperson of the grand jury may, in his or her discretion, select one of the grand jurors to act as secretary to keep records of the grand jury's business.

(5) The court, whenever necessary, shall appoint an interpreter,
and shall swear him <u>or her</u> not to disclose any testimony or the name of

30 (6) When a person held in official custody is a witness before a 31 grand jury or special inquiry judge, a public servant, assigned to 32 guard him <u>or her</u> during his <u>or her</u> appearance may accompany him <u>or her</u>. 33 The court shall swear such public servant not to disclose any testimony 34 or the name of any witness except as provided in RCW 10.27.090.

35 (7) Proceedings of a grand jury shall not be valid unless at least 36 twelve of its members are present. The ((foreman)) foreperson or 37 acting ((foreman)) foreperson of the grand jury shall conduct

1 proceedings in an orderly manner and shall administer an oath or 2 affirmation in the manner prescribed by law to any witness who shall 3 testify before the grand jury.

(8) The legal advisers of a grand jury are the court and public
attorneys, and a grand jury may not seek or receive legal advice from

attorneys or both must instruct the grand jury concerning the law with
respect to its duties or any matter before it, and such instructions
shall be recorded by the reporter.

10 (9)(a) Upon request of the prosecuting attorney of the county in 11 which a grand jury or special inquiry judge is impaneled, the attorney 12 general shall assist such prosecuting attorney in attending such grand 13 jury or special inquiry judge.

(b) Whenever directed by the court, the attorney general shall supersede the prosecuting attorney in attending the grand jury and in which event the attorney general shall be responsible for the prosecution of any indictment returned by the grand jury.

18 (c) When the attorney general is conducting a criminal 19 investigation pursuant to powers otherwise granted to him <u>or her</u>, he <u>or</u> 20 <u>she</u> shall attend all grand juries or special inquiry judges in relation 21 thereto and shall prosecute any indictments returned by a grand jury.

22 (10) After consulting with the court and receiving its approval, 23 the grand jury may request the governor to appoint a special prosecutor 24 to attend the grand jury. The grand jury shall in the request nominate 25 three persons approved by the court. jury has been convened may appear as a witness before the grand jury to advise the grand jury of any criminal activity or corruption within his <u>or her</u> jurisdiction.

The order of discharge is a bar to 9 10 another prosecution for the same offense.

In every case where imprisonment in the penitentiary is awarded against any convict, the form of the sentence shall be, that he <u>or she</u> be punished by confinement at hard labor; and he <u>or she</u> may also be sentenced to solitary imprisonment for such term as the court shall direct, not exceeding twenty days at any one time; and in the execution of such punishment the solitary shall precede the punishment by hard labor, unless the court shall otherwise order. 1 Sec. 1057. Such prisoner shall not be entitled 11 to demand a new requisition while in this state.

12 Sec. 1075. RCW 10.88.320 and 1971 ex.s. c 46 s 13 are each amended 13 to read as follows:

Sec. 1076. RCW 10.88.330 and 1979 ex.s. c 244 s 16 are each 1 2 amended to read as follows:

3 (1) The arrest of a person may be lawfully made also by any peace 4 officer or a private person, without a warrant upon reasonable 5 information that the accused stands charged in the courts of a state with a crime punishable by death or imprisonment for a term exceeding б 7 one year, but when so arrested the accused must be taken before a judge 8 or magistrate with all practicable speed and complaint must be made against him or her under oath setting forth the ground for the arrest 9 10 as in RCW 10.88.320; and thereafter his or her answer shall be heard as if he or she had been arrested on a warrant. 11

23 (iii) The officer has reasonable cause to believe that a crime as 24 defined in (b)(i) or (ii) of this subsection has been committed and 25 reasonable cause to believe that the person to be arrested has 26 committed it;

27 (iv) The officer has reasonable cause to believe that a felony has 28 been committed and reasonable cause to believe that the person to be 29 arrested has committed it; or

30 (v) The officer has received positive information by written, 31 telegraphic, teletypic, telephonic, radio, or other authoritative 32 source that a peace officer holds a warrant for the person's arrest; 33 and

(c) The regional commissioner of customs certifies to the state of 34 35 Washington that the customs officer has received proper training within 36 the agency to enable that officer to enforce or administer this 37 subsection.

1 Sec. 1077. RCW 10.88.340 and 1971 ex.s. c 46 s 15 are each amended 2 to read as follows:

in this section provided for, he <u>or she</u> or they shall have a right of action against said distributees and creditors to compel them to contribute their just share.

20 **Sec. 2074.** RCW 11.76.230 and 1965 c 145 s 11.76.230 are each 21 amended to read as follows:

The agent shall be liable on his <u>or her</u> bond for the care and preservation of the estate while in his <u>or her</u> hands, and for the payment of the funds to the county treasury, and may be sued thereon by any person interested including the state.

26 **Sec. 2075.** RCW 11.76.240 and 1975 1st ex.s. c 278 s 11 are each 27 amended to read as follows:

During the time the estate is held by the agent, or within four years after it is delivered to the county treasury, claim may be made thereto only by the absentee person or his <u>or her</u> legal representative, excepting that if it clearly appears that such person died prior to the decedent in whose estate distribution was made to him <u>or her</u>, but leaving lineal descendants surviving, such lineal descendants may claim. 31 Before letters of guardianship are issued, each guardian or limited 32 guardian shall take and subscribe an oath and, unless dispensed with by 33 order of the court as provided in RCW 11.88.105, file a bond, with 34 sureties to be approved by the court, payable to the state, in such sum

1 as the court may fix, taking into account the character of the assets 2 on hand or anticipated and the income to be received and disbursements 3 to be made, and such bond shall be conditioned substantially as 4 follows:

The court may require an additional bond whenever for any reason it appears to the court that an additional bond should be given.

If letters of 5 administration are granted upon petition filed within forty days after 6 7 the death of the incapacitated person, the personal representative 8 shall supersede the guardian or limited guardian in the administration of the estate and the estate shall be administered as a decedent's 9 10 estate as provided in this title, including the publication of notice to creditors and other interested persons and the barring of creditors 11 12 claims.

(18) Mortgage, pledge the assets or the credit of the trust estate, or otherwise encumber trust property, including future income, whether an initial encumbrance or a renewal or extension of it, for a term within or extending beyond the term of the trust, in connection with the exercise of any power vested in the trustee;

(19) Make ordinary or extraordinary repairs or alterations in
 buildings or other trust property, demolish any improvements, raze
 existing structures, and make any improvements to trust property;

(20) Create restrictions, easements, including easements to public
 use without consideration, and other servitudes;

33 (21) Manage any business interest, including any farm or ranch 34 interest, regardless of form, received by the trustee from the trustor 35 of the trust, as a result of the death of a person, or by gratuitous 36 transfer from any other transferor, and with respect to the business 37 interest, have the following powers:

(a) To hold, retain, and continue to operate that business interest
 solely at the risk of the trust, without need to diversify and without
 liability on the part of the trustee for any resulting losses;

4 (b) To enlarge or diminish the scope or nature or the activities of 5 any business;

6 (c) To authorize the participation and contribution by the business 7 to any employee benefit plan, whether or not qualified as being tax 8 deductible, as may be desirable from time to time;

(e) To endorse or guarantee on behalf of the trust any loan made to the business and to secure the loan by the trust's interest in the business or any other property of the trust;

(f) To leave to the discretion of the trustee the manner and degree 15 16 of the trustee's active participation in the management of the 17 business, and the trustee is authorized to delegate all or any part of the trustee's power to supervise, manage, or operate to such persons as 18 the trustee may select, including any partner, associate, director, 19 officer, or employee of the business; and also including electing or 20 21 employing directors, officers, or employees of the trustee to take part 22 in the management of the business as directors or officers or 23 otherwise, and to pay that person reasonable compensation for services 24 without regard to the fees payable to the trustee;

(g) To engage, compensate, and discharge or to vote for the engaging, compensating, and discharging of managers, employees, agents, lawyers, accountants, consultants, or other representatives, including anyone who may be a beneficiary of the trust or any trustee;

(h) To cause or agree that surplus be accumulated or that dividendsbe paid;

(i) To accept as correct financial or other statements rendered by any accountant for any sole proprietorship or by any partnership or corporation as to matters pertaining to the business except upon actual notice to the contrary;

(j) To treat the business as an entity separate from the trust, and in any accounting by the trustee it is sufficient if the trustee reports the earning and condition of the business in a manner conforming to standard business accounting practice;

1 (k) To exercise with respect to the retention, continuance, or 2 disposition of any such business all the rights and powers that the 3 trustor of the trust would have if alive at the time of the exercise, 4 including all powers as are conferred on the trustee by law or as are 5 necessary to enable the trustee to administer the trust in accordance 6 with the instrument governing the trust, subject to any limitations 7 provided for in the instrument; and

8 (1) To satisfy contractual and tort liabilities arising out of an unincorporated business, including any partnership, first out of the 9 10 business and second out of the estate or trust, but in no event may there be a liability of the trustee, except as provided in RCW 11 12 11.98.110 (2) and (4), and if the trustee is liable, the trustee is 13 entitled to indemnification from the business and the trust, 14 respectively;

15 (22) Participate in the establishment of, and thereafter in the 16 operation of, any business or other enterprise according to subsection 17 (21) of this section except that the trustee shall not be relieved of 18 the duty to diversify;

19 (23) Cause or participate in, directly or indirectly, the 20 formation, reorganization, merger, consolidation, dissolution, or other 21 change in the form of any corporate or other business undertaking where 22 trust property may be affected and retain any property received 23 pursuant to the change;

(24) Limit participation in the management of any partnership andact as a limited or general partner;

(25) Charge profits and losses of any business operation, including farm or ranch operation, to the trust estate as a whole and not to the trustee; make available to or invest in any business or farm operation additional moneys from the trust estate or other sources;

30 (26) Pay reasonable compensation to the trustee or co-trustees 31 considering all circumstances including the time, effort, skill, and 32 responsibility involved in the performance of services by the trustee;

A party examined by an adverse party may be examined on his <u>or her</u> own behalf, in respect to any matter pertinent to the issue. If the requisite number of 23 signers is so certified, the board shall thereupon place the proposition: "Shall a county airport district be established in the 24 25 following area: (describing the proposed district)?, " upon the ballot 26 for vote of the people of the proposed district at the next election, 27 general or special. If a majority of the voters on such proposition shall vote in favor of the proposition, the board, shall, 28 by 29 resolution, declare the district established. If the requisite number of qualified persons have not signed the application, further 30 signatures may be added and certified until the requisite number have 31 32 signed and the above procedure shall be thereafter followed.

33 The area of such district may be the area of the county including 34 incorporated cities and towns, or such portion or portions thereof as 35 the board may determine to be the most feasible for establishing an

airport. When established, an airport district shall be a municipality 1 2 as defined in this chapter and entitled to all the powers conferred by this chapter and exercised by municipal corporations in this state. 3 4 The airport district is hereby empowered to levy not more than seventy-five cents per thousand dollars of assessed value of the 5 property lying within the said airport district: PROVIDED, HOWEVER, 6 7 Such levy shall not be made unless first approved at any election 8 called for the purpose of voting on such levy.

9 Sec. 5002. RCW 14.08.112 and 1983 c 167 s 16 are each amended to 10 read as follows:

11 (1) Municipalities, including any governmental subdivision which 12 may be hereafter authorized by law to own, control, and operate an 13 airport or other air navigation facility, are hereby authorized to 14 issue revenue bonds to provide part or all of the funds required to accomplish the powers granted them by chapter 14.08 RCW, and to 15 16 construct, acquire by purchase or condemnation, equip, add to, extend, 17 improve, replace and repair airports, facilities enlarge, and structures thereon including but not being limited to facilities for 18 the servicing of aircraft and for the comfort and accommodation of air 19 20 travelers, and other properties incidental to the operation of airports 21 and to pay all costs incidental thereto.

22 The legislative body of the municipality shall create a special fund for the sole purpose of paying the principal of and interest on 23 the bonds of each issue, into which fund the legislative body shall 24 25 obligate the municipality to pay an amount of the gross revenue derived 26 from its ownership, control, use, and operation of the airport and all 27 airport facilities and structures thereon and used and operated in connection therewith, including but not being limited to fees charged 28 29 for all uses of the airport and facilities, rentals derived from leases of part or all of the airport, buildings and any or all air navigation 30 31 facilities thereon, fees derived from concessions granted, and proceeds of sales of part or all of the airport and any or all buildings and 32 structures thereon or equipment therefor, sufficient to pay the 33 34 principal and interest as the same shall become due, and to maintain 35 adequate reserves therefor if necessary. Revenue bonds and the 36 interest thereon shall be payable only out of and shall be a valid

claim of the owner thereof only as against the special fund and the
 revenue pledged to it, and shall not constitute a general indebtedness
 of the municipality.

4 Each revenue bond and any interest coupon attached thereto shall name the fund from which it is payable and state upon its face that it 5 is only payable therefrom; however, all revenue bonds and any interest 6 coupons issued under RCW 14.08.112 and 14.08.114 shall be negotiable 7 8 instruments within the provisions and intent of the negotiable 9 instruments law of this state. Each issue of revenue bonds may be 10 bearer coupon bonds or may be registered either as to principal only or 11 as to principal and interest as provided in RCW 39.46.030; shall be in 12 the denomination or denominations the legislative body of the 13 municipality shall deem proper; shall be payable at the time or times and at the place or places as shall be determined by the legislative 14 15 body; shall bear interest at such rate or rates as authorized by the legislative body; shall be signed on behalf of the municipality by the 16 17 ((chairman)) chair of the county legislative authority, mayor of the 18 city or town, president of the port commission, and similar officer of 19 any other municipality, shall be attested by the county auditor, the clerk or comptroller of the city or town, the secretary of the port 20 21 commission, and similar officer of any other municipality, one of which 22 signatures may be a facsimile signature, and shall have the seal of the 23 municipality impressed thereon; any interest coupons attached thereto 24 shall be signed by the facsimile signatures of said officials. Revenue bonds shall be sold in the manner as the legislative body of the 25 26 municipality shall deem best, either at public or private sale.

27 The municipality at the time of the issuance of revenue bonds may 28 provide covenants as it may deem necessary to secure and guarantee the 29 payment of the principal thereof and interest thereon, including but 30 not being limited to covenants to create a reserve fund or account and to authorize the payment or deposit of certain moneys therein for the 31 32 purpose of securing or guaranteeing the payment of the principal and interest, to establish and maintain rates, charges, fees, rentals, and 33 sales prices sufficient to pay the principal and interest and to 34 35 maintain an adequate coverage over annual debt service, to appoint a 36 trustee for the bond owners and a trustee for the safeguarding and 37 disbursing of the proceeds of sale of the bonds and to fix the powers and duties of the trustee or trustees, and to make any and all other 38

covenants as the legislative body may deem necessary to its best 1 2 interest and that of its inhabitants to accomplish the most advantageous sale possible of the bonds. The legislative body may also 3 4 provide that revenue bonds payable out of the same source or sources may later be issued on a parity with revenue bonds being issued and 5 6 sold.

7 The legislative body of the municipality may include an amount for 8 working capital and an amount necessary for interest during the period of construction of the airport or any facilities plus six months, in 9 10 the principal amount of any revenue bond issue; if it deems it to the best interest of the municipality and its inhabitants, it may provide 11 12 in any contract for the construction or acquisition of an airport or 13 facilities that payment therefor shall be made only in revenue bonds at 14 the par value thereof.

15 If the municipality or any of its officers shall fail to carry out 16 any of its or their obligations, pledges or covenants made in the 17 authorization, issuance and sale of bonds, the owner of any bond or the 18 trustee may bring action against the municipality and/or said officers 19 to compel the performance of any or all of the covenants.

(2) Notwithstanding subsection (1) of this section, such bonds may
be issued and sold in accordance with chapter 39.46 RCW.

22 **Sec. 5003.** RCW 14.12.030 and 1945 c 174 s 3 are each amended to 23 read as follows:

(1) In order to prevent the creation or establishment of airport 24 25 hazards, every political subdivision having an airport hazard area within its territorial limits may adopt, administer, and enforce, under 26 27 the police power and in the manner and upon the conditions hereinafter prescribed, airport zoning regulations for such airport hazard area, 28 29 which regulations may divide such area into zones, and, within such zones, specify the land uses permitted and regulate and restrict the 30 31 height to which structures and trees may be erected or allowed to grow.

Each such joint board shall have as members two representatives appointed by each political subdivision participating 6 7 in its creation and in addition a ((chairman)) chair elected by a 8 majority of the members so appointed.

9 **Sec. 5004.** RCW 14.12.110 and 1945 c 174 s 7 are each amended to 10 read as follows:

11 (1) Permits. Any airport zoning regulations adopted under this chapter may require that a permit be obtained before any new structure 12 13 or use may be constructed or established and before any existing use or 14 structure may be substantially changed or substantially altered or In any event, however, all such regulations shall provide 15 repaired. 16 that before any nonconforming structure or tree may be replaced, substantially altered or repaired, rebuilt, allowed to grow higher, or 17 18 replanted, a permit must be secured from the administrative agency authorized to administer and enforce the regulations, authorizing such 19 20 replacement, change, or repair. Any person desiring to erect any structure, or increase the height of any structure, or permit the growth of any tree, 28 29 or otherwise use his or her property in violation of airport zoning regulations adopted under this chapter, may apply to the board of 30 31 adjustment for a variance from the zoning regulations in question. 32 Such variances shall be allowed where a literal application or enforcement of the regulations would result in practical difficulty or 33 34 unnecessary hardship and the relief granted would not be contrary to 35 the public interest but do substantial justice and be in accordance 36 with the spirit of the regulations and this chapter: PROVIDED, That

1 any variance may be allowed subject to any reasonable conditions that 2 the board of adjustment may deem necessary to effectuate the purposes 3 of this chapter.

4 (3) Hazard marking and lighting. In granting any permit or variance under this section, the administrative agency or board of 5 adjustment may, if it deems such action advisable to effectuate the 6 7 purposes of this chapter and reasonable in the circumstances, SO 8 condition such permit or variance as to require the owner of the structure or tree in question to permit the political subdivision, at 9 10 its own expense, to install, operate, and maintain thereon such markers and lights as may be necessary to indicate to flyers the presence of an 11 12 airport hazard.

13 Sec. 5005. RCW 14.12.140 and 1945 c 174 s 10 are each amended to 14 read as follows:

(1) All airport zoning regulations adopted under this chapter shall provide for a board of adjustment to have and exercise the following powers:

The ((chairman)) chair, 4 or in his or her absence the acting ((chairman)) chair, may administer 5 oaths and compel the attendance of witnesses. All hearings of the б 7 board shall be public. The board shall keep minutes of its 8 proceedings, showing the vote of each member upon each question, or, if absent or failing to vote, indicating such fact, and shall keep records 9 10 of its examinations and other official actions, all of which shall immediately be filed in the office of the board and shall be a public 11 12 record.

13 Sec. 5006. RCW 14.16.010 and 1984 c 7 s 8 are each amended to read 14 as follows:

15 In this chapter "aircraft" means any contrivance now known or 16 hereafter invented, used, or designed for navigation of or flight in 17 the air, except a parachute or other contrivance designed for such navigation but used primarily as safety equipment. The term "airman" 18 or "airwoman" means any individual (including the person in command and 19 20 any pilot, mechanic, or member of the crew) who engages in the 21 navigation of aircraft while under way and any individual who is in 22 charge of the inspection, overhauling, or repairing of aircraft. 23 "Operating aircraft" means performing the services of aircraft pilot. 24 "Person" means any individual, proprietorship, partnership, 25 corporation, or trust. "Downed aircraft rescue transmitter" means a 26 transmitter of a type approved by the state department of transportation or the federal aviation administration with sufficient 27 transmission power and reliability that it will be automatically 28 29 activated upon the crash of an aircraft so as to transmit a signal on a preset frequency so that it will be effective to assist in the 30 location of the downed aircraft. "Air school" means air school as 31 32 defined in RCW 47.68.020(11).

33 **Sec. 5007.** RCW 14.16.030 and 1929 c 157 s 3 are each amended to 34 read as follows:

The public safety requiring and the advantages of uniform regulation making it desirable in the interest of aeronautical progress

that a person serving as an airman or airwoman within this state should 1 2 have the qualifications necessary for obtaining and holding the class 3 of license required by the United States government with respect to such an airman or airwoman subject to its jurisdiction, it shall be 4 5 unlawful for any person to serve as an airman or airwoman within this state unless he ((have)) or she has such a license: PROVIDED, HOWEVER, б 7 That for the first thirty days after entrance into this state this 8 section shall not apply to nonresidents of this state operating aircraft within this state, other than aircraft carrying persons or 9 10 property for hire, if such person shall have fully complied with the laws of the state, territory or foreign country of his or her residence 11 12 respecting the licensing of airmen or airwomen.

13 sec. 5008. RCW 14.16.040 and 1929 c 157 s 4 are each amended to 14 read as follows:

The certificate of the license herein required shall be kept in the personal possession of the licensee when he <u>or she</u> is serving as an airman <u>or airwoman</u> within this state, and must be presented for inspection upon the demand of any passenger, any peace officer of this state, or any official, manager, or person in charge of any airport or landing field in this state upon which he <u>or she</u> shall land.

21 **Sec. 5009.** RCW 14.20.030 and 1984 c 7 s 11 are each amended to 22 read as follows:

Before issuing an aircraft dealer license, the secretary shall 16 require the applicant to file with the secretary a surety bond in the 17 amount of twenty-five thousand dollars running to the state, and 18 19 executed by a surety company authorized to do business in the state. 20 The bond shall be approved by the attorney general as to form and 21 conditioned that the dealer shall conduct his or her business in 22 conformity with the provisions of this chapter, RCW 47.68.250, and 82.48.100. Any person who has suffered any loss or damage by reason of 23 24 any act by a dealer which constitutes ground for refusal, suspension, 25 or revocation of license under RCW 14.20.090 has a right of action against the aircraft dealer and the surety upon the bond. Successive 26 27 recoveries against the bond shall be permitted, but the aggregate 28 liability of the surety to all persons shall in no event exceed the 29 amount of the bond.

30 **Sec. 5012.** RCW 14.20.090 and 1984 c 7 s 16 are each amended to 31 read as follows:

The secretary shall refuse to issue an aircraft dealer's license or shall suspend or revoke an aircraft dealer's license whenever he <u>or she</u> has reasonable grounds to believe that the dealer has:

(1) Forged or altered any federal certificate, permit, rating, or
 license relating to ownership and airworthiness of an aircraft;

3 (2) Sold or disposed of an aircraft which he <u>or she</u> knows or has 4 reason to know has been stolen or appropriated without the consent of 5 the owner;

6 (3) Wilfully misrepresented any material fact in the application
7 for an aircraft dealer's license, aircraft dealer's certificate, or
8 registration certificate;

9 (4) Wilfully withheld or caused to be withheld from a purchaser of 10 an aircraft any document referred to in subsection (1) of this section 11 if applicable, or an affidavit to the effect that there are no liens, 12 mortgages, or encumbrances of any type on the aircraft other than noted 13 thereon, if the document or affidavit has been requested by the 14 purchaser;

(7) Been adjudged guilty of a crime that directly relates to the 19 business of an aircraft dealer and the time elapsed since the 20 21 conviction is less than ten years, or had a judgment entered against 22 the dealer within the preceding five years in any civil action involving fraud, misrepresentation, or conversion. For the purpose of 23 24 this section, the term "adjudged guilty" means, in addition to a final 25 conviction in either a state or municipal court, an unvacated 26 forfeiture of bail or collateral deposited to secure a defendant's 27 appearance in court, the payment of a fine, a plea of guilty, or a 28 finding of guilt regardless of whether the imposition of the sentence 29 is deferred or the penalty is suspended.

If the secretary issues an order that any person is not entitled to an aircraft dealer's license or that an existing license should be suspended or revoked, he <u>or she</u> shall forthwith notify the applicant or dealer in writing. The applicant has thirty days from the date of the

secretary's order to appeal therefrom to the superior court of Thurston county, which he <u>or she</u> may do by filing a notice of the appeal with the clerk of the superior court and at the same time filing a copy of the notice with the secretary.

The director of the state department of agriculture may control 18 19 birds which he or she determines to be injurious to agriculture, and 20 for this purpose enter into written agreements with the federal and state governments, political subdivisions and agencies of 21 such 22 governments, political subdivisions and agencies of this state 23 including counties, municipal corporations and associations and 24 individuals, when such cooperation will implement the control of 25 predatory birds injurious to agriculture.

26 **Sec. 6004.** RCW 15.04.160 and 1975 1st ex.s. c 238 s 2 are each 27 amended to read as follows:

(1) An employee engaged to pick berries in this state outside of 28 29 school hours for the school district where such employee is living while so employed may be less than twelve years of age: PROVIDED, That 30 31 (a) the employee is employed with the consent of his or her parent or person standing in the place of his or her parent, (b) the berries are 32 33 for sale within the state only, and are not to be shipped out of the 34 state in any form; (c) the secretary of agriculture or his or her 35 designated representative has certified that there are not sufficient

workers available in the immediate area to harvest the crop without such youthful employees, and (d) all employees of any employer engaging youthful employees are paid at the same rate for picking berries.

33 (5) "Nuisance" means any plant, produce or property found in any 34 commercial area upon which is found any pest or disease that is or may 35 be a source of infestation of other properties.

36 (6) "Commercial area" means a district where any horticultural

product is being produced to the extent that a producer is dependent thereon, in whole or in part, for his <u>or her</u> livelihood.

3 (7) "Infect," and its derivatives "infected," "infecting," and 4 "infection," means affected by or infested with pests or diseases as 5 above defined.

6 (8) "Disinfect," and its derivatives, means the control, cure, or
7 eradication of such pests or diseases by cutting or destroying infected
8 parts or the application of effective pesticides.

9 Sec. 6006. RCW 15.08.040 and 1961 c 11 s 15.08.040 are each 10 amended to read as follows:

11 The director, supervisor, and horticultural inspectors are 12 authorized to at any time enter horticultural premises and any 13 structure where fruit, vegetables, nursery stock, or horticultural 14 products are grown or situated for any purpose, to inspect the same for 15 infection.

16 No person shall hinder or interfere with any such officer in 17 entering or inspecting or performing any duty imposed upon him <u>or her</u>.

18 Sec. 6007. RCW 15.08.080 and 1961 c 11 s 15.08.080 are each 19 amended to read as follows:

20 Personal service of said notice shall be made upon the person in possession or in charge of said premises or property if possible. 21 Ιf 22 such person is not the owner, or personal service cannot be made on 23 such person, then a copy of the notice shall be mailed or telegraphed 24 to the owner at his or her home or post office address if known or can 25 with reasonable diligence be ascertained. In case of their failure so to do, the inspector may enter the premises and б 7 perform or cause to be performed the services required in the notice. 8 He or she shall keep an accurate account of the expense of performing said services, which shall become a lien on the premises or property 9 10 which may be foreclosed in the manner herein provided. The lien on personal property shall have preference over all other liens. 11

12 If the inspector has not disinfected or destroyed the property it 13 may be declared a nuisance as herein provided and treated as such.

14 **Sec. 6009.** RCW 15.08.100 and 1961 c 11 s 15.08.100 are each 15 amended to read as follows:

16 The officer disinfecting personal property may enforce the lien 17 thereon provided for in RCW 15.08.090 by impounding and selling the property. 17 The county auditor shall forthwith issue warrants in payment of the labor employed in the work, and thereupon the county shall be 18 subrogated to all rights of the laborers so paid. He or she shall fix 19 20 the day for hearing on the record before the county commissioners, 21 which shall be not less than twenty days from the date of filing. Whenever the director determines that a particular pest cannot be eradicated or effectively controlled by ordinary means, or that it is impractical to eradicate or control it without the destruction in whole or in part of uninfected host plants, he <u>or she</u> may issue a proclamation setting out the host-free period or host-free district, or both, describing the host plant and the district wherein planting, growing, cultivating, or maintenance in any manner of any plants or

1 products capable of continuing the particular pests is prohibited 2 during a specified period of time and until the menace therefrom no 3 longer exists.

4 **Sec. 6017.** RCW 15.09.040 and 1969 c 113 s 4 are each amended to 5 read as follows:

6 Within thirty days after the appointed seats on the horticultural 7 pest and disease board have been filled, the board shall conduct its 8 first meeting. A majority of the voting members of the board shall 9 constitute a quorum for the transaction of business and shall be 10 necessary for any action taken by the board. 33 **Sec. 6019.** RCW 15.09.080 and 1991 c 257 s 1 are each amended to 34 read as follows:

35 (1) Whenever the horticultural pest and disease control board finds

that an owner of land has failed to control and prevent the spread of horticultural pests and diseases on his <u>or her</u> land, as is his <u>or her</u> duty under RCW 15.09.060, it shall provide such person with written notice, which notice shall identify the pests and diseases found to be present and shall order prompt control or disinfection action to be taken within a specified and reasonable time period.

7 (2) If the person to whom the notice is directed fails to take 8 action in accordance with this notice, then the board shall perform or cause to be performed such measures as are necessary to control and 9 10 prevent the spread of the pests and diseases on such property and the expense of this work shall be charged to such person. (3) In the event the owner of land fails to control and prevent the 15 spread of horticultural pests and diseases as required by RCW 16 17 15.09.060, and the county horticultural pest and disease board 18 determines that actions it has taken to control and prevent the spread 19 of such pests or diseases has not been effective or the county horticultural pest and disease board determines that no reasonable 20 21 measures other than removal of the plants will control and prevent the spread of such pests or diseases, the county horticultural pest and 22 23 disease board may petition the superior court of the county in which 24 the property is situated for an order directing the owner to show cause why the plants should not be removed at the owner's expense and for an 25 26 order authorizing removal of said infected plants. The petition shall state: (a) The legal description of the property on which the plants 27 28 are located; (b) the name and place of residence, if known, of the 29 owners of said property; (c) that the county horticultural pest and 30 disease board has, through its officers or agents, inspected said property and that the plants thereon, or some of them, are infested 31 32 with a horticultural pest or disease as defined by RCW 15.08.010; (d) the dates of all notices and orders delivered to the owners pursuant to 33 this section; (e) that the owner has failed to control and prevent the 34 35 spread of said horticultural pest or disease; and (f) that the county 36 horticultural pest and disease board has determined that the measures 37 taken by it have not controlled or prevented the spread of the pest or disease or that no reasonable measure can be taken that will control 38

and prevent the spread of such pest or disease except removal of the 1 2 plants. The petition shall request an order directing the owner to appear and show cause why the plants on said property shall not be 3 removed at the expense of the owner, to be collected as provided in 4 5 this chapter. The order to show cause shall direct the owner to appear on a date certain and show cause, if any, why the plants on the 6 7 property described in the petition should not be removed at the owner's 8 The order to show cause and petition shall be served on the expense. owner not less than five days before the hearing date specified in the 9 10 order in the same manner as a summons and complaint. In the event the owner fails to appear or fails to show by competent evidence that the 11 12 horticultural pest or disease has been controlled, then the court shall 13 authorize the county horticultural pest and disease board to remove the plants at the owner's expense, to be collected as provided by this 14 chapter. If the procedure provided herein is followed, no action for 15 damages for removal of the plants shall lie against the county 16 17 horticultural pest and disease board, its officers or agents, or the 18 county in which it is situated.

19 Sec. 6020. RCW 15.09.100 and 1969 c 113 s 10 are each amended to 20 read as follows:

21 Any amount charged to the owner of land in accordance with the 22 provisions of RCW 15.09.080 and 15.09.090 shall be paid by such owner within sixty days of the date in which he or she was billed for such 23 24 amount. If payment is not made within such sixty day period, the 25 amount of such charge, together with a ten percent penalty surcharge, 26 shall, for purposes of collection, become a tax lien under RCW 27 84.60.010, as now or hereafter amended, and shall be promptly collected as such by the county treasurer: PROVIDED, That where good cause is 28 29 shown the board may extend for an additional two months the time period 30 during which payment shall be made.

Each dealer, handler, and processor shall at such times as the commission may by rule or regulation require, file with the commission a return under oath on forms to be furnished by the commission, stating the quantity of apples handled, shipped, or processed by him <u>or her</u> during the period prescribed by the commission. The return shall contain such further information as the commission may require.

12 **Sec. 6023.** RCW 15.24.150 and 1961 c 11 s 15.24.150 are each 13 amended to read as follows:

The commission shall appoint a treasurer who shall file with it a fidelity bond executed by a surety company authorized to do business in this state, in favor of the commission and the state, in the penal sum of fifty thousand dollars, conditioned upon the faithful performance of his or her duties and strict accounting of all funds of the commission.

All money received by the commission, or any other state official from the assessment herein levied, shall be paid to the treasurer, deposited in such banks as the commission may designate, and disbursed by order of the commission. None of the provisions of RCW 43.01.050 shall apply to money collected under this chapter.

The superior courts are hereby vested with jurisdiction to enforce the provisions of this chapter and the rules and regulations of the commission issued hereunder, and to prevent and restrain violations thereof.

As used in this chapter, unless a different meaning is plainly 4 required by the context:

20 There is hereby created the Washington tree fruit research commission, to be thus known and designated. The commission shall be 21 composed of nine members. Three members to be appointed by the 22 Washington state fruit commission, five members to be appointed by the 23 24 <u>Washington</u> apple ((advertising)) commission, and one member 25 representing the winter pear industry to be appointed by the director. 26 The director or his or her duly authorized representative shall be ex 27 officio member with a vote, to represent all assessed commodities.  leadership programs as the commission deems appropriate; and

(16) Work cooperatively with nonprofit and other organizations tocarry out the purposes of this chapter.

30 Sec. 6060. RCW 15.44.090 and 1979 ex.s. c 238 s 7 are each amended 31 to read as follows:

All assessments shall be collected by the first dealer and deducted from the amount due the producer, and all moneys so collected shall be paid to the treasurer of the commission on or before the twentieth day of the succeeding month for the previous month's collections, and deposited by him <u>or her</u> in banks designated by the commission to the credit of the commission fund. If a dealer or a producer who acts as

Any marketing agreement or order may contain provisions prohibiting 13 14 and/or otherwise regulating any one or more or all of the practices listed to the extent that such practices affect, directly or 15 indirectly, the commodity which forms the subject matter of such 16 agreement or order or any product thereof, but only with respect to 17 persons who engage in such practices with the intent of or with the 18 reasonably foreseeable effect of inducing any purchaser to become his 19 20 or her customer or his or her supplier or of otherwise dealing or 21 trading with him or her or of diverting trade from a competitor, to 22 wit:

23

(1) Paying rebates, commissions, or unearned discounts;

(2) Giving away or selling below the true cost (which includes all direct and indirect costs incurred to the point of sale plus a reasonable margin of mark-up for the seller) any of the affected commodities or of any other commodity or product thereof;

(3) Unfairly extending privileges or benefits (pertaining to price, to credit, to the loan, lease or giving away of facilities, equipment or other property or to any other matter or thing) to any customer, supplier, or other person;

(4) Discriminating between customers, or suppliers of like class;
(5) Using the affected or any other commodity or product thereof as
a loss leader or using any other device whereby for advertising,
promotional, come-on or other purposes such commodity or product is
sold below its fair value;

(6) Making or publishing false or misleading advertising. 1 Such 2 regulation may authorize uniform trade practices applicable to all similarly situated handlers and/or other persons. 3 Such regulation 4 shall not prevent any person (a) from selling below cost to liquidate excess inventory which cannot otherwise be moved, or (b) from meeting 5 б the equally low legal price of any competitor within any one trading 7 area during any one trading period and the director may define in said 8 marketing agreement or order said trading area and said trading period 9 in accordance with generally accepted industry practices; but in any 10 event the burden of proving that such selling was to meet the equally 11 low legal price of a competitor or to liquidate said excess inventory 12 shall be upon the person who sells below cost as above defined. Any 13 marketing agreement or order may authorize use of any money received and of any persons employed thereunder for legal proceedings, of any 14 15 type and in the name of any person, directed to enforcement of this or 16 any other law in force in the state of Washington relating to the prevention of unfair trade practices. 17

18 Sec. 6080. RCW 15.65.390 and 1987 c 393 s 9 are each amended to 19 read as follows:

20 There is hereby levied, and the director or his or her designee 21 shall collect, upon each and every affected unit of any agricultural 22 commodity specified in any marketing agreement or order an annual 23 assessment which shall be paid by the producer thereof upon each and every such affected unit stored in frozen condition or sold or marketed 24 25 or delivered for sale or marketed by him or her, and which shall be 26 paid by the handler thereof upon each and every such unit purchased or received for sale, processing or distribution, or stored in frozen 27 condition, by him or her: PROVIDED, That such assessment shall be paid 28 29 by producers only, if only producers are regulated by such agreement or order, and by handlers only, if only handlers are so regulated, and by 30 both producers and handlers if both are so regulated. 1 frozen condition or sold or marketed or delivered for sale or marketing 2 by all producers of such units during the year to which the assessment 3 applies.

4 **Sec. 6081.** RCW 15.65.400 and 1987 c 393 s 10 are each amended to 5 read as follows:

б In every marketing agreement and order the director shall prescribe 7 the rate of such assessment. Such assessment shall be expressed as a stated amount of money per unit or as a percentage of the receipt price 8 9 at the first point of sale. Such rate may be at the full amount of, or at any lesser amount than the amount hereinabove limited. 10 Such rate 11 may be altered or amended from time to time, but only upon compliance 12 with the procedural requirements of this chapter. 21 The legislature recognizes that there exists a great risk of potential damage from oil pollution of the waters of the state of 22 23 Washington and further declares that immediate steps must be undertaken 24 to reduce this risk. The legislature also is aware that such danger is 25 expected to increase in future years in proportion to the increase in 26 the size and cargo capacity of ships, barges, and other waterborne carriers, the construction and operational characteristics of these 27 28 carriers, the density of waterborne traffic, and the need for a greater 29 supply of petroleum products.

A program of systematic baseline studies to be conducted by the department of ecology has been recognized as a vital part of the efforts to reduce the risk of oil pollution of marine waters, and the legislature recognizes that many factors combine to make this effort one of considerable magnitude and difficulty. The marine shoreline of the state is about two thousand seven hundred miles long, a greater length than the combined coastlines of Oregon and California. There are some three million acres of submerged land and more than three hundred islands in these marine waters. The average depth of Puget Sound is two hundred twenty feet. There is a great diversity of animal life in the waters of the state. These waters have a multitude of uses by both humans and nonhumans, and the interaction between ((man's)) <u>human</u> activities and natural processes in these waters varies greatly with locale.

8 **Sec. 7002.** RCW 43.21C.030 and 1971 ex.s. c 109 s 3 are each 9 amended to read as follows:

Copies of such statement and the б 7 comments and views of the appropriate federal, province, state, and 8 agencies, which are authorized to develop and enforce local environmental standards, shall be made available to the governor, the 9 10 department of ecology, the ecological commission, and the public, and shall accompany the proposal through the existing agency review 11 12 processes;

13 (e) Study, develop, and describe appropriate alternatives to 14 recommended courses of action in any proposal which involves unresolved 15 conflicts concerning alternative uses of available resources;

(f) Recognize the worldwide and long-range character of environmental problems and, where consistent with state policy, lend appropriate support to initiatives, resolutions, and programs designed to maximize international cooperation in anticipating and preventing a decline in the quality of ((mankind's)) the world environment;

(g) Make available to the federal government, other states, provinces of Canada, municipalities, institutions, and individuals, advice and information useful in restoring, maintaining, and enhancing the quality of the environment;

(h) Initiate and utilize ecological information in the planning anddevelopment of natural resource-oriented projects.

## PART VIII

28 Sec. 8001. RCW 44.39.060 and 2009 c 549 s 6016 are each amended to 29 read as follows:

In the discharge of any duty imposed by this chapter, the committee or any personnel acting under its direction shall have the authority to examine and inspect all properties, equipment, facilities, files, records, and accounts of any state office, department, institution, board, committee, commission, or agency; to administer oaths; and to issue subpoenas, upon approval of a majority of the members of the house or senate rules committee, to compel the attendance of witnesses

(b) Three representatives of the nonsnowmobiling public, appointedby the commission; and

(c) One representative of the department of natural resources, one representative of the department of fish and wildlife, and one representative of the Washington state association of counties; each of whom shall be appointed by the director of such department or association.

26 (4) Terms of the members appointed under subsection (3)(a) and (b) of this section shall commence on October 1st of the year 27 of appointment and shall be for three years or until a successor is 28 29 appointed, except in the case of appointments to fill vacancies which shall be for the remainder of the unexpired term: PROVIDED, That the 30 31 first such members shall be appointed for terms as follows: Three 32 members shall be appointed for one year, three members shall be 33 appointed for two years, and three members shall be appointed for three 34 years.

35 (7) It is a traffic infraction for any person to perform false or 36 improvised repairs, or repairs in any manner not in accordance with 37 acceptable and customary repair practices, upon a motor vehicle.

No person, firm, or corporation shall sell or offer for sale any 27 regrooved tire or shall regroove any tire for use on the public 28 highways of this state which does not meet the standard established by 29 30 federal motor vehicle standard part 569--regrooved tires, as promulgated by the United States department of transportation under 31 authority of the National Traffic and Motor Vehicle Safety Act of 1966 32 33 (80 Stat. 719, 728; 15 U.S.C. 1392, 1407).

If it is determined at the hearing that 5 the vehicle was placed on the land without the consent of the landowner б 7 and that he or she has not subsequently acquiesced in its presence, 8 then the local agency shall not assess costs of administration or 9 removal of the vehicle against the property upon which the vehicle is 10 located or otherwise attempt to collect the cost from the owner;

31 (4) The foregoing provisions shall not relieve the driver of an 32 authorized emergency vehicle from the duty to drive with due regard for 33 the safety of all persons, nor shall such provisions protect the driver 34 from the consequences of his <u>or her</u> reckless disregard for the safety 35 of others. 1 Sec. 9067. Upon the entry of the order under RCW 46.70.101 the director shall promptly notify the applicant or licensee that the order has been entered and of the reasons therefor and that if requested by the applicant or licensee within fifteen days after the receipt of the director's notification, the matter will be promptly set down for hearing pursuant to chapter 34.05 RCW. If no hearing is requested and

none is ordered by the director, the order will remain in effect until 1 2 it is modified or vacated by the director. If a hearing is requested or ordered, the director, or his or her personal representative, after 3 notice of and opportunity for hearing, may modify or vacate the order, 4 5 or extend it until final determination. No final order may be entered under RCW 46.70.101 denying or revoking a license without appropriate 6 7 prior notice to the applicant or licensee, opportunity for hearing, and written findings of fact and conclusions of law. 8

9 Sec. 9084. RCW 46.70.111 and 1967 ex.s. c 74 s 15 are each amended 10 to read as follows:

For the purpose of any investigation or proceeding under this chapter, the director or any officer designated by him <u>or her</u> may administer oaths and affirmations, subpoena witnesses, compel their attendance, take evidence, and require the production of any books, papers, correspondence, memoranda, agreements, or other documents or records which the director deems relevant or material to the inquiry.

(1) In case of contumacy by, or refusal to obey a subpoena issued to, any person, any court of competent jurisdiction, upon application by the director, may issue to that person an order requiring him <u>or her</u> to appear before the director, or the officer designated by him <u>or her</u>, to produce documentary or other evidence touching the matter under investigation or in question. The failure to obey an order of the court may be punishable by contempt.

(3) The dispute shall be referred for arbitration to such 7 8 arbitrator as may be agreed upon by the parties to the dispute. If the parties cannot agree upon a single arbitrator within thirty days from 9 10 the date the protest is filed, the protesting dealer will select an arbitrator, the manufacturer will select an arbitrator, and the two 11 12 arbitrators will then select a third. If a third arbitrator is not 13 agreed upon within thirty days, any party may apply to the superior court, and the judge of the superior court having jurisdiction will 14 appoint the third arbitrator. The protesting dealer will pay the 15 arbitrator selected by him or her, and the manufacturer will pay the 16 arbitrator it selected. The expense of the third arbitrator and all 17 18 other expenses of arbitration will be shared equally by the parties. 19 Attorneys' fees and fees paid to expert witnesses are not expenses of 20 arbitration and will be paid by the person incurring them.

21 (4) Notwithstanding the terms of a franchise or written statement 22 of the manufacturer and notwithstanding the terms of a waiver, the 23 arbitration will take place in the state of Washington in the county 24 where the protesting dealer has his or her principal place of business. 25 RCW 46.96.160 applies to a determination made by the arbitrator or 26 arbitrators in determining whether good cause exists for permitting the 27 proposed establishment or relocation of a new motor vehicle dealer, and the manufacturer has the burden of proof to establish that good cause 28 29 exists for permitting the proposed establishment or relocation. After 30 a hearing has been held, the arbitrator or arbitrators shall render a decision as expeditiously as possible, but in any event not later than 31 32 one hundred twenty days from the date the arbitrator or arbitrators are selected or appointed. The manufacturer shall not establish or 33 relocate the new motor vehicle dealer until the arbitration hearing has 34 35 been held and the arbitrator or arbitrators have determined that there 36 is good cause for permitting the proposed establishment or relocation. 37 The written decision of the arbitrator is binding upon the parties

unless modified, corrected, or vacated under the Washington Arbitration
 Act. Any party may appeal the decision of the arbitrator under the
 Uniform Arbitration Act, chapter 7.04A RCW.

4 (5) If the franchise agreement or the manufacturer's written statement distributed and provided to its dealers does not provide for 5 arbitration under the Uniform Arbitration Act as a mechanism for б resolving disputes relating to the establishment of an additional new 7 8 motor vehicle dealer or the relocation of a new motor vehicle dealer, then the hearing provisions of this section and RCW 46.96.170 apply. 9 10 Nothing in this section is intended to preclude a new motor vehicle dealer from electing to use any other dispute resolution mechanism 11 12 offered by a manufacturer.

27 Increased construction costs for highway and bridge construction since the enactment of a highway bond issue by the 1951 legislature 28 29 makes necessary additional money with which to complete the sections of 30 primary state highway No. 1 planned from funds allocated under RCW 47.10.010 through 47.10.140 and it is vital to the economy of the state 31 32 and the safety of the traffic that these sections shall be completed to 33 relieve traffic congestions, to add capacity in event of war, and to 34 presently insure greater safety to highway users; the rapid increase of 35 traffic across Snoqualmie Pass necessitates continued improvement of

primary state highway No. 2 to provide four-lane paving contiguous to 1 2 Snoqualmie Pass as the funds will permit; the rapid increase of traffic and the facilitation of movement of military forces and equipment from 3 4 the military centers of the state makes imperative the construction of a highway from primary state highway No. 2 beginning approximately four 5 miles west of North Bend thence southwesterly by the most feasible 6 7 route by the way of Auburn to a junction with primary state highway No. 8 1 in the vicinity of Milton; said highway to follow approximately the route surveyed by the director of highways and covered in the report 9 10 filed by him or her with the 1951 legislature commonly known as the "Echo Lake Route," as the funds provided for herein will permit; the 11 12 construction of secondary state highways in to the Columbia Basin area 13 is immediately necessary to provide needed state arterial highways for the irrigated lands of the Columbia Basin areas to market centers and 14 thereby encourage the full development of the basin project. 15 The construction of such projects is required in the interest of the public 16 17 safety and for the orderly development of the state. The threat of war 18 makes acceleration of construction a vital necessity at this time.

19 Sec. 10003. RCW 47.12.023 and 1984 c 7 s 115 are each amended to 20 read as follows:

21 (1) Except as provided in RCW 47.12.026 and 47.12.029, whenever it 22 is necessary to secure any lands or interests in lands for any highway 23 purpose mentioned in RCW 47.12.010, or for the construction of any toll 24 facility or ferry terminal or docking facility, the title to which is 25 in the state of Washington and under the jurisdiction of the department of natural resources, the department of transportation may acquire 26 27 jurisdiction over the lands or interests in lands, or acquire rights to 28 remove materials from the lands in the manner set forth in this 29 section.

30 (2) At any time after the final adoption of a right-of-way plan or 31 other plan requiring the acquisition of lands or interests in lands for 32 any purpose as authorized in subsection (1) of this section, the 33 department of transportation may file with the department of natural 34 resources a notice setting forth its intent to acquire jurisdiction of 35 the lands or interests in lands under the jurisdiction of the 36 department of natural resources required for right-of-way or other highway purposes related to the construction or improvement of such
 state highway, toll facility, or ferry terminal or docking facility.

(3) The department of transportation at the time of filing its 3 notice of intent as provided in subsection (2) of this section shall 4 file therewith a written statement showing the total amount of just 5 compensation to be paid for the property in the event of settlement. б 7 The offer shall be based upon the department of transportation approved 8 appraisal of the fair market value of the property to be acquired. In 9 no event may the offer of settlement be referred to or used during any arbitration proceeding or trial conducted for the 10 purpose of 11 determining the amount of just compensation.

12 (4) Just compensation and/or fair market value for the purposes of 13 this section shall be determined in accordance with applicable federal 14 and state constitutional, statutory, and case law relating to the 15 condemnation of private and public property for public purposes.

16 (5) If the department of natural resources does not accept the 17 offer of the department of transportation, the department of 18 transportation may nonetheless pay to the department of natural 19 resources the amount of its offer and obtain immediate possession and 20 use of the property pending the determination of just compensation in 21 the manner hereinafter provided.

22 (6) If the amount of just compensation is not agreed to, either the 23 department of natural resources or the department of transportation may request in writing the appointment of an arbitrator for the purpose of 24 25 determining the amount of compensation to be paid by the department of 26 transportation for the acquisition of jurisdiction over the lands or 27 interests in lands or rights therein. In that event the department of 28 natural resources and the department of transportation may jointly 29 agree on an arbitrator to determine the compensation, and his or her 30 determination shall be final and conclusive upon both departments. The costs of the arbitrator shall be borne equally by the parties. 31 If the 32 department of natural resources and the department of transportation are unable to agree on the selection of an arbitrator within thirty 33 days after a request therefor is made, either the department of 34 35 transportation or the department of natural resources may file a 36 petition with the superior court for Thurston county for the purpose of 37 determining the amount of just compensation to be paid. The matter

shall be tried by the court pursuant to the procedures set forth in RCW
 8.04.080.

3 (7) Whenever the department of transportation has acquired immediate possession and use of property by payment of the amount of 4 its offer to the department of natural resources, and the arbitration 5 award or judgment of the court for the acquisition exceeds the payment б 7 for immediate possession and use, the department of transportation 8 shall forthwith pay the amount of such excess to the department of natural resources with interest thereon from the date it obtained 9 immediate possession. If the arbitration or court award is less than 10 the amount previously paid by the department of transportation for 11 12 immediate possession and use, the department of natural resources shall 13 forthwith pay the amount of the difference to the department of 14 transportation.

(8) Upon the payment of just compensation, as agreed to by the 15 department of transportation and the department of natural resources, 16 17 or as determined by arbitration or by judgment of the court, and other costs or fees as provided by statute, the department of natural 18 resources shall cause to be executed and delivered to the department of 19 transportation an instrument transferring jurisdiction over the lands 20 21 or interests in lands, or rights to remove material from the lands, to 22 the department of transportation.

(9) Except as provided in RCW 47.12.026, whenever the department of 23 24 transportation ceases to use any lands or interests in lands acquired 25 in the manner set forth in this section for the purposes mentioned 26 herein, the department of natural resources may reacquire jurisdiction 27 over the lands or interests in land by paying the fair market value thereof to the department of transportation. If the two departments 28 are unable to agree on the fair market value of the lands or interests 29 in lands, the market value shall be determined and the interests 30 therein shall be transferred in accordance with the provisions and 31 32 procedures set forth in subsections (4) through (8) of this section.

33 **Sec. 10004.** RCW 47.12.160 and 1984 c 7 s 122 are each amended to 34 read as follows:

Whenever a part of a parcel of land is to be acquired for state highway purposes and the remainder lying outside of the right-of-way is to be left in such shape or condition as to be of little value to its

owner or to give rise to claims or litigation concerning severance or 1 2 other damage, and its value does not exceed the probable amount of the severance claims or damages, the department may acquire by gift, 3 purchase, or condemnation the whole parcel and may sell that portion 4 5 lying outside of the highway right-of-way or may exchange the same for other property needed for highway purposes. The provisions of this 6 7 section do not apply if the taking of that portion of the land lying 8 outside of the highway right-of-way would deprive any adjacent owner of 9 an existing right of ingress and egress to his or her property.

10 **Sec. 10005.** RCW 47.12.230 and 1969 ex.s. c 197 s 5 are each 11 amended to read as follows:

12 Warrants issued for payment of property and engineering costs as 13 provided herein shall be of a distinctive design and shall contain the words "for purchase by the state finance committee from . . . . fund" 14 (indicating the proper investing fund as provided by the agreement). 15 16 Such warrants shall be approved by the secretary of the state finance 17 committee prior to their issuance by the state treasurer. Upon presentation of such warrants to the state treasurer for payment, he or 18 she shall pay the par value thereof from the fund for which the state 19 20 finance committee agreed to purchase such warrants whether or not there 21 are then funds in the motor vehicle fund. The state treasurer shall 22 deposit such warrants in the treasury for the investing fund.

23 Sec. 10006. RCW 47.12.283 and 1979 ex.s. c 189 s 1 are each 24 amended to read as follows:

(1) Whenever the department of transportation determines that any real property owned by the state of Washington and under the jurisdiction of the department is no longer required for highway purposes and that it is in the public interest to do so, the department may, in its discretion, sell the property under RCW 47.12.063 or under subsections (2) through (6) of this section.

(2) Whenever the department determines to sell real property under its jurisdiction at public auction, the department shall first give notice thereof by publication on the same day of the week for two consecutive weeks, with the first publication at least two weeks prior to the date of the auction, in a legal newspaper of general circulation in the area where the property to be sold is located. The notice shall

be placed in both the legal notices section and the real estate classified section of the newspaper. The notice shall contain a description of the property, the time and place of the auction, and the terms of the sale. The sale may be for cash or by real estate contract.

6 (3) The department shall sell the property at the public auction, 7 in accordance with the terms set forth in the notice, to the highest 8 and best bidder providing the bid is equal to or higher than the 9 appraised fair market value of the property.

10 (4) If no bids are received at the auction or if all bids are rejected, the department may, in its discretion, 11 enter into 12 negotiations for the sale of the property or may list the property with 13 a licensed real estate broker. No property shall be sold by 14 negotiations or through a broker for less than the property's appraised fair market value. Any offer to purchase real property pursuant to 15 this subsection shall be in writing and may be rejected at any time 16 17 prior to written acceptance by the department.

18 (5) Before the department shall approve any offer for the purchase of real property having an appraised value of more than ten thousand 19 dollars, pursuant to subsection (4) of this section, the department 20 21 shall first publish a notice of the proposed sale in a local newspaper 22 of general circulation in the area where the property is located. The 23 notice shall include a description of the property, the selling price, 24 the terms of the sale, including the price and interest rate if sold by 25 real estate contract, and the name and address of the department 26 employee or the real estate broker handling the transaction. The 27 notice shall further state that any person may, within ten days after the publication of the notice, deliver to the designated state employee 28 29 or real estate broker a written offer to purchase the property for not 30 less than ten percent more than the negotiated sale price, subject to the same terms and conditions. A subsequent offer shall not be 31 32 considered unless it is accompanied by a deposit of twenty percent of the offer in the form of cash, money order, cashiers check, 33 or certified check payable to the Washington state treasurer, to be 34 35 forfeited to the state (for deposit in the motor vehicle fund) if the 36 offeror fails to complete the sale if the offeror's offer is accepted. 37 If a subsequent offer is received, the first offeror shall be informed by registered or certified mail sent to the address stated in his or 38

<u>her</u> offer. The first offeror shall then have ten days, from the date of mailing the notice of the increased offer, in which to file with the designated state employee or real estate broker a higher offer than that of the subsequent offeror. After the expiration of the ten\_day period, the department shall approve in writing the highest and best offer which the department then has on file.

7 (6) All moneys received pursuant to this section, less any real
8 estate broker's commissions paid pursuant to RCW 47.12.320, shall be
9 deposited in the motor vehicle fund.

10 Sec. 10007. RCW 47.26.150 and 1988 c 167 s 17 are each amended to 11 read as follows:

12 The transportation improvement board shall meet at least once 13 quarterly and upon the call of its ((chairman)) chair and shall from 14 time to time adopt rules and regulations for its own government and as 15 may be necessary for it to discharge its duties and exercise its powers 16 under this chapter.

17 Sec. 10008. RCW 47.26.4254 and 1999 sp.s. c 1 s 611 are each 18 amended to read as follows:

19 (1) Any funds required to repay series III bonds authorized by RCW 47.26.420, or the interest thereon, when due shall first be taken from 20 21 that portion of the motor vehicle fund that results from the imposition 22 of excise taxes on motor vehicle and special fuels imposed by chapters 82.36 and 82.38 RCW and that is distributed to the urban arterial trust 23 24 account in the motor vehicle fund pursuant to RCW 46.68.090(( $\frac{(1)(q)}{(q)}$ )) (2)(e), subject, however, to the prior lien of the first authorization 25 of bonds authorized by RCW 47.26.420. If the moneys so distributed to 26 the urban arterial trust account, after first being applied to 27 28 administrative expenses of the transportation improvement board and to the requirements of bond retirement and payment of interest on first 29 30 authorization bonds and series II bonds as provided in RCW 47.26.425 and 47.26.4252, are insufficient to meet the requirements for bond 31 retirement or interest on any series III bonds, the amount required to 32 33 make such payments on series III bonds or interest thereon shall next 34 be taken from that portion of the motor vehicle fund that results from 35 the imposition of excise taxes on motor vehicle and special fuels and

1 that is distributed to the state, counties, cities, and towns pursuant 2 to RCW 46.68.090, subject, however, to subsection (2) of this section.

(2) To the extent that moneys so distributed to the urban arterial 3 4 trust account are insufficient to meet the requirements for bond 5 retirement or interest on any series III bonds, sixty percent of the amount required to make such payments when due shall first be taken б 7 from that portion of the motor vehicle fund that results from the 8 imposition of excise taxes on motor vehicle and special fuels and that is distributed to the state. The remaining forty percent shall first 9 10 be taken from that portion of the motor vehicle fund that results from the imposition of excise taxes on motor vehicle and special fuels and 11 12 that is distributed to the cities and towns pursuant to RCW 13 46.68.090((<del>(1)(i)</del>)) <u>(2)(g)</u> and to the counties pursuant to RCW 46.68.090((((1)(j))) (2)(h). Of the counties', cities', and towns' 14 share of any additional amounts required in each fiscal year, the 15 percentage thereof to be taken from the counties' distributive share 16 and from the cities' and towns' distributive share shall correspond to 17 the percentage of funds authorized for specific county projects and for 18 specific city and town projects, respectively, from the proceeds of 19 20 series III bonds, for the period through the first eleven months of the 21 prior fiscal year as determined by the ((chairman)) chair of the transportation improvement board and reported to the state finance 22 23 committee and the state treasurer not later than the first working day 24 of June.

(3) Any payments on such bonds or interest thereon taken from motor vehicle or special fuel tax revenues that are distributable to the state, counties, cities, and towns shall be repaid from the first moneys distributed to the urban arterial trust account not required for redemption of the first authorization bonds, series II bonds, or series III bonds or interest on these bonds.

31 **Sec. 10009.** RCW 47.28.080 and 1985 c 242 s 2 are each amended to 32 read as follows:

Any person, firm, or corporation proposing a bid for the construction or improvement of any state highway in response to a call for bids published therefor may withdraw the bid proposal without forfeiture and without prejudice to the right of the bidder to file a new bid proposal before the time fixed for the opening of the bid

proposals. The request for the withdrawal shall be made in writing, 1 signed by the person proposing the bid or his or her duly authorized 2 agent, and filed at the place and before the time fixed in the call for 3 4 bids for receipt of the bid proposals. No bid proposal may be considered that has not been filed with the department before the time 5 fixed for the receipt of bid proposals. In any provisions regarding 6 7 the filing or withdrawing of bid proposals the time fixed for the 8 receipt of bid proposals in the call for bid proposals as published 9 shall control without regard for the time when the bid proposals are 10 actually opened.

11 **Sec. 10010.** RCW 47.32.060 and 1988 c 202 s 45 are each amended to 12 read as follows:

13 At the time and place appointed for hearing upon the complaint, 14 which hearing shall be by summary proceedings, if the court or judge thereof finds that due notice has been given by posting and publication 15 16 and that the order of the department was duly made, and is further 17 satisfied and finds that the state highway or portion thereof described is legally a state highway having the width of right-of-way specified 18 in the order and that the structure, buildings, improvements, or other 19 20 means of occupancy of the state highway or portion thereof as stated in 21 the certificate of the department do in fact encroach, or that any 22 portion thereof encroach, upon the state highway right-of-way, the 23 court or judge thereof shall thereupon make and enter an order establishing that each of the structures, buildings, improvements, and 24 25 other means of occupancy specified in the order is unlawfully 26 maintained within the right-of-way and is subject to confiscation and sale and that they be forthwith confiscated, removed from the right-of-27 way, and sold, and providing that six days after the entry of the 28 29 order, a writ shall issue from the court directed to the sheriff of the county, commanding the sheriff to seize and remove from the right-of-30 31 way of the state highway each such structure, building, improvement, or other means of occupancy specified in the order forthwith on receipt of 32 a writ based on the order and to take and hold the property in his or 33 34 her custody for a period of ten days, unless redelivered earlier as 35 provided for by law, and if not then so redelivered to sell the 36 property at public or private sale and to pay the proceeds thereof into 37 the registry of the court within sixty days after the issuance of the

writ, and further in such action, including costs of posting original notices of the department, the costs of posting and publishing notices of hearing as part thereof and any cost of removal, be paid by the clerk to the state treasurer and credited to the motor vehicle fund. The order shall be filed with the clerk of the court and recorded in the minutes of the court, and is final unless appellate review thereof is sought within five days after filing of the order.

8 **Sec. 10011.** RCW 47.32.070 and 1971 c 81 s 115 are each amended to 9 read as follows:

Six days after filing of the order above provided for, if no review 10 11 thereof be taken to the supreme court or the court of appeals of the state, the clerk of the court shall issue under seal of such court a 12 13 writ directed to the sheriff of the county in which such court is held commanding him or her to remove, take into custody and dispose of the 14 property described in such order and make returns thereof as provided 15 16 for such writ by said order. On receipt of such writ it shall be the 17 duty of such sheriff to obey the command thereof, proceed as therein directed and make return within the time fixed by such writ; and said 18 sheriff shall be liable upon his or her official bond for the faithful 19 20 discharge of such duties. Upon filing of such return the clerk of 21 court shall make payments as provided for in the order of court. If by 22 the sheriff's return any of the property seized and removed pursuant to 23 such writ is returned as unsold and as of no sale value, and if the 24 court or judge thereof be satisfied that such is the fact, the court or 25 judge thereof may make further order directing the destruction of such 26 property, otherwise directing the sheriff to give new notice and again offer the same for sale, when, if not sold, the same may on order of 27 28 court be destroyed.

29 Sec. 10012. RCW 47.32.090 and 1961 c 13 s 47.32.090 are each 30 amended to read as follows:

The sureties on such bond shall justify as in other cases if the sheriff requires it and in case they do not so justify when required, the sheriff shall retain and sell or dispose of the property; and if the sheriff does not require the sureties to justify, he <u>or she</u> shall stand good for their sufficiency. He <u>or she</u> shall date and indorse his <u>or her</u> acceptance upon the bond, and shall return the affidavit, bond and justification, if any, to the office of the clerk of such superior court, whereupon such clerk shall set the hearing thereof as a separate case for trial, in which such claimant shall be the plaintiff and the sheriff and the state of Washington defendants: PROVIDED, That no costs shall, in such case, be assessed against the sheriff or the state of Washington in the event the plaintiff should prevail.

7 Sec. 10013. RCW 47.36.110 and 1984 c 7 s 199 are each amended to 8 read as follows:

9 In order to provide safety at intersections on the state highway system, the department may require persons traveling upon any portion 10 11 of such highway to stop before entering the intersection. For this 12 purpose there may be erected a standard stop sign as prescribed in the state department of transportation's "Manual on Uniform Traffic Control 13 14 Devices for Streets and Highways." All persons traveling upon the highway shall come to a complete stop at such a sign, and the 15 16 appearance of any sign so located is sufficient warning to a person 17 that he or she is required to stop. A person stopping at such a sign 18 shall proceed through that portion of the highway in a careful manner and at a reasonable rate of speed not to exceed twenty miles per hour. 19 20 It is unlawful to fail to comply with the directions of any such stop 21 sign. When the findings of a traffic engineering study show that the 22 condition of an intersection is such that vehicles may safely enter the 23 major artery without stopping, the department or local authorities in their respective jurisdictions shall install and maintain a "Yield" 24 25 sign.

26 **Sec. 10014.** RCW 47.36.200 and 2006 c 331 s 1 are each amended to 27 read as follows:

28 (1) When construction, repair, or maintenance work is conducted on 29 or adjacent to a public highway, county road, street, bridge, or other 30 thoroughfare commonly traveled and when the work interferes with the normal and established mode of travel on the highway, county road, 31 street, bridge, or thoroughfare, the location shall be properly posted 32 33 by prominently displayed signs or ((flagmen)) flaggers or both. Signs 34 used for posting in such an area shall be consistent with the 35 provisions found in the state of Washington "Manual on Uniform Traffic

Control Devices for Streets and Highways" obtainable from the
 department of transportation.

(2) If the construction, repair, or maintenance work includes or 3 4 uses grooved pavement, abrupt lane edges, steel plates, or gravel or earth surfaces, the construction, repair, or maintenance zone must be 5 posted with signs stating the condition, as required by current law, б 7 and in addition, must warn motorcyclists of the potential hazard only if the hazard or condition exists on a paved public highway, county 8 road, street, bridge, or other thoroughfare commonly traveled. For the 9 10 purposes of this subsection, the department shall adopt by rule a uniform sign or signs for this purpose, including at least the 11 12 following language, "MOTORCYCLES USE EXTREME CAUTION."

(3) Any contractor, firm, corporation, political subdivision, orother agency performing such work shall comply with this section.

15 (4) Each driver of a motor vehicle used in connection with such 16 construction, repair, or maintenance work shall obey traffic signs 17 posted for, and flaggers stationed at such location in the same manner 18 and under the same restrictions as is required for the driver of any 19 other vehicle.

20 (5) A violation of or a failure to comply with this section is a 21 misdemeanor. Each day upon which there is a violation, or there is a 22 failure to comply, constitutes a separate violation.

23 **Sec. 10015.** RCW 47.41.040 and 1984 c 7 s 218 are each amended to 24 read as follows:

25 Before July 1, 1971, the department shall determine whether or not 26 the topography of the land adjoining the highway will permit adequate 27 screening of any junkyard lawfully in existence located outside of a zoned industrial area or an unzoned industrial area as defined under 28 29 RCW 47.41.030 on August 9, 1971, that is within one thousand feet of the nearest edge of the right-of-way and visible from the main traveled 30 31 way of any highway on the interstate and primary system and whether screening of the junkyard would be economically feasible. 32 Within thirty days thereafter the department shall notify by certified mail 33 34 the record owner of the land upon which the junkyard is located, or the 35 operator thereof, of its determination.

36 If it is economically feasible to screen the junkyard, the 37 department shall screen the junkyard so that it will not be visible 1 from the main-traveled way of the highway. The department is 2 authorized to acquire by gift, purchase, exchange, or condemnation such 3 lands or interest in lands as may be required for these purposes.

4 If it is not economically feasible to screen the junkyard, the 5 department shall acquire by purchase, gift, or condemnation an interest in the real property used for junkyard purposes that is visible from 6 7 the main traveled way of the highway, restricting any owner of the 8 remaining interest to use of the real estate for purposes other than a junkyard. In addition to compensation for the real property interest, 9 10 the operator of a junkyard shall receive the actual reasonable expenses in moving his or her business personal property to a location within 11 the same general area where a junkyard may be lawfully established, 12 13 operated, and maintained. This section shall be interpreted as being 14 in addition to all other rights and remedies of a junkyard owner or operator and shall not be interpreted as a limitation on or alteration 15 of the law of compensation in eminent domain. 16

17 **Sec. 10016.** RCW 47.42.080 and 1985 c 376 s 6 are each amended to 18 read as follows:

(1) Any sign erected or maintained contrary to the provisions of 19 20 this chapter or rules adopted hereunder that is designed to be viewed 21 from the interstate system, the primary system, or the scenic system is 22 a public nuisance, and the department, the chief of the Washington 23 state patrol, the county sheriff, or the chief of police of any city or 24 town shall notify the permittee or, if there is no permittee, the owner 25 of the property on which the sign is located, by certified mail at his 26 or her last known address, that it constitutes a public nuisance and 27 must comply with the chapter or be removed.

(2) If the permittee or owner, as the case may be, fails to comply with the chapter or remove any such sign within fifteen days after being notified to remove the sign he <u>or she</u> is guilty of a misdemeanor. In addition to the penalties imposed by law upon conviction, an order may be entered compelling removal of the sign. Each day the sign is maintained constitutes a separate offense.

(3) If the permittee or the owner of the property upon which it is
located, as the case may be, is not found or refuses receipt of the
notice, the department, the chief of the Washington state patrol, the
county sheriff, or the chief of police of any city or town shall post

the sign and property upon which it is located with a notice that the sign constitutes a public nuisance and must be removed. If the sign is not removed within fifteen days after such posting, the department, the chief of the Washington state patrol, the county sheriff, or the chief of police of any city or town shall abate the nuisance and destroy the sign, and for that purpose may enter upon private property without incurring liability for doing so.

8 (4) Nothing in this section may be construed to affect the 9 provisions contained in RCW 47.42.102 requiring the payment of 10 compensation upon the removal of any signs compensable under state law.

(5) Any sign erected or maintained on state highway right-of-way contrary to this chapter or rules adopted under it is a public nuisance, and the department is authorized to remove any such sign without notice.

15 **Sec. 10017.** RCW 47.42.103 and 1984 c 7 s 229 are each amended to 16 read as follows:

17 (1) Compensation as required by RCW 47.42.102 shall be paid to the person or persons entitled thereto for the removal of such signs. 18 Ιf no agreement is reached on the amount of compensation to be paid, the 19 20 department may institute an action by summons and complaint in the 21 superior court for the county in which the sign is located to obtain a 22 determination of the compensation to be paid. 21 (3) The director shall issue regulations requiring employers to 22 maintain accurate records of employee exposures to potentially toxic 23 materials or harmful physical agents which are required to be monitored 24 or measured. Such regulations shall provide employees or their representatives with an opportunity to observe such monitoring or 25 26 measuring, and to have access to the records thereof. Such regulations 27 shall also make appropriate provisions for each employee or former employee to have access to such records as will indicate his or her own 28 29 exposure to toxic materials or harmful physical agents. Each employer 30 shall promptly notify any employee who has been or is being exposed to toxic materials or harmful physical agents in concentrations or at 31 32 levels which exceed those prescribed by any applicable safety and 33 health standard promulgated under this chapter and shall inform any 34 employee who is being thus exposed of the corrective action being 35 taken.

36 **Sec. 12019.** RCW 49.17.240 and 1973 c 80 s 24 are each amended to 37 read as follows:

(1) The director in the promulgation of rules under the authority 1 2 of this chapter shall establish safety and health standards for conditions of employment of general and/or specific applicability for 3 4 industries, businesses, occupations, crafts, trades, all and employments subject to the provisions of this chapter, or those that 5 are a national or accepted federal standard. In the event that such medical examinations are in the 25 26 nature of research, as determined by the director, such examinations 27 may be furnished at the expense of the department. The results of such 28 examinations or tests shall be furnished only to the director, other 29 appropriate agencies of government, and at the request of the employee 30 to his or her physician.

(3) Whenever the director adopts by rule any safety and health 31 32 standard he or she may at the same time provide by rule the effective date of such standard which shall not be less than thirty days, 33 excepting emergency rules, but may be made effective at such time in 34 35 excess of thirty days from the date of adoption as specified in any 36 rule adopting a safety and health standard. Any rule not made 37 effective thirty days after adoption, having a delayed effectiveness in excess of thirty days, may only be made upon a finding made by the 38

director that such delayed effectiveness of the rule is reasonably necessary to afford the affected employers a reasonable opportunity to make changes in methods, means, or practices to meet the requirements of the adopted rule. Temporary orders granting a variance may be utilized by the director in lieu of the delayed effectiveness in the adoption of any rule.

35 **Sec. 12021.** RCW 49.24.020 and 1937 c 131 s 2 are each amended to 36 read as follows:

Every employer of persons for work in compressed air shall:

2 (1) Connect at least two air pipes with the working chamber and3 keep such pipes in perfect working condition;

4 (2) Attach to the working chamber in accessible positions all
5 instruments necessary to show its pressure and keep such instruments in

Every person who shall wilfully and maliciously, either alone or in combination with others, break a contract of service or employment, knowing or having reasonable cause to believe that the consequence of his <u>or her</u> so doing will be to endanger human life or to cause grievous bodily injury, or to expose valuable property to destruction or serious injury, shall be guilty of a misdemeanor.

17 Sec. 12040. RCW 49.46.010 and 2002 c 354 s 231 are each amended to

Social security requires protection against this greatest hazard of our 9 10 economic life. This can be provided only by application of the insurance principle of sharing the risks, and by the systematic 11 12 accumulation of funds during periods of employment to provide benefits 13 for periods of unemployment, thus maintaining purchasing powers and 14 limiting the serious social consequences of relief assistance. The state of Washington, therefore, exercising herein its police and 15 sovereign power endeavors by this title to remedy any widespread 16 17 unemployment situation which may occur and to set up safeguards to 18 prevent its recurrence in the years to come. The legislature, 19 therefore, declares that in its considered judgment the public good, and the general welfare of the citizens of this state require the 20 21 enactment of this measure, under the police powers of the state, for 22 the compulsory setting aside of unemployment reserves to be used for the benefit of persons unemployed through no fault of their own, and 23 24 that this title shall be liberally construed for the purpose of 25 reducing involuntary unemployment and the suffering caused thereby to 26 the minimum.

29 "Benefits" means the compensation payable to an individual, as 30 provided in this title, with respect to his <u>or her</u> unemployment.

(3) For the purpose of payment of benefits and payment of contributions, the term "wages" includes tips which are received after January 1, 1987, while performing services which constitute employment, and which are reported to the employer for federal income tax purposes.

33 (4)(a) "Remuneration" means all compensation paid for personal 34 services including commissions and bonuses and the cash value of all 35 compensation paid in any medium other than cash. The reasonable cash 36 value of compensation paid in any medium other than cash and the 37 reasonable value of gratuities shall be estimated and determined in 38 accordance with rules prescribed by the commissioner. Remuneration

1 does not include payments to members of a reserve component of the 2 armed forces of the United States, including the organized militia of 3 the state of Washington, for the performance of duty for periods not 4 exceeding seventy-two hours at a time.

(b) Previously accrued compensation, other than severance pay or 5 payments received pursuant to plant closure agreements, when assigned 6 7 to a specific period of time by virtue of a collective bargaining 8 agreement, individual employment contract, customary trade practice, or request of the individual compensated, shall be considered remuneration 9 for the period to which it is assigned. (2) There is established a unit within the department for the purpose of detection and investigation of fraud under this title. The department will employ supervisory and investigative personnel for the program, who must be qualified by training and experience.

30 (3) The commissioner or the commissioner's duly authorized designee is authorized to receive criminal history record information that 31 includes nonconviction data for any purpose associated with the 32 33 investigation for abuse or fraud under chapter 50.20 RCW. Dissemination or use of nonconviction data for purposes other than that 34 35 authorized in this section is prohibited.

36 **Sec. 13014.** RCW 50.12.060 and 1945 c 35 s 45 are each amended to 37 read as follows:

19 Sec. 13034. RCW 50.24.150 and 1979 ex.s. c 190 s 13 are each 20 amended to read as follows:

21 No later than three years after the date on which any 22 contributions, interest, or penalties have been paid, an employer who 23 has paid such contributions, interest, or penalties may file with the 24 commissioner a petition in writing for an adjustment thereof in 25 connection with subsequent contribution payments or for a refund thereof when such adjustment cannot be made. (2) Such marginal lands present difficulties and handicaps which
 are beyond remedy and control solely by regulatory processes in the
 exercise of the police power.

(3) They contribute substantially and increasingly to the problems of, and necessitate excessive and disproportionate expenditures for, crime prevention, correction, prosecution, and punishment, the treatment of juvenile delinquency, the preservation of the public health and safety, and the maintaining of adequate police, fire and accident protection, and other public services and facilities.

35 (4) This menace is becoming increasingly direct and substantial in36 its significance and effect.

1 (5) The benefits which will result from the remedying of such 2 conditions and the redevelopment of such marginal lands will accrue to 3 all the inhabitants and property owners of the communities in which 4 they exist.

5 (6) Such conditions of marginal lands tend to further obsolescence, 6 deterioration, and disuse because of the lack of incentive to the 7 individual landowner and his <u>or her</u> inability to improve, modernize, or 8 rehabilitate his <u>or her</u> property while the condition of the neighboring 9 properties remains unchanged.

10 (7) As a consequence the process of deterioration of such marginal 11 lands frequently cannot be halted or corrected except by redeveloping 12 the entire area, or substantial portions of it.

This remedy shall be in addition to any other remedy 18 under the terms of the sale. No purchaser shall transfer title to such 19 20 property within one year from the date of purchase.

21 **Sec. 16009.** RCW 53.34.020 and 1959 c 236 s 2 are each amended to 22 read as follows:

The district shall have the power to enter into a contract or 23 24 contracts for the use of said projects, their approaches and equipment 25 and from time to time to amend such contracts, with persons and with private and public corporations, and by said contracts to give such 26 27 persons or corporations the right to use said projects, their 28 approaches and equipment for the transmission of power for telephone 29 and telegraph lines, for the transportation of water, gas, petroleum, 30 and other products, for railroad and railway purposes, and for any other purpose to which the same may be adapted: PROVIDED, That no such 31 32 contract shall be for a period longer than ninety-nine years, and that 33 the projects shall be put to the largest possible number of uses 34 consistent with the purposes for which such projects are constructed.

No such contract 3 4 shall be made with any person or corporation unless and until such 5 person or corporation shall bind himself or herself or itself to pay as rental therefor an amount determined by the port district and specified б 7 in the contract which shall be a fair and just proportion of the total 8 amount required to pay interest on the bonds provided for in this chapter, plus a just proportion of the amount necessary for their 9 10 retirement, and plus the cost of maintenance of the projects, their approaches and equipment. 11

12 The port district may require any of such contracts to be entered 13 into before beginning the construction of said projects or before the 14 expenditure of funds under the provisions of this chapter if in its 15 judgment it is deemed expedient.

There shall be no monopoly of the use of said projects, and their 16 17 approaches by any one use, or by any person or corporation, private or public, in respect to the several uses, and the port district may 18 19 continue to make separate, additional, and supplemental contracts for one or more uses until in the judgment of said port district the 20 21 capacity of the projects and approaches for any such use has been 22 reached. When such capacity has been reached contracts for the use of 23 said projects shall be given preference in regard to such uses according to the public interest as determined by the port district, 24 25 and subsequent contracts shall be subject to all existing and prior 26 The port district shall have the power to prescribe contracts. regulations for the use of such facilities by the parties to contracts 27 for such use, or any of them, and to hear and determine all 28 29 controversies which may arise between such parties, under such rules as 30 the port district may from time to time promulgate; and all contracts 31 shall expressly reserve such power to the port district.

32 **Sec. 16010.** RCW 53.34.140 and 1959 c 236 s 14 are each amended to 33 read as follows:

Prior to the issuance and delivery of revenue bonds or notes under the authority of this chapter, such revenue bonds or notes and a certified copy of the resolution, resolutions, or trust agreements authorizing such revenue bonds or notes shall be forwarded by the port 1 commission to the state auditor together with any additional 2 information requested by him <u>or her</u>, and when such revenue bonds or 3 notes have been examined they shall be registered by the auditor in 4 books to be kept by him <u>or her</u> for that purpose, and a certificate of 5 registration shall be endorsed upon each such revenue bond or note and 6 signed by the auditor or a deputy appointed by him <u>or her</u> for that 7 purpose.

8 Revenue bonds or notes so registered shall then be prima facie 9 valid and binding obligations of the port district in accordance with 10 the terms thereof, notwithstanding any defect or irregularity in the 11 proceedings for the authorization and issuance of such revenue bonds or 12 notes or in the sale, execution or delivery thereof or in the 13 application of the proceeds thereof.

14 **Sec. 16011.** RCW 53.36.010 and 1983 c 250 s 1 are each amended to 15 read as follows:

admission, or if he or she shall be entitled to any private benefits, 1 2 as a result of such private service, unless he or she agrees at the time of his or her employment with the district to accept a reduction 3 in the payment of any benefits payable under the plan to which he or 4 she requests entry that are based in whole or in part on such added and 5 accredited service by the amount of benefits received. б For the 7 purposes of contributions, the date of entry of service shall be deemed 8 the date of entry into service with the private utility, which service is accredited by this section, and the amount of contributions for the 9 10 period of accredited service shall be based on the wages or salary of such person during that added and accredited period of service with the 11 12 private utility.

13 The district may receive such payments from a third party and shall 14 make from such payments contributions with respect to such prior 15 service as may be necessary to enable it to assume its obligations.

After such contributions have been made and such service added and accredited such employee shall be established in the plan to which he or she seeks admission with all rights, benefits, and privileges that he <u>or she</u> would have been entitled to had he <u>or she</u> been a member of the plan from the beginning of his <u>or her</u> immediately preceding continuous employment with the private utility or of his <u>or her</u> eligibility.

23 Sec. 17004. RCW 54.08.010 and 2006 c 344 s 36 are each amended to 24 read as follows:

25 At any general election held in an even-numbered year, the county 26 legislative authority of any county in this state may, or, on petition 27 of ten percent of the qualified electors of the county based on the total vote cast in the last general county election held in an even-28 29 numbered year, shall, by resolution, submit to the voters of the county the proposition of creating a public utility district which shall be 30 31 coextensive with the limits of the county as now or hereafter established. Whenever the petition 10 11 shall be certified to as sufficient, the county auditor shall forthwith 12 transmit the same, together with his or her certificate of sufficiency 13 attached thereto, to the county legislative authority which shall submit the proposition to the voters of the county at the next general 14 election in an even-numbered year according to RCW 29A.04.330. 15 The notice of the election shall state the boundaries of the proposed 16 public utility district and the object of such election, and shall in 17 18 other respects conform to the requirements of the general laws of the state of Washington, governing the time and manner of holding 19 elections. Any petition for the formation of a public utility district may 25 describe a less area than the entire county in which the petition is 26 27 filed, the boundaries of which shall follow the then existing precinct boundaries and not divide any voting precinct; and in the event that 28 29 such a petition is filed the county legislative authority shall fix a date for a hearing on such petition, and shall publish the petition, 30 31 without the signatures thereto appended, for two weeks prior to the date of the hearing, together with a notice stating the time of the 32 33 meeting when the petition will be heard. The publication, and all other publications required by chapter 1, Laws of 1931, shall be in a 34 35 newspaper of general circulation in the county in which the district is situated. The hearing on the petition may be adjourned from time to 36 37 time, not exceeding four weeks in all. No person having signed such petition shall be 11 allowed to withdraw his or her name therefrom after the filing of the 12 same with the county auditor: PROVIDED, That each signature shall be dated and that no signature dated prior to the date on which the form 13 of petition was submitted to the county auditor shall be valid. 14 Whenever such petition shall be certified to as sufficient, the county 15 auditor shall forthwith transmit the same, together with his or her 16 17 certificate of sufficiency attached thereto, to the county legislative 18 authority which shall submit such proposition to the voters of said 19 district at the next general election in an even-numbered year according to RCW 29A.04.330. The notice of the election shall state 20 21 the object of such election, and shall in other respects conform to the 22 requirements of the general laws of Washington, governing the time and 23 manner of holding elections.

(5) Any repair work performed under the provisions of this section shall comply with the requirements imposed by any applicable code, statute, ordinance, or regulation. A landlord whose property is damaged because of repairs performed in a negligent manner may recover the actual damages in an action against the tenant. 1 (6) Nothing in this section shall prevent the tenant from agreeing 2 with the landlord to undertake the repairs himself <u>or herself</u> in return 3 for cash payment or a reasonable reduction in rent, the agreement 4 thereof to be agreed upon between the parties, and such agreement does 5 not alter the landlord's obligations under this chapter.

6 **Sec. 19022.** RCW 59.18.140 and 1989 c 342 s 6 are each amended to 7 read as follows:

The administrative fee for this arbitration procedure shall be established by agreement of the parties and the arbitrator and, unless otherwise allocated by the arbitrator, shall be shared equally by the parties: PROVIDED, That upon either party signing an affidavit to the effect that he <u>or she</u> is unable to pay his <u>or her</u> share of the fee, that portion of the fee may be waived or deferred.
