Background: A district judge must retire from judicial office at the end of the calendar year in which the judge attains the age of 75 years. This provision must not affect the term of any judge that was elected or appointed prior to August 11, 1969.

Summary of Substitute Bill: The mandatory retirement age for district court judges is repealed.

Effective Date: Ninety days after adjournment of session in which bill is passed.

Staff Summary of Public Testimony on Original Bill: PRO: Get rid of all mandatory retirement ages for judges. People do not age uniformly. Asking the public to vote on an amendment to the constitution may be costly. We support this bill. This bill only requires a statute change. The state constitution is silent on retirement ages for district court judges. A judge can be removed from the state supreme court by a commission and the supreme court. Nineteen states have no mandatory retirement ages for judges.
