AN ACT Relating to the use of express toll lanes in the eastside corridor; amending RCW 47.56.810; reenacting and amending RCW 43.84.092; adding new sections to chapter 47.56 RCW; creating a new section; and prescribing penalties.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

б Sec. 1. The legislature recognizes that the Puget NEW SECTION. 7 Sound region is faced with growing traffic congestion and has limited 8 ability to expand freeway capacity due to financial, environmental, and 9 physical constraints. Freeway high occupancy vehicle lanes have been 10 an effective means of providing transit, vanpools, and carpools with a fast trip on congested freeway corridors, but in many cases, these 11 12 lanes operate beyond their capacity during peak commute times.

It is the intent of the legislature to improve mobility for people 13 and goods by maximizing the effectiveness of the freeway system. 14 An 15 express toll lanes network is one approach for managing the use of freeway high occupancy vehicle lanes and, at the same time, generating 16 funds to improve the Interstate 405 and state route number 167 17 The legislature acknowledges that as one of the most 18 corridor. congested freeway sections in the state, the combined Interstate 405 19

and state route number 167 corridor serves as an ideal candidate for the use of an express toll lanes network. An express toll lanes network could provide benefits for movement of vehicles and people, as well as having the potential to generate revenue for other improvements in the Interstate 405 and state route number 167 corridor.

The legislature also recognizes the need for geographic balance and б 7 regional equity in decisions regarding tolling and pricing, and intends to consider the implementation of express toll 8 lanes on other 9 facilities in the region in the future. It is further the intent of 10 the legislature to use its evaluation of initial express toll lanes on Interstate 405 to guide additions to the express toll lanes network, 11 particularly in the most congested areas of the Interstate 405 and 12 13 state route number 167 corridor, such as the Renton-to-Bellevue segment and the Interstate 405/state route number 167 interchange, with the 14 ultimate goal of continuous express toll lanes from Puyallup to 15 16 Lynnwood.

17 Therefore, it is the intent of this act to direct the department of 18 transportation to develop and operate express toll lanes on Interstate 19 405 between the city of Bellevue on the south end and Interstate 5 on 20 the north end and to conduct an evaluation of that project to determine 21 the impacts on the movement of vehicles and people through the 22 Interstate 405 and state route number 167 corridor, effectiveness for transit, carpools and single occupancy vehicles, and feasibility of 23 24 financing capacity improvements through tolls.

25 **Sec. 2.** RCW 47.56.810 and 2008 c 122 s 3 are each amended to read 26 as follows:

The definitions in this section apply throughout this subchapter unless the context clearly requires otherwise:

(1) "Tolling authority" means the governing body that is legally empowered to review and adjust toll rates. Unless otherwise delegated, the transportation commission is the tolling authority for all state highways.

(2) "Eligible toll facility" or "eligible toll facilities" means
portions of the state highway system specifically identified by the
legislature including, but not limited to, transportation corridors,
bridges, crossings, interchanges, on-ramps, off-ramps, approaches,
bistate facilities, and interconnections between highways.

1 (3) "Toll revenue" or "revenue from an eligible toll facility" 2 means toll receipts, all interest income derived from the investment of 3 toll receipts, and any gifts, grants, or other funds received for the 4 benefit of the eligible toll facility.

5 <u>(4) "Express toll lanes" means one or more high occupancy vehicle</u> 6 <u>lanes of a highway in which the department charges tolls primarily as</u> 7 <u>a means of regulating access to or use of the lanes to maintain travel</u> 8 <u>speed and reliability.</u>

9 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 47.56 RCW 10 under the subchapter heading "toll facilities created after July 1, 11 2008" to read as follows:

(1) The imposition of tolls for express toll lanes on Interstate 405 between the junctions with Interstate 5 on the north end and NE 6th Street in the city of Bellevue on the south end is authorized, Interstate 405 is designated an eligible toll facility, and toll revenue generated in the corridor must only be expended as allowed under RCW 47.56.820.

(2) Tolls for the express toll lanes must be set as follows:

(a) The schedule of toll rates must be set by the tolling authority pursuant to RCW 47.56.850. Toll rates may vary in amount by time of day, level of traffic congestion within the highway facility, or other criteria, as the tolling authority deems appropriate.

(b) In those locations with two express toll lanes in eachdirection, the toll rate must be the same in both lanes.

(c) Toll charges may not be assessed on transit buses and vanpools.

(d) The department shall establish performance standards for travel time, speed, and reliability for the express toll lanes project. The department must automatically adjust the toll rate within the schedule established by the tolling authority, using dynamic tolling, to ensure that average vehicle speeds in the lanes remain above forty-five miles per hour at least ninety percent of the time during peak hours.

(e) The tolling authority shall periodically review the toll rates
against traffic performance of all lanes to determine if the toll rates
are effectively maintaining travel time, speed, and reliability on the
highway facilities.

36 (3) The department may construct and operate express toll lanes on
 37 Interstate 405 between the city of Bellevue on the south end and

Interstate 5 on the north end. Operation of the express toll lanes may 1 2 not commence until the department has completed capacity improvements necessary to provide a two-lane system from NE 6th Street in the city 3 of Bellevue to state route number 522 and the conversion of the 4 5 existing high occupancy vehicle lane to an express toll lane between state route number 522 and the city of Lynnwood. The department shall 6 7 work with local jurisdictions to monitor impacts to local streets and, after consultation with local jurisdictions, recommend mitigation 8 9 measures to the legislature in those locations where it is appropriate.

10 (4) The department shall monitor the express toll lanes project and 11 shall annually report to the transportation commission and the 12 legislature on the impacts from the project on the following 13 performance measures:

(a) Whether the express toll lanes maintain speeds of forty-five
miles per hour at least ninety percent of the time during peak periods;
(b) Whether the average traffic speed changed in the general
purpose lanes;

(c) Whether transit ridership changed;

19 (d) Whether the actual use of the express toll lanes is consistent 20 with the projected use;

(e) Whether the express toll lanes generated sufficient revenue to pay for operating costs;

23 (f) Whether travel times and volumes have increased or decreased on 24 adjacent local streets and state highways; and

25 (g) Whether the actual gross revenues are consistent with projected 26 gross revenues.

(5) A violation of the lane restrictions applicable to the expresstoll lanes established under this section is a traffic infraction.

29 <u>NEW SECTION.</u> Sec. 4. A new section is added to chapter 47.56 RCW 30 under the subchapter heading "toll facilities created after July 1, 31 2008" to read as follows:

(1) The department shall conduct a traffic and revenue analysis for the development of a forty-mile continuous express toll lane system that includes state route number 167 and Interstate 405. The department shall also develop a corridor-wide project management plan to develop a strategy for phasing the completion of improvements in the Interstate 405 and state route number 167 corridor.

1 (2) The department shall use the information from the traffic and 2 revenue analysis and the corridor-wide project management plan to 3 develop a finance plan to fund improvements in the Interstate 405 and 4 state route number 167 corridor. The department must include the 5 following elements in the finance plan:

6 (a) Current state and federal funding contributions for projects in 7 the Interstate 405 and state route number 167 corridor;

8 (b) A potential future state and federal funding contribution to 9 leverage toll revenues;

10 (c) Financing mechanisms to optimize the revenue available for 11 capacity improvements including, but not limited to, using the full 12 faith and credit of the state;

(d) An express toll lane system operating in the Interstate 405 andstate route number 167 corridor by 2014; and

(e) Completion of the capacity improvements in the Interstate 405and state route number 167 corridor.

17 (3) The department must consult with a committee consisting of 18 local and state elected officials from the Interstate 405 and state 19 route number 167 corridor and representatives from the transit agencies 20 that operate in the Interstate 405 and state route number 167 corridor 21 while developing the performance standards, traffic and revenue 22 analysis, and finance plan.

(4) The department must provide the traffic and revenue analysis
plan and finance plan to the governor and the legislature by January
2012.

(5) The department shall conduct ongoing education and outreach toensure public awareness of the express toll lane system.

28 <u>NEW SECTION.</u> Sec. 5. A new section is added to chapter 47.56 RCW 29 under the subchapter heading "toll facilities created after July 1, 30 2008" to read as follows:

The Interstate 405 express toll lanes operations account is created in the state treasury. All revenues received by the department as toll charges collected from Interstate 405 express toll lane users must be deposited into the account. Moneys in the account may be spent only after appropriation. Expenditures from the account may be used for, but not limited to, debt service, planning, administration,

construction, maintenance, operation, repair, rebuilding, enforcement,
 and the expansion of express toll lanes on Interstate 405.

3 Sec. 6. RCW 43.84.092 and 2010 1st sp.s. c 30 s 20, 2010 1st sp.s. 4 c 9 s 7, 2010 c 248 s 6, 2010 c 222 s 5, 2010 c 162 s 6, and 2010 c 145 5 s 11 are each reenacted and amended to read as follows:

6 (1) All earnings of investments of surplus balances in the state 7 treasury shall be deposited to the treasury income account, which 8 account is hereby established in the state treasury.

9 (2) The treasury income account shall be utilized to pay or receive funds associated with federal programs as required by the federal cash 10 11 management improvement act of 1990. The treasury income account is subject in all respects to chapter 43.88 RCW, but no appropriation is 12 required for refunds or allocations of interest earnings required by 13 the cash management improvement act. Refunds of interest to the 14 federal treasury required under the cash management improvement act 15 16 fall under RCW 43.88.180 and shall not require appropriation. The 17 office of financial management shall determine the amounts due to or from the federal government pursuant to the cash management improvement 18 act. The office of financial management may direct transfers of funds 19 20 between accounts as deemed necessary to implement the provisions of the cash management improvement act, and this subsection. Refunds or 21 allocations shall occur prior to the distributions of earnings set 22 23 forth in subsection (4) of this section.

24 (3) Except for the provisions of RCW 43.84.160, the treasury income account may be utilized for the payment of purchased banking services 25 26 on behalf of treasury funds including, but not limited to, depository, safekeeping, and disbursement functions for the state treasury and 27 affected state agencies. The treasury income account is subject in all 28 respects to chapter 43.88 RCW, but no appropriation is required for 29 payments to financial institutions. Payments shall occur prior to 30 31 distribution of earnings set forth in subsection (4) of this section.

32 (4) Monthly, the state treasurer shall distribute the earnings 33 credited to the treasury income account. The state treasurer shall 34 credit the general fund with all the earnings credited to the treasury 35 income account except:

36 (a) The following accounts and funds shall receive their 37 proportionate share of earnings based upon each account's and fund's

criminal justice assistance account, the municipal sales and use tax 1 2 equalization account, the natural resources deposit account, the oyster reserve land account, the pension funding stabilization account, the 3 perpetual surveillance and maintenance account, the public employees' 4 retirement system plan 1 account, the public employees' retirement 5 system combined plan 2 and plan 3 account, the public facilities 6 7 construction loan revolving account beginning July 1, 2004, the public health supplemental account, the public transportation systems account, 8 9 the public works assistance account, the Puget Sound capital 10 construction account, the Puget Sound ferry operations account, the tribal settlement account, the real estate 11 Puvallup appraiser 12 commission account, the recreational vehicle account, the regional 13 mobility grant program account, the resource management cost account, 14 the rural arterial trust account, the rural Washington loan fund, the site closure account, the small city pavement and sidewalk account, the 15 special category C account, the special wildlife account, the state 16 17 employees' insurance account, the state employees' insurance reserve account, the state investment board expense account, the state 18 investment board commingled trust fund accounts, the state patrol 19 highway account, the state route number 520 civil penalties account, 20 21 the state route number 520 corridor account, the supplemental pension 22 account, the Tacoma Narrows toll bridge account, the teachers' retirement system plan 1 account, the teachers' retirement system 23 24 combined plan 2 and plan 3 account, the tobacco prevention and control 25 account, the tobacco settlement account, the transportation 2003 26 account (nickel account), the transportation equipment fund, the 27 transportation fund, the transportation improvement account, the transportation improvement board bond retirement 28 account, the transportation infrastructure account, the transportation partnership 29 account, the traumatic brain injury account, the tuition recovery trust 30 31 fund, the University of Washington bond retirement fund, the University 32 of Washington building account, the urban arterial trust account, the volunteer firefighters' and reserve officers' relief and pension 33 principal fund, the volunteer firefighters' and reserve officers' 34 35 administrative fund, the Washington judicial retirement system account, the Washington law enforcement officers' and firefighters' system plan 36 37 1 retirement account, the Washington law enforcement officers' and 38 firefighters' system plan 2 retirement account, the Washington public

safety employees' plan 2 retirement account, the Washington school 1 employees' retirement system combined plan 2 and 3 account, the 2 Washington state health insurance pool account, the Washington state 3 patrol retirement account, the Washington State University building 4 account, the Washington State University bond retirement fund, the 5 water pollution control revolving fund, and the Western Washington 6 7 University capital projects account. Earnings derived from investing balances of the agricultural permanent fund, the normal school 8 permanent fund, the permanent common school fund, the scientific 9 permanent fund, and the state university permanent fund shall be 10 11 allocated to their respective beneficiary accounts.

(b) Any state agency that has independent authority over accounts or funds not statutorily required to be held in the state treasury that deposits funds into a fund or account in the state treasury pursuant to an agreement with the office of the state treasurer shall receive its proportionate share of earnings based upon each account's or fund's average daily balance for the period.

(5) In conformance with Article II, section 37 of the state
 Constitution, no treasury accounts or funds shall be allocated earnings
 without the specific affirmative directive of this section.
