## HOUSE BILL 1835

State of Washington 62nd Legislature 2011 Regular Session

1 AN ACT Relating to assault in the first degree; amending RCW 2 9A.36.011; reenacting and amending RCW 9.94A.515; and prescribing 3 penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 9A.36.011 and 1997 c 196 s 1 are each amended to read 6 as follows:

7 (1) A person is guilty of assault in the first degree if he or she,8 with intent to inflict great bodily harm:

9 (a) Assaults another with a firearm or any deadly weapon or by any 10 force or means likely to produce great bodily harm or death; or

(b) Administers, exposes, or transmits to or causes to be taken by
another, poison, the human immunodeficiency virus as defined in chapter
70.24 RCW, or any other destructive or noxious substance; or

(c) Assaults another and inflicts great bodily harm.

15 (2) <u>A person is guilty of assault in the first degree if he or she</u> 16 <u>intentionally assaults another with a deadly weapon and recklessly</u> 17 <u>inflicts great bodily harm.</u>

18 (3) Assault in the first degree is a class A felony.
