AN ACT Relating to criminal gang intimidation of a law enforcement officer; reenacting and amending RCW 9.94A.515; adding a new section to chapter 9A.46 RCW; and prescribing penalties.

5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 9A.46 RCW 6 to read as follows:

(1) A criminal street gang associate or member, as defined in RCW 9.94A.030, and a person acting at the direction of a criminal street gang associate or member, who by his or her actions, demeanor, or language intentionally causes or attempts to cause fear on the part of a law enforcement officer, corrections officer, firefighter, or paramedic by threatening the law enforcement officer, corrections officer, firefighter, or paramedic or a family member of the law enforcement officer, corrections officer, firefighter, or paramedic, and whether or not the law enforcement officer, corrections officer, firefighter, or paramedic is on duty at the time the threat is made, is guilty of the crime of criminal gang intimidation of a law enforcement officer. A subjective standard, based on the training and experience of the law enforcement officer, corrections officer, firefighter, or
