- (3) In addition to the authority to discipline license holders, the 10 11 disciplinary authority may grant or deny licenses based on the 12 conditions and criteria established in this chapter and the chapters 13 specified in subsection (2) of this section. This chapter also governs 14 any investigation, hearing, or proceeding relating to denial of licensure or issuance of a license conditioned on the applicant's 15 compliance with an order entered under RCW 18.235.110 by the 16 disciplinary authority. 17
- 18 **Sec. 2.** RCW 43.24.150 and 2011 c 298 s 25 are each amended to read 19 as follows:
 - (1) The business and professions account is created in the state treasury. All receipts from business or professional licenses, registrations, certifications, renewals, examinations, or civil penalties assessed and collected by the department from the following chapters must be deposited into the account:
