1 AN ACT Relating to administration of drugs by health care
2 assistants; amending RCW 18.135.130; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 18.135.130 and 2009 c 43 s 3 are each amended to read
5 as follows:

6 (1) This section applies only to health care assistants certified
7 in categories C or E by the department of health.

8 (2)(a) The administration of drugs by a health care assistant is
9 restricted to oral, topical, rectal, otic, ophthalmic, or inhaled
10 routes administered pursuant to a written order of a supervising health
11 care practitioner. The drugs authorized for administration under this
12 section are limited to the following:

13 (i) Over-the-counter drugs that may be administered to a patient
14 while in the care of a health care practitioner are: Benadryl,
15 acetaminophen, ibuprofen, aspirin, neosporin, polysporin, normal
16 saline, colace, kenalog, and hydrocortisone cream;

17 (ii) Nonover-the-counter unit dose legend drugs that may be
18 administered to a patient while in the care of a health care
19 practitioner are: Kenalog, hydrocortisone cream, reglan, compazine,

1 zofran, bactroban, albuterol, xopenex, silvadene, gastrointestinal
2 cocktail, fluoride, lmx cream, emla, lat, optic dyes, oral contrast,
3 and oxygen.

4 ~~(b) ((Only health care assistants who are certified as category C~~
5 ~~or E assistants by the department of health may administer the oral~~
6 ~~drugs specified in (a) of this subsection.~~

7 ~~(e))~~ Health care assistants authorized to administer certain over-
8 the-counter and legend drugs under ~~((a) of))~~ this ~~((subsection))~~
9 section must demonstrate initial and ongoing competency to administer
10 specific drugs as determined by the health care practitioner.

11 ~~((2))~~ (3) A health care practitioner must administer a medication
12 if:

13 (a) A patient is unable to physically ingest or safely apply a
14 medication independently or with assistance; or

15 (b) A patient is unable to indicate an awareness that he or she is
16 taking a medication.

17 ~~((3))~~ (4) This section expires July 1, 2013.

18 NEW SECTION. **Sec. 2.** The department of health shall adopt any
19 rules necessary to implement this act.
