1 AN ACT Relating to special license plates with a special year tab
2 for persons with disabilities; amending RCW 46.19.060; and providing an
3 effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 46.19.060 and 2011 c 171 s 75 are each amended to read
6 as follows:

7 (1) An additional fee may not be charged for special license plates
8 for persons with disabilities except for any other fees and taxes
9 required to be paid upon registration of a motor vehicle.

10 (2) A registered owner who qualifies for special parking privileges
11 as described in RCW 46.19.010 may apply to the department for special
12 license plates for persons with disabilities or special license plates
13 with a special year tab for persons with disabilities. Special license
14 plates with a special year tab for persons with disabilities are

25 (3) A registered owner who chooses to purchase special license
26 plates as described in subsection (2) of this section shall pay the
27 applicable special license plate fee, in addition to any other fees or
28 taxes required for registering a motor vehicle.

29 (4) Special license plates for persons with disabilities or special
30 license plates with a special year tab for persons with disabilities
31 must be renewed in the same manner and at the time required for the
32 renewal of standard motor vehicle license plates under chapter 46.16A
33 RCW.

34 (5) Special license plates for persons with disabilities or special
35 license plates with a special year tab for persons with disabilities
36 may be transferred from one motor vehicle to another motor vehicle

1 owned by the person with the parking privilege upon application to the
2 department, county auditor or other agent, or subagent appointed by the
3 director.

4 (6) Special license plates for persons with disabilities or special
5 license plates with a special year tab for persons with disabilities
6 must be removed from the motor vehicle when the person with
7 disabilities transfers or assigns his or her interest in the motor
8 vehicle.

9 NEW SECTION. **Sec. 2.** This act takes effect January 1, 2013.
