1 AN ACT Relating to soliciting or accepting campaign contributions; 2 reenacting and amending RCW 42.17.710 and 42.17A.560; providing an 3 effective date; and providing an expiration date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 42.17.710 and 2006 c 348 s 5 and 2006 c 344 s 31 are 6 each reenacted and amended to read as follows:

7 (1) During the period beginning on the thirtieth day before the 8 date a regular legislative session convenes and continuing through the 9 date of final adjournment, and during the period beginning on the date 10 a special legislative session convenes and continuing through the date 11 that session adjourns, no state official or a person employed by or acting on behalf of a state official or state legislator may solicit or 12 13 accept contributions to a public office fund, to a candidate or 14 authorized committee, or to retire a campaign debt. Contributions 15 received through the mail after the thirtieth day before a regular 16 legislative session may be accepted if the contribution is postmarked 17 prior to the thirtieth day before the session.

18 (2) <u>The restrictions of this section also apply to any incumbent of</u>

4 <u>(3)</u> This section does not apply to activities authorized in RCW 5 43.07.370.

6 **Sec. 2.** RCW 42.17A.560 and 2006 c 348 s 5 and 2006 c 344 s 31 are 7 each reenacted and amended to read as follows:

(1) During the period beginning on the thirtieth day before the 8 9 date a regular legislative session convenes and continuing through the 10 date of final adjournment, and during the period beginning on the date 11 a special legislative session convenes and continuing through the date 12 that session adjourns, no state official or a person employed by or acting on behalf of a state official or state legislator may solicit or 13 14 accept contributions to a public office fund, to a candidate or authorized committee, or to retire a campaign debt. Contributions 15 received through the mail after the thirtieth day before a regular 16 legislative session may be accepted if the contribution is postmarked 17 18 prior to the thirtieth day before the session.

19 (2) The restrictions of this section also apply to any incumbent of 20 <u>a local elected office who has filed for a state office, or persons</u> 21 <u>employed by or acting on behalf of the incumbent of a local elected</u> 22 <u>office.</u>

23 (3) This section does not apply to activities authorized in RCW 24 43.07.370.
