#### **House Bills**

HB 1095 by Representatives Taylor, Kretz, Short, and McCune

Regarding payments in lieu of taxes for lands managed by the department of fish and wildlife.

Authorizes a county legislative authority, if deemed by the authority as beneficial for the economic development of the county, to elect to either reduce payments or excuse from payments certain department-owned game land.

Requires the department of fish and wildlife to make payments under RCW 77.12.203 (in-lieu payments authorized) for lands transferred to the department from other state agencies.

# HB 1096 by Representative Appleton

Concerning health care financing.

Creates the Washington health security trust to provide coverage for a set of health services for all residents.

Abolishes the health care authority and transfers its powers, duties, and functions to the Washington health security trust.

Requires Washington state employers to pay a health security assessment to the department of revenue to fund the Washington health security trust.

Requires certain residents to pay a standard monthly flat rate health security premium.

Creates the reserve account.

Creates the benefits account.

Creates the displaced worker training account with an expiration date of January 1, 2016.

Deposits certain contributions, and reserves, dividends, and refunds currently in the public employees' and retirees' insurance account in the reserve account and benefits account.

Transfers the state health care authority administrative account to the reserve account and the benefits account.

Requires revenue from certain taxes to be deposited in the reserve account and the benefits account instead of the general fund.

Requires money in the tobacco settlement account to be transferred to the reserve account and the benefits account instead of the general fund.

Repeals RCW 82.04.260 (tax on manufacturers and processors of various foods and by-products).

Changing offender registration periods for crimes committed by juveniles.

Revises registration requirements for sex offenses and kidnapping offenses committed by a juvenile.

HB 1098 by Representatives Hurst and Hasegawa

Concerning automated traffic safety cameras.

Reviews the original automated traffic safety camera pilot program to address concerns raised by the public about abuses related to the use of automated traffic safety cameras. -- 2011 REGULAR SESSION --

Jan 12 First reading, referred to Transportation.

HB 1099 by Representatives Hurst and Hasegawa

Concerning automated traffic safety cameras.

Reviews the original automated traffic safety camera pilot program to address concerns raised by the public about abuses related to the use of automated traffic safety cameras.

HB 1100 by Representatives Moeller, Fitzgibbon, Billig, and Santos

Concerning the medical use of cannabis.

Clarifies the law on the medical use of cannabis.

**HB 1101** by Representatives Moeller and Kenney

Providing patients with information on options for breast reconstruction.

Requires an ambulatory surgical facility and a hospital in which a mastectomy, lymph node dissection, or lumpectomy is performed to provide the patient with information regarding the option of postprocedure reconstructive surgery.

- HB 1102 by Representatives Blake, Chandler, Takko, and Van De Wege

Concerning landowner liability associated with forest roads subject to road maintenance and abandonment plans.

Excludes certain physical constructions used to block access to, or enhance the surrounding aquatic habitat of, a road subject to the road maintenance and abandonment plan requirements of the forest practices rules, as a known dangerous artificial latent condition.

HB 1103 by Representatives Kristiansen, Morris, and Armstrong

Modifying the use of television viewers in motor vehicles. Modifies provisions relating to motor vehicles equipped with television viewers.

HB 1104 by Representatives Moeller, Walsh, Billig, Kenney, Maxwell, and Dammeier; by request of Department of Social and Health Services

Concerning the protection of vulnerable adults.

Expands the definitions of "vulnerable adult" and "financial exploitation" in chapter 74.34 RCW (abuse of vulnerable adults).

Authorizes the department of social and health services to share certain reports and findings with appropriate state or local agencies, law enforcement agencies, the office of the attorney general, federally recognized tribes, or other entities or businesses.

Authorizes the department of social and health services' adult protective services division to enter into agreements with federally recognized tribes to investigate reports of abandonment, abuse, neglect, financial exploitation, or selfneglect of vulnerable adults on property over which a federally recognized tribe has exclusive jurisdiction.

HB 1105 by Representatives Kagi, Walsh, Kenney, Maxwell, and Roberts; by request of Department of Social and Health Services

Addressing child fatality review in child welfare cases.

Authorizes the secretary of the department of social and health services to examine and obtain copies of reports and records of autopsies or post mortems in child fatality review cases.

Requires the department of social and health services to consult with the office of the family and children's ombudsman in certain cases to determine if a child fatality review is required.

Authorizes the department of social and health services to conduct a review of a near fatality at its discretion.

Provides that a child fatality review report is subject to public disclosure.

HB 1106 by Representatives Takko, Orcutt, and Blake; by request of Parks and Recreation Commission

Authorizing disposal of property within the Seashore Conservation Area to resolve boundary disputes.

Authorizes the parks and recreation commission to directly dispose of up to five contiguous acres of real property within the seashore conservation area, without public auction, to resolve boundary disputes.

HB 1107 by Representatives Taylor, Shea, and McCune

Preparing for the epidemiological consequences of diseases related to wolf populations.

Requires the department of health, with the assistance of the department of fish and wildlife and the state veterinarian, to develop and implement a program to detect, interdict, and assess the epidemiological consequences of diseases that may afflict or may be carried by wolves and the actual and potential impact of wolves' role in such diseases upon human health in the state. Requires the department of health to implement the act by using federal grant money or other sources of funding not supported by the state general fund.

HB 1108 by Representatives Taylor, Shea, and McCune

Concerning the state's management of wolves.

Prevents the decline of wild game animal populations in Washington because of wolf predation.

Protects the stockgrowers of Washington from economic loss because of wolf predation.

Provides for the health and safety of people working outdoors or engaged in outdoor recreation.

Asserts the rights of Washington pursuant to the 9th and 10th amendments to the United States Constitution.

Concerning legislative review of gray wolf conservation and management.

Requires the legislature to approve or reject the department of fish and wildlife's recommended final environmental impact statement and the gray wolf conservation and management plan as a whole.

Requiring certain state agencies that manage natural resources to coordinate their land management with local governments.

Requires the department of fish and wildlife, the department of natural resources, and the parks and recreation commission to coordinate with all applicable affected local government officials during the development, revision, and implementation of any public land use plan under the control or authority of the department or the commission, as applicable.

## HB 1111 by Representatives Taylor, Shea, Kretz, Short, McCune, and Condotta

Addressing federal and state government coordination with local governments.

Authorizes a local government or special purpose district, if the ordinances, regulations, plans, or policies of a local government or special purpose district are less restrictive than applicable federal or state laws or requirements, to demand that the federal or state government coordinate with the local government or special purpose district before the federal or state government implements, enforces, expands, or extends the federal or state law or requirement within the jurisdictional boundary of the local government or special purpose district.

HB 1112 by Representatives Taylor, McCune, and Shea

Concerning hunter education.

Modifies age requirements when purchasing a hunting license.

HB 1113 by Representatives Rolfes, Klippert, Warnick, Hurst, Finn, Miloscia, Kelley, Goodman, Liias, and Fitzgibbon

Modifying provisions relating to prior offenses for the purposes of felony driving or being in physical control of a vehicle while under the influence of intoxicating liquor or any drug.

Modifies provisions relating to prior offenses with regard to felony driving or being in physical control of a vehicle while under the influence of intoxicating liquor or any drug.

**HB 1114** by Representatives Rolfes and Appleton

Concerning adoption decrees for children adopted in foreign countries.

Authorizes an adoptive parent to petition the court for refinalization of a foreign adoption when certain conditions are met.

HB 1115 by Representatives Alexander, Angel, and Dammeier

Authorizing immediate salary reductions for state officials when there is a general salary reduction for state employees.

Requires the citizens' commission on salaries for elected officials, in the event that the omnibus operating appropriations act reflects a general salary reduction for state employees, to immediately file a new salary schedule with the secretary of state that reduces the salaries of state elected officials, members of the legislature, and judges of the supreme court, court of appeals, superior courts, and district courts commensurate with the reduction for state employees.

Provides that the act takes effect if the proposed amendment to Article XXVIII, section 1 of the state Constitution is validly submitted to and is approved and ratified by the voters at the next general election.

Concerning alcohol sales in state liquor stores and contract liquor stores.

Requires the liquor control board to convert at least twenty state liquor stores to contract liquor stores between September 1, 2011, and July 1, 2013, and convert ten state liquor stores to contract liquor stores on a pilot basis between September 1, 2011, and July 1, 2012.

Authorizes certain independently owned grocery stores to apply for and receive a contract liquor store appointment.

Regarding the relinquishment of water rights.

Abolishes relinquishment of water rights by removing all references to relinquishment in the RCW.

Developing training for manufactured housing community managers.

Establishes a training program for managers of manufactured housing communities.

HB 1119 by Representatives Morris and Anderson

Privatizing the management of the state ferry system.

Privatizes management functions of the ferry system, making the system contractually accountable for efficient and quality service.

**HB 1121** by Representatives Pearson, Hurst, Kristiansen,

and McCune

Prohibiting public funds for being used to provide purchases by offenders who are incarcerated.

Prohibits public funds from being used to provide any purchase of personal goods at a store located within a correctional facility for or on behalf of an offender who is incarcerated.

Requires the department of social and health services, office of juvenile justice, to seek funding from the United States department of justice, office of justice programs, office of juvenile justice and delinquency prevention, to establish a competitive statewide gang prevention and intervention grant program.

Creates the crime of school criminal gang intimidation.

Addressing bargaining with certified exclusive bargaining representatives.

Provides foster youth who are legally dependent on the state and who reach the age of eighteen while still in foster care with continued foster care services to support basic and healthy transition into adulthood.

Engages in the fostering connections act by supporting foster youth to age nineteen with the goal of increasing support to age twenty-one as resources become available.

Concerning the tax preference review process.

Prohibiting requests for waivers of rights of residents of long-term care facilities.

Prohibits a long-term care facility or nursing facility from requiring or requesting residents to sign waivers of any rights set forth in the vulnerable adults statute.

SB 5048 by Senators Kline, Nelson, and Chase

Creating the Washington enhanced intelligence act.

Prohibits a state, local, or county law enforcement agency from collecting or maintaining protected information about an individual or group unless the information directly relates to criminal conduct or activity and there is reasonable suspicion that the subject of the information is or may be involved in criminal conduct or activity.

Requires state, local, and county law enforcement agencies to adopt a privacy policy governing treatment of protected information and ensure that all employees are properly trained with regard to protected information, agency privacy policies, and the provisions of the act.

Requires the attorney general to conduct in-place audits of state, local, and county law enforcement agency files and records at unscheduled intervals.

Licensing court reporting firms or agencies.

Requires a license for certain private court reporting firms or agencies doing business in the state.

Requires a court reporting firm or agency licensed in the state to comply with all rules and regulations pertaining to certified court reporters.

Authorizes the director of the department of licensing to impose a civil penalty for a violation of chapter 18.145 RCW (court reporting practice act).

Authorizing community custody after fifteen years for specified persistent offenders.

Authorizes community custody after fifteen years for certain persistent offenders.

SB 5054 by Senators Kline and Harper

Regulating legal proceedings involving public hazards. Regulates legal proceedings involving public hazards.

Requires the personal representative of an estate to provide certain information to the department of social and health services division of child support.

Concerning bail and pretrial release practices.

Modifies bail and pretrial release practices.

Addresses proof of financial responsibility; bail bond agents; and disclosure of certain health care information.

Requires the state institute for public policy to develop and validate a pretrial risk assessment tool to measure the likelihood that a defendant will fail to appear in court as required.

Requires the administrator for the courts to provide superior courts and courts of limited jurisdiction access to the risk assessment tool.

Requires the center for court research to research, evaluate, monitor, and report on the validity of the risk assessment tool.

Requires a police officer to complete a standardized form at the time of arrest that includes information regarding

the defendant's mental health and any history of domestic violence.

Clarifies that public inspection of or access to information related to mental health is subject to chapter 71.05 RCW (mental illness) and not the public records act. Makes appropriations.
