HB 1144-S2 by House Committee on Ways & Means (originally sponsored by Representatives McCoy, Crouse, Eddy, Morris, Haler, Kelley, Liias, Jacks, Frockt, and Hudgins)

Concerning renewable energy investment cost recovery program.

Modifies renewable energy investment cost recovery program provisions relating to: (1) Placement of a solar energy system on property owned by a nonprofit organization or a nonprofit housing organization;

- (2) Required information on an application for the investment cost recovery incentive;
- (3) Authorizing Washington State University to charge for services to cover costs of processing applications;
  - (4) Rates paid for the incentive;
  - (5) Option to purchase a solar energy system; and
- (6) Credit against taxes due from a light and power business.

Concerning harassment against criminal justice participants.

Makes harassment against criminal justice participants a crime under certain circumstances.

Authorizes a criminal justice participant, who is a target for threats or harassment prohibited under the act, and any family member residing with the criminal justice participant to apply to the secretary of state to have an address designated by the secretary of state serve as the person's address or the address of the minor or incapacitated person.

Requires the sentencing guidelines commission to report to the appropriate committees of the legislature on the number of prosecutions for harassing a criminal justice participant.

Expires July 1, 2018.
