Authorizing persons designated by the decedent to direct disposition, if the decedent died while serving on active duty in any branch of the United States armed forces, United States reserve forces, or national guard.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses disposition of human remains when the decedent died while serving on active duty in any branch of the United States armed forces, United States reserve forces, or national guard.

Provides that sales and use taxes need not be repaid on the site preparation for, the construction of, the acquisition of any related machinery and equipment that will become a part of, and the rental of equipment for use in the state route number 16 corridor improvements project.

Changes the composition of the public disclosure commission.

Prohibits local governments from imposing a tax, fee, assessment, surcharge, or other charge on any product satisfying the definition of checkout bag.

Provides a business and occupation tax exemption on amounts received by retail stores from customers who provide payment for the use of a recycled paper bag.

Exempts from disclosure under the public records act, video and audio recordings of any portion of an executive session from which the public is excluded.

Improving disclosure in real estate transactions of possible limits on reliance on permit exempt wells in future development.

Expands the seller disclosure statement for unimproved residential real property and commercial real estate to include information on the reliability of permit exempt wells.

Prohibits discharging or discriminating against an employee for reporting any injury, illness, or unsafe condition to the employer, agent of the employer, safety and health committee involved, or employee safety and health representative involved.

Increases penalties for certain violations of the industrial safety and health act.

Requires the director of the department of labor and industries to adjust certain civil penalty amounts to account for the percentage increase or decrease in the consumer price index.

Prohibits the application of pesticides, in certain locations, by airplane, air-blast sprayer, fumigation, or other application method that poses a substantial risk of pesticide drift.

Assigns duties to the department of labor and industries and the department of health relating to investigations and enforcement of violations.

Supports the development of commercial-scale aviation biofuels production facilities in the state by facilitating and streamlining the permitting process for new facilities and the expansion of existing facilities and providing access to low-cost financing through the issuance of revenue bonds.

Requires the housing finance commission to: (1) Issue bonds for financing project costs of facilities;

- (2) Make or purchase loans for financing the facilities;
- (3) Enter into financing documents relating to the repayment of those loans or the provision of, or security for, debt service on the bonds.

Requires Innovate Washington to convene a sustainable aviation biofuels work group.

Terminates the work group on June 30, 2015.

Requires the superintendent of public instruction to establish common components of the teacher and principal evaluation systems in order to assure fairness in the conduct of evaluations and comparability of evaluation results across the state.

Requires teachers and principals to have an individual professional growth plan that is informed by the results of the evaluation and designed to assist the teacher or principal in increasing skills and competencies identified in the evaluation.

Establishes the Washington charter school commission as an independent state agency whose mission is to authorize high quality charter schools throughout the state, particularly schools designed to expand opportunities for educationally disadvantaged students.

Establishes the transformation zone district as a statewide school district within the state.

Promoting local intervention and prevention programs for reducing gang violence.

Requires the Washington state partnership council on juvenile justice, when funding is appropriated for this purpose, to award grants to carry out local projects focused on criminal street gang prevention and intervention programs.

Creates the criminal street gang prevention and intervention grant program account.

Makes an appropriation.
