- Creates the non-appropriated Public Employees' Benefits' Board (PEBB) Benefits Account (Benefits Account).
- Permits the Health Care Authority to contract for benefits or services directly using funds from the Benefits Account.

The Health Care Authority (HCA) administers benefits plans, forms benefits contracts, develops participation rules, and through the Public Employees' Benefit Board (PEBB)

approves schedules of rates and premiums for active employee and retired participants. The members of the PEBB vote to approve contracts and benefits for the PEBB program.

The HCA uses the Public Employees' and Retirees' Insurance Account, a non-appropriated fund with uses restricted to the payment of premiums for employee and retiree insurance benefit contracts.

# **Staff Summary of Public Testimony:**

(In support) The Health Care Authority (HCA) would like to have this account created to give them flexibility in the way they purchase services for members. The ability to directly purchase from providers could save the state money in some cases. The HCA would like the opportunity to contract for services directly in some circumstances, rather than through an insurance plan. It would allow the HCA to retain more control over these products, and reduce administrative overhead.
