1 AN ACT Relating to the expansion of the membership of the capital  
2 projects advisory review board; amending RCW 39.10.220; and reenacting  
3 and amending RCW 43.131.408.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 39.10.220 and 2013 c 222 s 2 are each amended to read  
6 as follows:

7 (1) The board is created in the department of enterprise services  
8 to provide an evaluation of public capital projects construction  
9 processes, including the impact of contracting methods on project  
10 outcomes, and to advise the legislature on policies related to public  
11 works delivery methods.

12 (2) Members of the board are appointed as follows:

13 (a) Two representatives from construction general contracting; one  
14 representative from the architectural profession; one representative  
15 from the engineering profession; two representatives from construction  
16 specialty subcontracting; two representatives from construction trades  
17 labor organizations; one representative from the office of minority and  
18 women's business enterprises; one representative from a higher  
19 education institution; one representative from the department of

1 enterprise services; one individual representing Washington cities; two  
2 representatives from private industry; and one representative of a  
3 domestic insurer authorized to write surety bonds for contractors in  
4 Washington state, each appointed by the governor. All appointed  
5 members must be knowledgeable about public works contracting  
6 procedures. If a vacancy occurs, the governor shall fill the vacancy  
7 for the unexpired term;

8 (b) One member representing counties, selected by the Washington  
9 state association of counties;

10 (c) One member representing public ports, selected by the  
11 Washington public ports association;

12 (d) One member representing public hospital districts, selected by  
13 the association of Washington public hospital districts;

14 (e) One member representing school districts, selected by the  
15 Washington state school directors' association; (~~and~~)

16 (f) One member representing regional transit authorities; and

17 (g) Two members of the house of representatives, one from each  
18 major caucus, appointed by the speaker of the house of representatives,  
19 and two members of the senate, one from each major caucus, appointed by  
20 the president of the senate. Legislative members are nonvoting.

21 (3) Members selected under subsection (2)(a) of this section shall  
22 serve for terms of four years, with the terms expiring on June 30th on  
23 the fourth year of the term.

24 (4) The board chair is selected from among the appointed members by  
25 the majority vote of the voting members.

26 (5) Legislative members of the board shall be reimbursed for travel  
27 expenses in accordance with RCW 44.04.120. Nonlegislative members of  
28 the board, project review committee members, and committee chairs shall  
29 be reimbursed for travel expenses as provided in RCW 43.03.050 and  
30 43.03.060.

31 (6) Vacancies are filled in the same manner as appointed. Members  
32 of the board may be removed for malfeasance or misfeasance in office,  
33 upon specific written charges by the governor, under chapter 34.05 RCW.

34 (7) The board shall meet as often as necessary.

35 (8) Board members are expected to consistently attend board  
36 meetings. The chair of the board may ask the governor to remove any  
37 member who misses more than two meetings in any calendar year without  
38 cause.

1 (9) The department of enterprise services shall provide staff  
2 support as may be required for the proper discharge of the function of  
3 the board.

4 (10) The board may establish committees as it desires and may  
5 invite nonmembers of the board to serve as committee members.

6 (11) The board shall encourage participation from persons and  
7 entities not represented on the board.
