1 AN ACT Relating to snowmobile license fees; amending RCW 46.17.350
2 and 46.17.350; creating new sections; and providing an expiration date.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 46.17.350 and 2010 c 161 s 531 are each amended to
5 read as follows:

15 NEW SECTION. **Sec. 3.** Section 1 of this act applies to snowmobile
16 registrations that are due on October 1, 2014. Section 1 of this act
17 expires October 1, 2015.

18 NEW SECTION. **Sec. 4.** Section 2 of this act applies to snowmobile
19 registrations that are due on or after October 1, 2015.
