- (b) A family member of an individual who was confined in a
- 25 juvenile detention facility or institution;
- 26 (c) A representative of the department of children, youth, and
- 27 families;

- 1 (d) A representative of the Washington association of
- 2 prosecuting attorneys;
- 3 (e) A representative of the Washington association of sheriffs 4 and police chiefs;
- 5 (f) A representative of a statewide organization representing 6 criminal defense attorneys;
- 7 (g) A representative of a statewide organization representing 8 public defenders;
- 9 (h) A representative of a statewide organization providing legal 10 services to youth;
- 11 (i) A representative from the office of the superintendent of 12 public instruction;
- 13 (j) A representative from the state board for community and 14 technical colleges;
- 15 (k) A representative from the Washington student achievement 16 council; and
- 17 (1) Two representatives from service providers that assist 18 individuals when exiting from a juvenile detention facility or 19 institution by providing mentoring or other community involvement
- 20 opportunities to that individual.
- 21 (3)(a) By November 1, 2021, and in compliance with RCW
- 22 43.01.036, the Washington partnership council on juvenile justice
- 23 shall submit an initial set of recommendations to the appropriate
- 24 committees of the legislature and the governor related to improving
- 25 outcomes for individuals exiting a juvenile detention facility or
- 26 institution as required under this section.
- (b) By September 1, 2022, the Washington partnership council on
- 28 juvenile justice shall submit a final report to the appropriate
- 29 committees of the legislature and the governor that describes the
- 30 recommendations related to improving outcomes for individuals
- 31 exiting a juvenile detention facility or institution as required
- 32 under this section.
- 33 (4) The following definitions apply to this section:
- 34 (a) "Detention facility" means:

- 1 (i) Any detention facility as defined under RCW 13.40.020; and
- 2 (ii) Any juvenile correctional facility under alternative
- 3 administration operated under a consortium of counties under RCW
- 4 13.04.035.
- 5 (b) "Institution" has the same meaning as in RCW 13.40.020.
- 6 (5) This section expires on January 1, 2023."

- 8 Renumber the remaining sections consecutively and correct any
- 9 internal references accordingly.

## EFFECT:

- Requires the Washington Partnership Council on Juvenile Justice to convene stakeholders to develop recommendations regarding improving outcomes for individuals exiting a juvenile detention facility or institution and provide a report to the Legislature and Governor that includes these recommendations by September 1, 2022, with an initial set of recommendations due by November 1, 2021.
- Requires that the Department of Children, Youth, and Families prioritize the delivery of available programming related to community transition services from individuals who share characteristics with the individual being served related to: race; ethnicity; sexual identity; and gender identity.
