 - EFFECT: (1) Removes proposed definitions, prohibitions, and restrictions on artificial and synthetically derived cannabinoids including related to: (a) the ban on the manufacture and sale artificial cannabinoids and their use as additives in cannabis products; (b) the requirement for rulemaking prior to the manufacture and sale of synthetically derived cannabinoids; (c) packaging and labeling disclosures; (d) activities of cannabis processors; and (e) the restrictions on artificial and synthetically derived cannabinoids related to medical cannabis products and the availability of a related sales and use tax exemption.
 - (2) Requires the Washington State University Center for Cannabis Policy, Research, and Outreach to convene a five-member scientific panel to review available scientific research, data, and regulations of other jurisdictions related to cannabinoids and the regulation of cannabinoids including, but not limited to: (a) Definitions of impairing cannabinoids; (b) definitions of synthetic cannabinoids, synthetically derived cannabinoids, and artificial cannabinoids; and (c) health and safety considerations related to the conversion process and consumption of cannabinoids. Requires a report to the Legislature by December 1, 2022, with annual updates thereafter.
