Authorizes expenditures from the Taxpayer Fairness Account for the sole purpose of funding increases in the working families' tax exemption over and above the amounts authorized in House Bill No. 1297 (2021). Removes the restrictions on the eligible transportation uses of the Carbon Emissions Reductions Account. Directs the first \$500 million of auction proceeds per year to the Carbon Emissions Reductions Account, with the balance of auction proceeds each year going to the Taxpayers Fairness Account. Eliminates the Climate Investment Account, the Climate Commitment Account, the Natural Climate Solutions Account, and the Air Quality and Health Disparities Account.
