20 "NEW SECTION. Sec. 26. The appropriations in this section are
21 provided to the health care authority community behavioral health
22 program and are subject to the following conditions and limitations:

23 (1) The following sums, or so much thereof as may be necessary,
24 are each appropriated: \$25,000,000 from the state general fund for
25 the fiscal year ending June 30, 2022; and \$20,000,000 from the state
26 general fund for the fiscal year ending June 30, 2023. The amounts
27 in this subsection are provided solely for the authority to contract

1 with behavioral health administrative service organizations to
2 implement the statewide recovery navigator program established in
3 section 2 of this act and for related technical assistance to
4 support this implementation. This includes funding for recovery
5 navigator teams to provide community-based outreach and case
6 management services based on the law enforcement assisted diversion
7 model and for technical assistance support from the law enforcement
8 assisted diversion national support bureau.

9 (2) The following sums, or so much thereof as may be necessary,
10 are each appropriated: \$1,673,000 from the state general fund for
11 the fiscal year ending June 30, 2022; \$3,114,000 from the state
12 general fund for the fiscal year ending June 30, 2023; and
13 \$3,890,000, from the general fund- federal account for the fiscal
14 biennium ending June 30, 2023. The amounts in this subsection are
15 provided solely for the authority to implement clubhouse services in
16 every region of the state.

17 (3) The following sums, or so much thereof as may be necessary,
18 are each appropriated: \$5,000,000 from the state general fund for
19 the fiscal year ending June 30, 2022; and \$7,500,000 from the state
20 general fund for the fiscal year ending June 30, 2023. The amounts
21 in this subsection are provided solely for the authority to
22 implement the homeless outreach stabilization team program, pursuant
23 to section 5(1) of this act.

24 (4) The following sums, or so much thereof as may be necessary,
25 are each appropriated: \$2,500,000 from the state general fund for
26 the fiscal year ending June 30, 2022; and \$2,500,000 from the state
27 general fund for the fiscal year ending June 30, 2023. The amounts
28 in this subsection are provided solely for the authority to expand
29 efforts to provide opioid use disorder medication in city, county,
30 regional, and tribal jails.

31 (5) The following sums, or so much thereof as may be necessary,
32 are each appropriated: \$500,000 from the state general fund for the
33 fiscal year ending June 30, 2022; and \$500,000 from the state
34 general fund for the fiscal year ending June 30, 2023. The amounts

1 in this subsection are provided solely for the authority to expand
2 opioid treatment network programs for people with co-occurring
3 opioid and stimulant use disorder.

4 (6) The following sums, or so much thereof as may be necessary,
5 are each appropriated: \$1,400,000 from the state general fund for
6 the fiscal year ending June 30, 2022; and \$1,400,000 from the state
7 general fund for the fiscal year ending June 30, 2023. The amounts
8 in this subsection are provided solely for behavioral health
9 administrative service organizations to develop regional recovery
10 navigator program plans pursuant to section 2 of this act and to
11 establish positions focusing on regional planning to improve access
12 to and quality of regional behavioral health services with a focus
13 on integrated care.

14 (7) The following sums, or so much thereof as may be necessary,
15 are each appropriated: \$75,000 from the state general fund for the
16 fiscal year ending June 30, 2022; and \$75,000 from the state general
17 fund for the fiscal year ending June 30, 2023. The amounts in this
18 subsection are provided solely for the authority to contract with an
19 organization with expertise in supporting efforts to increase access
20 to and improve quality in recovery housing and recovery residences.
21 This funding shall be used to increase recovery housing availability
22 through partnership with private landlords, increase accreditation
23 of recovery residences statewide, operate a grievance process for
24 resolving challenges with recovery residences, and conduct a
25 recovery capital outcomes assessment for individuals living in
26 recovery residences.

27 (8) The following sums, or so much thereof as may be necessary,
28 are each appropriated: \$500,000 from the state general fund for the
29 fiscal year ending June 30, 2022; and \$500,000 from the state
30 general fund for the fiscal year ending June 30, 2023. The amounts
31 in this subsection are provided solely for the authority to provide
32 short-term housing vouchers for individuals with substance use
33 disorders.

34

1 (9) The following sums, or so much thereof as may be necessary,
2 are each appropriated: \$250,000 from the state general fund for the
3 fiscal year ending June 30, 2022; and \$250,000 from the state
4 general fund for the fiscal year ending June 30, 2023. The amounts
5 in this subsection are provided solely for the authority to issue
6 grants for substance use disorder family navigator services.

7 (10) The following sums, or so much thereof as may be
8 necessary, are each appropriated: \$200,000 from the state general
9 fund for the fiscal year ending June 30, 2022; and \$200,000 from the
10 state general fund for the fiscal year ending June 30, 2023. The
11 amounts in this subsection are provided solely for the authority to
12 convene and provide staff and contracted services support to the
13 recovery oversight committee established in section 1 of this act.

14 (11) The following sums, or so much thereof as may be
15 necessary, are each appropriated: \$2,565,000 from the state general
16 fund for the fiscal year ending June 30, 2022; and \$2,565,000 from
17 the state general fund for the fiscal year ending June 30, 2023.
18 The amounts in this subsection are provided solely for staff and
19 contracted services support for the authority to develop and
20 implement the recovery services plan established in section 1 of
21 this act and to carry out other requirements of this act. Within
22 these amounts, funding is provided for the authority to:

23 (a) Establish an occupational nurse consultant position within
24 the authority to provide contract oversight, accountability,
25 performance improvement activities, and to ensure Medicaid managed
26 care organization plan compliance with provisions in law and
27 contract related to care transitions work with local jails.

28 (b) Establish a position within the authority to create and
29 oversee a program to initiate and support emergency department
30 programs for inducing medications for patients with opioid use
31 disorder paired with a referral to community-based outreach and case
32 management programs.

1 NEW SECTION. **Sec. 27.** The appropriation in this section is
2 provided to the administrative office of the courts and is subject
3 to the following conditions and limitations:

4 The following sums, or so much thereof as may be necessary, are
5 each appropriated: \$2,250,000 from the state general fund for the
6 fiscal year ending June 30, 2022; and \$2,250,000 from the state
7 general fund for the fiscal year ending June 30, 2023. The amounts
8 in this subsection are provided solely to fund grants for
9 therapeutic courts operated by municipalities and district courts.
10 The administrative office of the courts must allocate grant funding
11 based upon a formula established by the administrative office of the
12 courts. The formula must distribute the grant funding equitably
13 between those therapeutic courts located east of the crest of the
14 Cascade mountains and those therapeutic courts located west of the
15 crest of the Cascade mountains. Multiple jurisdictions served by a
16 single municipal court or district court may apply for funds as a
17 single entity. Local jurisdictions receiving grant funding for
18 therapeutic courts must use funding to identify individuals before
19 the courts with substance use disorders or other behavioral health
20 needs and engage those individuals with community-based therapeutic
21 interventions.

23 NEW SECTION. **Sec. 28.** The appropriation in this section is
24 provided to the department of commerce and is subject to the
25 following conditions and limitations:

26 The following sums, or so much thereof as may be necessary, are
27 each appropriated: \$500,000 from the state general fund for the
28 fiscal year ending June 30, 2022; and \$1,000,000 from the state
29 general fund for the fiscal year ending June 30, 2023. The amounts
30 in this subsection are provided solely for the department to provide
31 grants for the operational costs of new staffed recovery residences
32 which serve individuals with substance use disorders who require
33 more support than a level 1 recovery residence.

1 NEW SECTION. **Sec. 29.** The appropriation in this section is
2 provided to the criminal justice training commission and is subject
3 to the following conditions and limitations:

4 The following sums, or so much thereof as may be necessary, are
5 each appropriated: \$150,000 from the state general fund for the
6 fiscal year ending June 30, 2022; and \$150,000 from the state
7 general fund for the fiscal year ending June 30, 2023. The amounts
8 in this subsection are provided solely for the commission to
9 compensate trainer time to deliver the curriculum related to law
10 enforcement interactions with persons with a substance use disorder
11 pursuant to section 7 of this act."

EFFECT: Provides that the requirements that the Health Care Authority (1) establish requirements for recovery navigator programs to provide immediate response to in-custody referrals from law enforcement; (2) provide funding to Behavioral Health Administrative Services Organizations (BHASOs) for their recovery navigator programs; (3) establish regional access standards for the grant program for behavioral health treatment services not covered by medical assistance and for those not eligible for medical assistance; and (4) establish regional expanded recovery plans for the Expanded Recovery Support Services program are subject to the availability of amounts appropriated for those purposes. Appropriates the following amounts to the Health Care Authority Community Behavioral Health program: (1) \$45 million from the state general fund to implement a statewide recovery navigator program and for related technical assistance; (2) \$4.8 million from the state general fund and \$3.9 million from the general fund-federal account to implement Clubhouse services in every region of the state; (3) \$12.5 million from the state general fund to implement the homeless outreach stabilization team program; 4) \$5 million from the state general fund to expand efforts to provide opioid use disorder medication in city, county, regional, and tribal jails; 5) \$1 million from the state general fund to expand opioid treatment network programs for people with co-occurring opioid and stimulant use disorder; (6) \$2.8 million from the state general fund for BHASOs to develop regional recovery navigator program plans and to

establish positions focusing on regional planning to improve access to and quality of regional behavioral health services with a focus on integrated care; (7) \$150,000 from the state general fund for the authority to contract with an organization with expertise in supporting efforts to increase access to and improve quality in recovery housing and recovery residences; (8) \$1 million from the state general fund to provide short-term housing vouchers for individuals with substance use disorders; (9) \$500,000 from the state general fund to issue grants for substance use disorder family navigator services; (10) \$400,000 from the state general fund for support for the Recovery Oversight Committee; and (11) \$5.1 million from the state general fund to develop and implement the recovery services plan and carry out other requirements of the act.

Appropriates the following amounts to other state agencies as follows: (1) \$4.5 million from the state general fund to the Administrative Office of the Courts (Office) for therapeutic courts operated by municipalities and district courts to be allocated pursuant to a formula established by the Office which distributes funding equitably between courts located east and west of the Cascade mountains; (2) \$1.5 million from the state general fund to the Department of Commerce to provide grants for the operational costs of new staffed recovery residences which serve individuals with substance use disorders who require more support than a level 1 recovery residence; and (3) \$300,000 from the state general fund to the Criminal Justice Training Commission to compensate trainer time to deliver a curriculum related to law enforcement interactions with persons with a substance use disorder.
