AN ACT Relating to the practice of colon hydrotherapy; amending RCW 18.36A.060, 18.36A.140, 18.36A.160, and 18.130.040; reenacting and amending RCW 18.36A.020 and 18.130.040; adding a new section to chapter 18.36A RCW; providing an effective date; and providing an expiration date.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 18.36A 8 RCW to read as follows:

9 (1) Beginning July 1, 2022, the secretary shall issue a 10 certification as a colon hydrotherapist to any applicant who:

(a) Has completed education and training requirements established by the board. At a minimum, education and training requirements must address proper technique, the use of appropriate equipment, and safety and consent procedures; and

(b) Has successfully passed an examination approved by the board.

16 (2) The board may recognize certification or accreditation by a 17 professional organization as satisfying any of the requirements in 18 subsection (1) of this section if the organization's standards are 19 substantially equivalent to or more stringent than those established 20 under subsection (1) of this section.

1 (3) A colon hydrotherapist may not practice colon hydrotherapy unless the colon hydrotherapist has established an affiliation with 2 3 one or more naturopaths licensed under this chapter. A colon hydrotherapist must submit the names of all naturopaths with which 4 the colon hydrotherapist is affiliated to the board on a schedule 5 6 established by the board. A colon hydrotherapist may practice in a office of 7 location other than the naturopath. а A colon hydrotherapist may only perform colon hydrotherapy on patients who 8 have been referred to the colon hydrotherapist by a naturopath with 9 whom the colon hydrotherapist is affiliated and only according to the 10 11 plan of care delegated from the naturopath to the colon 12 hydrotherapist.

22 <u>(3) "Colon hydrotherapy" means the performance of enemas or</u> 23 <u>colonic irrigation.</u>

24 (4) "Common diagnostic procedures" means the use of venipuncture 25 consistent with the practice of naturopathic medicine, commonly used 26 diagnostic modalities consistent with naturopathic practice, health 27 history taking, physical examination, radiography, examination of 28 body orifices excluding endoscopy, laboratory medicine, and obtaining 29 samples of human tissues, but excluding incision or excision beyond 30 that which is authorized as a minor office procedure.

((-(3))) (5) "Department" means the department of health.

32 ((((++))) (6) "Educational program" means an accredited program 33 preparing persons for the practice of naturopathic medicine.

34 ((<del>(5)</del>)) <u>(7)</u> "Homeopathy" means a system of medicine based on the 35 use of infinitesimal doses of medicines capable of producing symptoms 36 similar to those of the disease treated, as listed in the homeopathic 37 pharmacopeia of the United States.

1 ((<del>(6)</del>)) <u>(8)</u> "Hygiene and immunization" means the use of such 2 preventative techniques as personal hygiene, asepsis, public health, 3 and immunizations, to the extent allowed by rule.

4 ((<del>(7)</del>)) <u>(9)</u> "Manual manipulation" or "mechanotherapy" means 5 manipulation of a part or the whole of the body by hand or by 6 mechanical means.

((<del>(8)</del>)) (10) "Minor office procedures" means care and procedures 7 incident thereto of superficial lacerations, lesions, and abrasions, 8 and the removal of foreign bodies located in superficial structures, 9 not to include the eye; and the use of antiseptics and topical or 10 local anesthetics in connection therewith. "Minor office procedures" 11 12 also includes intramuscular, intravenous, subcutaneous, and intradermal injections of substances consistent with the practice of 13 14 naturopathic medicine and in accordance with rules established by the 15 secretary.

16 ((<del>(9)</del>)) <u>(11)</u> "Naturopath" means an individual licensed under this 17 chapter.

18 (((10))) (12) "Naturopathic medicines" means vitamins; minerals; 19 botanical medicines; homeopathic medicines; hormones; and those 20 legend drugs and controlled substances consistent with naturopathic 21 medical practice in accordance with rules established by the board. 22 Controlled substances are limited to codeine and testosterone 23 products that are contained in Schedules III, IV, and V in chapter 24 69.50 RCW.

25 ((<del>(11)</del>)) <u>(13)</u> "Nutrition and food science" means the prevention 26 and treatment of disease or other human conditions through the use of 27 foods, water, herbs, roots, bark, or natural food elements.

(((12))) (14) "Physical modalities" means use of physical, chemical, electrical, and other modalities that do not exceed those used as of July 22, 2011, in minor office procedures or common diagnostic procedures, including but not limited to heat, cold, air, light, water in any of its forms, sound, massage, and therapeutic exercise.

34 ((<del>(13)</del>)) <u>(15)</u> "Radiography" means the ordering, but not the 35 interpretation, of radiographic diagnostic and other imaging studies 36 and the taking and interpretation of standard radiographs.

37 ((((14)))) (16) "Secretary" means the secretary of health or the 38 secretary's designee.

39 ((<del>(15)</del>)) <u>(17)</u> "Suggestion" means techniques including but not 40 limited to counseling, biofeedback, and hypnosis.
