1 AN ACT Relating to exempting certain prepaid services from
2 insurance regulation; and adding a new section to chapter 48.01 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** A new section is added to chapter 48.01
5 RCW to read as follows:

6 (1) It is the public policy of the state of Washington to promote
7 ready access to legal assistance and counsel for all citizens of the
8 state and to authorize that legal service contractors can issue legal
9 service plans to businesses and individuals in the state of
10 Washington.

11 (2) Legal service contractors are not insurers under RCW
12 48.01.050 and legal service plans are not insurance under RCW
13 48.01.040.

14 (3) This section does not in any way affect the practice of law
15 in this state.

16 (4) This section does not apply to or affect any of the following
17 arrangements:

18 (a) Retainer, fee, engagement, or representation agreements made
19 by an attorney or firm of attorneys with any person or group other
20 than a legal service contractor;

1 (b) Referral of individual clients to an attorney by a nonprofit
2 lawyer referral service or public corporation or entity such as state
3 or local bar association provided there is no fee or charge for such
4 referral;

5 (c) Employee welfare benefit plans to the extent that state law
6 or regulation is preempted by federal law or regulation;

7 (d) The provision of legal assistance to low or moderate-income
8 persons by nonprofit legal aid organizations or legal aid programs
9 affiliated with the Washington state bar association, a local bar
10 association, a law school accredited by the American bar association,
11 or a program operated in conjunction with a paralegal education
12 program approved by the American bar association; or

13 (e) Policies of insurance, or coverage incidental to such
14 insurance which may include legal defense, issued by an insurer
15 holding a valid certificate of authority in this state and issued
16 under applicable laws in this title pertaining to such insurance.

17 (5) For the purposes of this section:

18 (a) "Legal service contractor" means any person, entity, or group
19 of persons, including associations, who does not engage in the
20 practice of law or the business of insurance and who, for
21 consideration, provides members with access to legal services through
22 agreements with providing attorneys.

23 (b) "Legal service plan" or "plan" means an arrangement between a
24 legal service contractor and an individual or person or group of
25 individuals or persons, whereby specified legal services may be
26 provided to, or provided at discounted rates to members by providing
27 attorneys in consideration of a periodic payment that does not
28 constitute payment of attorney fees of any providing attorneys.

29 (c) "Member" means an individual, person, or group of individuals
30 or persons eligible to receive legal services under a legal service
31 plan.

32 (d) "Providing attorney" means an attorney licensed, in good
33 standing, and eligible to practice law in this state who provides
34 legal services under a providing attorney agreement in accordance
35 with the terms of the legal service plan, and pursuant to an
36 engagement agreement between the providing attorney and the member.

37 (e) "Providing attorney agreement" means a written contract or
38 agreement between a legal service contractor and a providing attorney
39 under which the providing attorney renders and provides legal
40 services to members of a legal service plan.
